

1 AN ACT relating to teachers.

2 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

3 ➔Section 1. KRS 161.030 is amended to read as follows:

4 (1) Notwithstanding the age of the pupil, the certification of all teachers and other
5 school personnel, in public schools only, is vested in the Education Professional
6 Standards Board. When so certified, teachers and other school personnel shall not
7 be required to have licensure, certification, or other forms of approval from any
8 other state agency for the performance of their respective assignments within the
9 common schools, except as provided for by law. All certificates authorized under
10 KRS 161.010 to 161.126 shall be issued in accordance with the administrative
11 regulations of the Education Professional Standards Board. After July 15, 1994, all
12 certificate applications and other data collection instruments of the board shall
13 include a request for voluntary information about the applicant's ethnic background.
14 This information shall be available to help local school districts locate minority
15 candidates. A person who holds a certificate prior to this requirement may request
16 that ethnic information be added to his or her file. Nothing in this section shall
17 preclude the right of an individual in a nonpublic school from seeking voluntary
18 certification by the Education Professional Standards Board.

19 (2) Certificates shall be issued upon written application and in accordance with statutes
20 and regulations in effect at the time of application to persons who have completed,
21 at colleges, universities, or local school district programs approved by the
22 Education Professional Standards Board for the preparation of teachers and other
23 school personnel, the curricula prescribed by the administrative regulations of the
24 Education Professional Standards Board.

25 (3) ~~[(a) Certification of all new teachers and teachers seeking additional certification~~
26 ~~shall require the successful completion of appropriate assessments prior to~~
27 ~~certification. The assessments shall be selected by the Education Professional~~

1 ~~Standards Board and shall measure knowledge in the specific teaching field of~~
2 ~~the applicant, including content of the field and teaching of that content. The~~
3 ~~Education Professional Standards Board shall determine the minimum~~
4 ~~acceptable level of achievement on each assessment. The assessments shall~~
5 ~~measure those concepts, ideas, and facts which are being taught in teacher~~
6 ~~education programs in Kentucky. Upon successful completion of the~~
7 ~~assessments and the approved teacher preparation program, a certificate valid~~
8 ~~for one (1) year shall be issued.~~

9 ~~(b) If an applicant for teacher certification has completed the approved teacher~~
10 ~~preparation program and has taken but failed to successfully complete the~~
11 ~~appropriate assessments selected by the Education Professional Standards~~
12 ~~Board, a conditional certificate may be issued for a period not to exceed one~~
13 ~~(1) year, if the employing school district, in collaboration with the teacher~~
14 ~~education institution, agrees to provide technical assistance and mentoring~~
15 ~~support to the conditionally certified teacher. The teacher shall retake the~~
16 ~~assessments during the validity period of the conditional certificate. The~~
17 ~~conditional certificate shall not be reissued. Upon successful completion of~~
18 ~~the required assessments, a certificate valid for one (1) year shall be issued~~
19 ~~and the teacher shall be eligible to participate in the internship program as~~
20 ~~provided in subsection (5) of this section. The teacher shall not be eligible to~~
21 ~~participate in the internship program while teaching on the conditional~~
22 ~~certificate. The Education Professional Standards Board shall promulgate~~
23 ~~administrative regulations to establish the standards and procedures for~~
24 ~~issuance of the conditional certificate.~~

25 ~~(c) If an out of state teacher with less than two (2) years' experience comes to~~
26 ~~Kentucky after the deadline for taking the assessments, a temporary certificate~~
27 ~~may be issued for a period up to six (6) months provided the local board~~

1 cannot fill the vacant position with a certified teacher. The teacher shall take
2 the assessments if they are administered during the period of the temporary
3 certificate. The certificate shall be extended for the remainder of the year if
4 the teacher successfully completes the assessments. If the teacher fails the
5 assessments, the temporary certificate shall be valid only for the current
6 semester.

7 ~~(4) A reasonable fee to be paid by the teacher and directly related to the actual cost of~~
8 ~~the administration of the assessments shall be established by the Education~~
9 ~~Professional Standards Board. Provisions shall be made for persons having less than~~
10 ~~minimum levels of performance on any assessment to repeat that assessment, and~~
11 ~~candidates shall be informed of their strengths and weaknesses in the specific~~
12 ~~performance areas. The Education Professional Standards Board shall provide for~~
13 ~~confidentiality of the individual assessment scores. Scores shall be available only to~~
14 ~~the candidate and to the education officials who are responsible for determining~~
15 ~~whether established certification standards have been met. Scores shall be used only~~
16 ~~in the assessment for certification of new teachers and of out of state teachers with~~
17 ~~less than two (2) years of teaching experience who are seeking initial certification~~
18 ~~in Kentucky.~~

19 ~~(5) Except as provided in subsection (3)(b) of this section,]~~All new teachers and out-
20 of-state teachers with less than two (2) years of successful teaching experience who
21 are seeking initial certification in Kentucky shall serve a one (1) year internship.
22 The teacher shall be a full-time employee or shall have an annual contract and serve
23 on at least a half-time basis and shall have supervision, assistance, and assessment
24 during the one (1) year internship. The internship may be served in a public school
25 or a nonpublic school which meets the state performance standards as established in
26 KRS 156.160 or which has been accredited by a regional or national accrediting
27 association. Successful completion shall be determined by a majority vote of the

1 beginning teacher committee. The internship period shall be counted as experience
2 for the purpose of continuing contract status, retirement eligibility, and benefits for
3 single salary experience increments. Upon successful completion of the beginning
4 teacher program, the one (1) year initial teaching certificate shall be extended for
5 the remainder of the usual duration period established for that particular certificate
6 by Education Professional Standards Board administrative regulations.

7 ~~(4)~~~~(6)~~ The beginning teacher committee shall be composed of three (3) persons who
8 have successfully completed special training in the supervision and assessment of
9 the performance of beginning teachers as provided in subsection ~~(6)~~~~(8)~~ of this
10 section, except as provided in paragraph (g) of this subsection. The committee shall
11 consist of a resource teacher, the school principal of the school where the internship
12 is served, and a teacher educator appointed by a state-approved teacher training
13 institution.

14 (a) If more than two (2) teacher interns are employed in the same school, the
15 principal's responsibility may be shared with an assistant principal who holds
16 certification as a principal.

17 (b) In unusual situations, the Education Professional Standards Board may permit
18 the assistant principal to serve in lieu of the principal on a beginning teacher
19 committee.

20 (c) If the teacher training institution is unable to provide a member, the district
21 superintendent shall appoint an instructional supervisor from the school
22 district.

23 (d) If the intern is teaching in a regionally or nationally accredited nonpublic
24 school without a principal, the person filling the principal member position
25 may have other appropriate qualifications as required by administrative
26 regulations promulgated by the Education Professional Standards Board.

27 (e) If the teacher training institution is unable to provide a member to serve on the

1 beginning teacher committee in a nonpublic school, the chief officer of the
2 school shall appoint an instructional supervisor or a teacher with like
3 qualifications and responsibilities to serve on the beginning teacher committee
4 in lieu of the teacher educator.

5 (f) The resource teacher shall be appointed by the Education Professional
6 Standards Board with recommendations from the local school district from a
7 pool of qualified resource teachers, and, any statutes to the contrary
8 notwithstanding and to the extent of available appropriations, shall be entitled
9 to be paid a reasonable stipend by the Education Professional Standards Board
10 for work done outside normal working hours. In the case of a resource teacher
11 in a nonpublic school, payment shall be made directly to the resource teacher
12 by the Education Professional Standards Board. Priority shall be given to
13 resource teachers in the following order, except as provided in paragraph (g)
14 of this subsection:

- 15 1. Teachers with the same certification in the same school;
- 16 2. Teachers with the same certification in the same district;
- 17 3. Teachers in the same school;
- 18 4. Teachers in the same district; and
- 19 5. Teachers in an adjacent school district.

20 (g) 1. The resource teacher for an individual pursuing initial certification as a
21 baccalaureate level teacher of exceptional children/communication
22 disorders shall be a master's level teacher of exceptional
23 children/communication disorders, if one is available.

- 24 2. If a master's level teacher of exceptional children/communication
25 disorders is not available, the Education Professional Standards Board
26 may allow a licensed speech-language pathologist to serve on the
27 beginning teacher committee in lieu of a resource teacher.

1 (h) The committee shall meet with the beginning teacher a minimum of three (3)
2 times per year for evaluation and recommendation with all committee
3 members present. In addition, each member of the committee shall observe
4 the beginning teacher in the classroom a minimum of three (3) times per year.
5 If the teacher's first year performance is judged by the committee to be less
6 than satisfactory, the teacher shall be provided with an opportunity to repeat
7 the internship one (1) time if the teacher is employed by a school district.

8 ~~(5)~~~~(7)~~ The resource teacher shall spend a minimum of seventy (70) hours working
9 with the beginning teacher. Twenty (20) of these hours shall be in the classroom
10 setting, and fifty (50) of these hours shall be in consultation other than class time or
11 attending assessment meetings. The resource teacher shall have completed at least
12 four (4) years of successful teaching experience as attested to by his or her
13 immediate supervisor or by having achieved tenure and be able to show evidence of
14 continuing professional development by having achieved a master's degree or its
15 equivalent or the accumulation of two thousand (2,000) hours of continuing
16 professional activities.

17 ~~(6)~~~~(8)~~ By contract with teacher education institutions in the Commonwealth, the
18 Education Professional Standards Board shall provide special training for persons
19 who will be serving on the beginning teacher committees. Completion of special
20 training shall be evidenced by successfully passing the assessments as prescribed by
21 the Education Professional Standards Board. A principal hired after July 15, 1996,
22 shall be required to complete the beginning teacher committee training program
23 within one (1) year after his or her appointment.

24 ~~(7)~~~~(9)~~ If an applicant establishes eligibility for a one (1) year certificate ~~under the~~
25 ~~provisions of subsection (3)(a) of this section,~~ but does not become employed on
26 the basis needed to satisfy the one (1) year internship requirement, the applicant
27 shall be eligible for the issuance of a certificate for substitute teaching as provided

1 by the administrative regulations of the Education Professional Standards Board.
2 The applicant shall remain eligible for the one (1) year certificate, ~~as provided in~~
3 ~~subsection (3)(a) of this section,~~ and for the opportunity to serve the internship for
4 a period of five (5) years after establishing eligibility. If the internship is not
5 completed within the five (5) year period, the applicant must reestablish eligibility
6 by repeating and passing the assessment program in effect for new teachers at that
7 time or by completing a minimum of six (6) graduate hours toward completion of a
8 graduate program required by administrative regulations promulgated by the
9 Education Professional Standards Board. The option for renewal through
10 completion of graduate hours shall be available only for the first reestablishment of
11 eligibility.

12 ~~(8)~~~~(10)~~ (a) The Education Professional Standards Board shall issue a ten (10) year
13 emeritus certificate to an applicant who has:

- 14 1. Retired or will retire not more than one (1) year prior to the expiration
15 date of the certificate;
- 16 2. Met the requirements to receive an emeritus certificate as set forth in
17 administrative regulation promulgated by the Education Professional
18 Standards Board; and
- 19 3. Completed the required application unless the provisions of KRS
20 161.120 apply.

21 (b) The Education Professional Standards Board shall issue a one (1) time five (5)
22 year exception certificate to an individual:

- 23 1. Whose certificate has expired;
- 24 2. Whose rank upon expiration was Rank I or Rank II;
- 25 3. Who has met the requirements to receive an exception certificate as set
26 forth in administrative regulation promulgated by the Education
27 Professional Standards Board;

- 1 4. Who completed three (3) years of classroom instruction prior to the
- 2 certificate's expiration; and
- 3 5. Who has completed the required application unless the provisions of
- 4 KRS 161.120 apply.

5 ~~(9)~~~~(11)~~ The Education Professional Standards Board shall approve the curricula of
6 any college or university, or of any department thereof, for the training of teachers,
7 and any nontraditional or alternative teacher preparation program offered in a
8 public or private postsecondary education institution, private contractor, or state
9 agency, and shall also approve the curricula of any local district alternative
10 certification program, when the curricula comply with the administrative
11 regulations of the Education Professional Standards Board for the issuance of
12 certificates and when the institution has met the terms and conditions provided in
13 KRS 161.010 to 161.120. Any student who has completed any of these curricula, as
14 approved by the Education Professional Standards Board, and who has completed
15 the prescribed requirements for the issuance of certificates shall be granted a
16 certificate corresponding to the curricula completed.

17 ➔Section 2. KRS 156.101 is amended to read as follows:

18 (1) The purpose of this section is to encourage and require the maintenance and
19 development of effective instructional leadership in the public schools of the
20 Commonwealth and to recognize that principals, with the assistance of assistant
21 principals, supervisors of instruction, guidance counselors, and directors of special
22 education, have the primary responsibility for instructional leadership in the schools
23 to which they are assigned.

24 (2) For the purpose of this section, "instructional leader" shall be defined as an
25 employee of the public schools of the Commonwealth employed as a principal,
26 assistant principal, supervisor of instruction, guidance counselor, director of special
27 education, or other administrative position deemed by the Education Professional

1 Standards Board to require an administrative certificate.

2 (3) In order to carry out the purpose of this section, the Kentucky Board of Education
3 shall establish a statewide program to improve and maintain the quality and
4 effectiveness of instructional leadership in the public schools of the
5 Commonwealth.

6 (4) The instructional leader improvement program shall contain the following
7 provisions:

8 (a) Each instructional leader employed by the public schools of the
9 Commonwealth shall participate in a continuing intensive training program
10 designed especially for instructional leaders;

11 (b) 1. Effective until June 30, 2006, every two (2) years each instructional
12 leader shall complete an intensive training program approved by the
13 Kentucky Board of Education to include no fewer than forty-two (42)
14 participant hours of instruction;

15 2. Effective July 1, 2006, each instructional leader shall annually complete
16 an intensive training program approved by the Kentucky Board of
17 Education to include no fewer than twenty-one (21) participant hours of
18 instruction;

19 (c) The Kentucky Board of Education shall prescribe specific criteria for the
20 training program, which shall include a provision to allow an instructional
21 leader to annually receive three (3) participant hours credit for duties
22 performed as part of a beginning teacher committee pursuant to KRS
23 161.030~~(4)~~~~(6)~~. A maximum of six (6) participant hours credit shall be
24 awarded annually for serving on multiple beginning teacher committees. The
25 Kentucky Department of Education may contract for specific training with
26 qualified agencies or institutions or approve programs offered by training
27 providers, including local district training programs, except that the

1 department shall ensure the requirements of paragraph (d) of this subsection
2 are met; and

3 (d) Annually, each local district superintendent shall report to the Kentucky
4 Department of Education any instructional leader who fails to complete the
5 training requirements of paragraph (b) of this subsection and shall place the
6 leader on probation for one (1) year. The Department of Education shall
7 verify completion of the required training. If the required training for the prior
8 year and the current year is not completed during the probationary period, the
9 Department of Education shall forward the information to the Education
10 Professional Standards Board, which shall revoke the instructional leader's
11 certificate.

12 (5) The Kentucky Department of Education shall ensure that training options in human
13 resource management and conflict resolution techniques are available to education
14 leaders throughout the state.

15 (6) This section shall be known as the "Effective Instructional Leadership Act."

16 ➔Section 3. KRS 161.048 is amended to read as follows:

17 (1) The General Assembly hereby finds that:

- 18 (a) 1. There are persons who have distinguished themselves through a variety
19 of work and educational experiences that could enrich teaching in
20 Kentucky schools;
- 21 2. There are distinguished scholars who wish to become teachers in
22 Kentucky's public schools, but who did not pursue a teacher preparation
23 program;
- 24 3. There are persons who should be recruited to teach in Kentucky's public
25 schools as they have academic majors, strong verbal skills as shown by
26 a verbal ability test, and deep knowledge of content, characteristics that
27 empirical research identifies as important attributes of quality teachers;

- 1 4. There are persons who need to be recruited to teach in Kentucky schools
2 to meet the diverse cultural and educational needs of students; and
- 3 5. There should be alternative procedures to the traditional teacher
4 preparation programs that qualify persons as teachers;
- 5 (b) There are hereby established alternative certification program options as
6 described in subsections (2) to (10) of this section;
- 7 (c) It is the intent of the General Assembly that the Education Professional
8 Standards Board inform scholars, persons with exceptional work experience,
9 and persons with diverse backgrounds who have potential as teachers of these
10 options and assist local boards of education in implementing these options and
11 recruitment of individuals who can enhance the education system in
12 Kentucky;
- 13 (d) The Education Professional Standards Board may reject the application of any
14 candidate who is judged as not meeting academic requirements comparable to
15 those for students enrolled in Kentucky teacher preparation programs; and
- 16 (e) The Education Professional Standards Board shall promulgate administrative
17 regulations establishing standards and procedures for the alternative
18 certification options described in this section. If the certification option
19 requires employment prior to certification, the procedures shall establish a
20 process for candidates to obtain an eligible for hire letter from the Education
21 Professional Standards Board.
- 22 (2) Option 1: Certification of a person with exceptional work experience. An individual
23 who has exceptional work experience and has been offered employment in a local
24 school district shall receive a one (1) year provisional certificate with approval by
25 the Education Professional Standards Board of a joint application by the individual
26 and the employing school district under the following conditions:
- 27 (a) The application contains documentation of all education and work experience;

1 (b) The candidate has documented exceptional work experience in the area in
2 which certification is being sought; and

3 (c) The candidate possesses:

4 1. A bachelor's degree or a graduate degree;

5 2. A minimum cumulative grade point average of two and seventy-five
6 hundredths (2.75) on a four (4) point scale or a minimum grade point
7 average of three (3.0) on a four (4) point scale on the last thirty (30)
8 hours of credit completed, including undergraduate and graduate
9 coursework from a nationally or regionally accredited postsecondary
10 institution; and

11 3. An academic major ~~for a passing score on the academic content~~
12 ~~assessment~~ in the area in which certification is being sought by the
13 applicant as designated by the Education Professional Standards Board.

14 The candidate shall participate in the teacher internship program under KRS
15 161.030. After successful completion of the internship program, the candidate shall
16 receive a professional certificate and shall be subject to certificate renewal
17 requirements the same as other teachers with a professional certificate.

18 (3) Option 2: Certification through a local school district training program. A local
19 school district or group of school districts may seek approval for a training
20 program. The state-approved local school district training program is an alternative
21 to the college teacher preparation program as a means of acquiring teacher
22 certification for a teacher at any grade level. The training program may be offered
23 for all teaching certificates approved by the Education Professional Standards
24 Board, including interdisciplinary early childhood education, except for specific
25 certificates for teachers of exceptional children. To participate in a state-approved
26 local school district alternative training program, the candidate shall possess:

27 (a) A bachelor's degree or a graduate degree;

- 1 (b) A minimum cumulative grade point average of two and seventy-five
 2 hundredths (2.75) on a four (4) point scale or a minimum grade point average
 3 of three (3) on a four (4) point scale on the last thirty (30) hours of credit
 4 completed, including undergraduate and graduate coursework from a
 5 nationally or regionally accredited postsecondary institution; and
- 6 (c) ~~[A passing score on the academic content assessment in the area in which
 7 certification is being sought by the applicant as designated by the Education
 8 Professional Standards Board. To be eligible to take an academic content
 9 assessment, the applicant shall have completed a thirty (30) hour major in the
 10 academic content area or five (5) years of experience in the academic content
 11 area as approved by the Education Professional Standards Board; and~~
- 12 (d) ~~]An offer of employment in a school district which has a training program
 13 approved by the Education Professional Standards Board.~~

14 Upon meeting the participation requirements as established in this subsection, the
 15 candidate shall be issued a one (1) year provisional certificate by the Education
 16 Professional Standards Board. The candidate shall participate in the teacher
 17 internship program under KRS 161.030. After successful completion of the
 18 internship program, the candidate shall receive a professional certificate and shall
 19 be subject to certificate renewal requirements the same as other teachers with a
 20 professional certificate.

- 21 (4) Option 3: Certification of a professional from a postsecondary institution: A
 22 candidate who possesses the following qualifications may receive a one (1) year
 23 provisional certificate for teaching at any level:
- 24 (a) A master's degree or doctoral degree in the academic content area for which
 25 certification is sought;
- 26 (b) A minimum of five (5) years of full-time teaching experience, or its
 27 equivalent, in the academic content area for which certification is sought in a

1 regionally or nationally accredited institution of higher education; and

2 (c) An offer of employment in a school district which has been approved by the
3 Education Professional Standards Board.

4 The candidate shall participate in the teacher internship program under KRS
5 161.030. After successful completion of the internship program, the candidate shall
6 receive a professional certificate and shall be subject to certificate renewal
7 requirements the same as other teachers with professional certificates.

8 (5) Option 4: Certification of an adjunct instructor. A person who has expertise in areas
9 such as art, music, foreign language, drama, science, computer science, and other
10 specialty areas may be employed as an adjunct instructor in a part-time position by
11 a local board of education under KRS 161.046.

12 (6) Option 5: Certification of a veteran of the Armed Forces. The Education
13 Professional Standards Board shall issue a statement of eligibility, valid for five (5)
14 years, for teaching at the elementary, secondary, and secondary career technical
15 education levels to a veteran of the Armed Forces who was honorably discharged
16 from active duty as evidenced by Defense Department Form 214 (DD 214) or
17 National Guard Bureau Form 22 or to a member of the Armed Services currently
18 serving with six (6) or more years of honorable service, including Reserves,
19 National Guard, or active duty. The candidate shall possess:

20 (a) A bachelor's degree or graduate degree;

21 (b) A minimum cumulative grade point average of two and seventy-five
22 hundredths (2.75) on a four (4) point scale or a minimum grade point average
23 of three (3) on a four (4) point scale on the last thirty (30) hours of credit
24 completed, including undergraduate and graduate coursework from a
25 nationally or regionally accredited postsecondary institution; and

26 (c) An academic major ~~for a passing score on the academic content assessment~~
27 ~~in the area in which certification is being sought by the applicant as~~

1 designated by the Education Professional Standards Board.

2 Upon an offer of employment by a school district, the eligible veteran shall receive
3 a one (1) year provisional certificate with approval by the Education Professional
4 Standards Board of a joint application by the veteran and the employing school
5 district. During this year, the veteran shall participate in the teacher internship
6 program under KRS 161.030. After successful completion of the internship
7 program, the veteran shall receive a professional certificate.

8 (7) Option 6: University alternative program. With approval of the Education
9 Professional Standards Board, a university may provide an alternative program that
10 enrolls students in a postbaccalaureate teacher preparation program concurrently
11 with employment as a teacher in a local school district. A student in the alternative
12 program shall be granted a one (1) year provisional certificate and shall participate
13 in the Kentucky teacher internship program, notwithstanding provisions of KRS
14 161.030. A student may not participate in the internship program until the student
15 has successfully completed the assessments required by the board. The one (1) year
16 provisional certificate may be renewed four (4) additional years, and shall be
17 contingent upon the candidate's continued enrollment in the preparation program
18 and compliance with all requirements established by the board. A professional
19 certificate shall be issued upon the teacher candidate's successful completion of the
20 program, the internship program requirements, and all academic content
21 assessments in the specific teaching field of the applicant as designated by the
22 Education Professional Standards Board.

23 (8) Option 7: Certification of a person in a field other than education to teach in
24 elementary, middle, or secondary programs. This option shall not be limited to
25 teaching in shortage areas. An individual certified under provisions of this
26 subsection shall be issued a one (1) year provisional certificate, renewable for a
27 maximum of four (4) additional years with approval of the Education Professional

1 Standards Board.

2 (a) The candidate shall possess:

3 1. A bachelor's degree with a declared academic major in the area in which
4 certification is sought or a graduate degree in a field related to the area
5 in which certification is sought;

6 2. A minimum cumulative grade point average of two and seventy-five
7 hundredths (2.75) on a four (4) point scale or a minimum grade point
8 average of three (3) on a four (4) point scale on the last thirty (30) hours
9 of credit completed, including undergraduate and graduate coursework
10 from a nationally or regionally accredited postsecondary institution; and

11 3. A passing score on the GRE or equivalent as designated by the
12 Education Professional Standards Board. A candidate who has a
13 terminal degree shall be exempt from the requirements of this
14 subparagraph; ~~and~~

15 ~~4. A passing score on the academic content assessment in the area in which~~
16 ~~certification is being sought as designated by the Education Professional~~
17 ~~Standards Board].~~

18 (b) Prior to receiving the one (1) year provisional certificate or during the first
19 year of the certificate, the teacher shall complete the following:

20 1. For elementary teaching, the individual shall successfully complete the
21 equivalent of a two hundred forty (240) hour institute, based on six (6)
22 hour days for eight (8) weeks. The providers and the content of the
23 institute shall be approved by the Education Professional Standards
24 Board. The content shall include research-based teaching strategies in

3 (b) The provisional certificate granted under paragraph (a) of this subsection may
4 be renewed two (2) times with a recommendation of the superintendent and
5 approval of the Education Professional Standards Board.

6 (c) A Teach for America participant who is approved for a second renewal of his
7 or her provisional certificate under paragraph (b) of this subsection may
8 participate in the teacher internship program under KRS 161.030.

9 (d) A Teach for America participant shall be issued a professional certificate
10 upon the participant's successful completion of the internship program and
11 assessments relating to teaching of subject matter required by the Education
12 Professional Standards Board under KRS 161.030.

13 (e) Notwithstanding any statute or administrative regulation to the contrary, a
14 teacher certified under this subsection shall have ten (10) years from the date
15 that the teacher successfully completed the internship program to complete a

18 (10) Option 9: Expedited certification of a person to teach at any grade level through a

27 exceptional students:

- 1 (a) An out-of-state license to teach exceptional students;

- 3 for which certification is sought; and
- 4 (c) Successful completion of the teacher internship program requirement required
- 5 under KRS 161.030.
