12		(e)	Require the design plans for all road projects constructing a new route to
13			identify, if at all feasible, one (1) or more publicly owned sites at least four (4)
14			acres in size, along the proposed new route that will be used as waste sites
15			during the construction phase of the project but that have the potential for a
16			city, county, or other governmental entity to turn the site into an industrial
17			park upon completion of the road project, regardless of whether the site
18			currently has the infrastructure necessary to support an industrial park;
19		(f)	Consult with all legislative bodies affected by a new road construction project

- (f) Consult with all legislative bodies affected by a new road construction project during the design phase for the purpose of soliciting local government officials' preferences for the location of waste sites that could be turned into an industrial park;
- 23 (g) From time to time, examine and have examined and audited all of its books, 24 papers and records;

(h) Cause to be made all necessary surveys in the establishment and construction of the system of public highways; all necessary maps, prints, plans and specifications of all work to be done on the roads; estimates of costs;

3		(i) Promulgate administrative regulations under KRS Chapter 13A for the care
4		and maintenance of roads after they have been constructed.
5	(2)	The department may:
6		(a) Publish bulletins containing useful information concerning the construction

8		(b) Establish a process to prequalify the following for professional service
9		contracts to provide right of way services that comply with state and federal
10		laws and administrative regulations:
11		1. Real estate appraisers licensed under KRS Chapter 324A; and
12		2. Real estate brokers licensed under KRS Chapter 324.
13	(3)	An invoice or bill to be paid out of the road or bridge funds shall not be approved
14		by the department for payment until it has been carefully examined by the
15		department to ascertain if the bill or invoice is in every respect a proper and
16		legitimate charge against the road or bridge funds. The commissioner may call
17		before him any person who may have information respecting any bill or invoice.
