1	A RESOLUTION urging elementary and secondary schools to include information
2	about type 1 diabetes if they provide health-related information to the parents or legal
3	guardians of students in grades K-12.
4	WHEREAS, according to the Centers for Disease Control and Prevention the
5	number of young people in Kentucky and the United States with type 1 diabetes is
6	expected to increase more rapidly in the future, possibly by as much as 65 percent in the
7	next 40 years; and
8	WHEREAS, type 1 diabetes is an autoimmune disease for which medical guidelines
9	published by the American Diabetes Association recommend proactive screening to
10	detect and identify the risk of developing the disease as a means to prevent diabetic
11	ketoacidosis (DKA), a life-threatening complication associated with type 1 diabetes, and
12	other costly medical events associated with a type 1 diabetes diagnosis; and
13	WHEREAS, Kentucky's 2021 Diabetes Report finds that DKA, a complication of
14	diabetes in which ketones or fatty acids builds up in the blood due to a lack of insulin,
15	accounted for 34 percent of all hospitalizations with an average hospital stay of three
16	days, an average charge of \$23,901, and a total average billed charges of \$93,117,008 for
17	Kentucky's Medicaid program; and
18	WHEREAS, youth diabetes represents the second most costly condition covered by
19	Kentucky's Medicaid program, with an annual average cost per patient of \$3,922 per year
20	in 2021; and
21	WHEREAS, the increasing prevalence of type 1 diabetes, a lifelong autoimmune
22	condition requiring the daily use of insulin injections and other costly medical
23	interventions, presents a unique public health and health financing challenge to the
24	Commonwealth of Kentucky;
25	NOW, THEREFORE,

→ Section 1. The members of the House of Representatives hereby urge
 elementary and secondary schools that provide information related to medication policy
 or other school health issues at the beginning of each school year to the parents or legal
 guardians of students in grades K-12 to include:

(1) A description of type 1 diabetes;

- 6 (2) A description of the risk factors and warning signs associated with type 1 diabetes;
- 8 (3) A recommendation that the parents or guardians of students displaying 9 warning signs associated with type 1 diabetes should consult with the student's primary 10 care provider to determine if immediate screening for type 1 diabetes is appropriate;
- 11 (4) A description of the screening process for type 1 diabetes and the significance 12 of stage 1, stage 2, and stage 3; and
- 13 (5) A recommendation that following a type 1 diabetes diagnosis, parents or 14 guardians should consult with the pupil's primary care provider to develop an appropriate 15 treatment plan.
- Section 2. The Department of Education in cooperation with the Department for
 Public Health is encouraged to develop and make available the information described in
 Section 1 of this Act.
