I	A RESOLUTION recognizing October 2024 as Domestic Violence Awareness
2	Month in Kentucky.
3	WHEREAS, Kentuckians deserve to live in a Commonwealth where all individuals,
4	families, and communities have the freedom and resources to live in safety and thrive;
5	and
6	WHEREAS, domestic violence and dating violence not only severely impact the
7	lives of victims, but also result in an economic cost to communities over victims'
8	lifetimes of approximately \$3.6 trillion, arising from medical services related to domestic
9	and dating violence, lost productivity and wages, utilization of the criminal justice
10	system, expenses, and other costs; and
11	WHEREAS, approximately one in five homicides occur at the hands of an intimate
12	partner, and over one-half of female homicide victims in the United States are killed by a
13	current or former male intimate partner; and
14	WHEREAS, the Kentucky Criminal Justice Statistical Analysis Center reported 27
15	Kentuckians lost their lives to domestic violence in 2022, with an additional 27 charges
16	of attempted homicide arising from domestic violence being filed in Kentucky courts;
17	and
18	WHEREAS, over the past five years, Kentucky's 15 state-funded domestic violence
19	shelter programs have housed over 10,000 adults and 6,000 children and provided
20	nonresidential services to an additional 72,000 Kentuckians; and
21	WHEREAS, domestic and dating violence is motivated by power and control and is
22	perpetuated by a complex range of abuse tactics, including but not limited to physical,
23	verbal, emotional, and financial abuse; stalking and intimidation; and sabotage of career
24	and education; and
25	WHEREAS, these abuse tactics lead to housing and job instability, homelessness,
26	negative impacts on workforce participation, serious health issues, high medical debt,
27	poor credit ratings arising from financial exploitation, and additional challenges that keep

1 survivors of domestic violence and dating violence from being able to meet their basic

- 2 needs and the needs of their children; and
- 3 WHEREAS, children exposed to domestic violence can experience long-term
- 4 consequences, including difficulty at school, substance abuse, behavioral problems in
- 5 adolescence, and serious adult health problems; and
- WHEREAS, the mental, emotional, physical, and financial effects of domestic and
- 7 dating violence impact our state and local systems, communities, families, individuals,
- 8 and children; and
- 9 WHEREAS, the root causes and prevalence of domestic and dating violence
- throughout the Commonwealth must be brought into the public focus; and
- WHEREAS, domestic and dating violence cannot be prevented until they are
- 12 openly recognized and addressed; and
- WHEREAS, the House of Representatives recognizes the vital role that all
- 14 Kentuckians can play in preventing, and one day ending, domestic violence and dating
- 15 violence;

- → Section 1. The House of Representatives does hereby recognize October 2024
- as Domestic Violence Awareness Month in Kentucky.
