A NEW SECTION OF KRS CHAPTER 237 IS CREATED TO 18 19 **READ AS FOLLOWS:** 20 Any person may voluntarily request to be placed on the list established under this (1) 21 section and be restricted from purchasing or possessing firearms. 22 By June 1, 2025, the Department of Kentucky State Police shall: (2)23 (a) Establish a list for a person to voluntarily provide information to the 24 Department of Kentucky State Police to be entered into the National Instant 25 Criminal Background Check System (NICS) that would restrict the person 26 from purchasing or possessing firearms; 27 (b) Develop and distribute forms for a person to be included on and removed
