

1 AN ACT relating to the Department of Fish and Wildlife Resources and declaring  
2 an emergency.

3 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

4 ➔Section 1. KRS 150.021 is amended to read as follows:

- 5 (1) The Department of Fish and Wildlife Resources shall constitute ~~a~~<sup>an independent</sup>  
6 department of state government within the meaning of KRS Chapter 12, and shall  
7 be administratively attached to the *Department of Agriculture*~~[Tourism, Arts and~~  
8 ~~Heritage Cabinet only for those limited functions and purposes expressly requested~~  
9 ~~by the department to be performed by the Tourism, Arts and Heritage Cabinet. The~~  
10 ~~department shall have sole discretion as to which functions shall be deemed~~  
11 ~~necessary for the efficient operation of the department and the properties in its~~  
12 ~~eustody and control].~~ The department shall consist of a commissioner, a Fish and  
13 Wildlife Resources Commission, the Division of Law Enforcement, and other  
14 agents and employees provided for in this chapter. The department shall enforce the  
15 laws and regulations adopted under this chapter relating to wildlife and shall  
16 exercise all powers necessarily incident thereto.
- 17 (2) (a) The Finance and Administration Cabinet shall assess the Department of Fish  
18 and Wildlife Resources each fiscal year a fee in an amount equal to five  
19 percent (5%) of the debt service associated with all phases and  
20 implementation of the capital project to replace, repair, or maintain the two  
21 (2) way radio system utilized by the Department of Kentucky State Police.
- 22 (b) The fee shall be assessed on each phase of the implementation of the two (2)  
23 way radio system and shall continue to be assessed until all debt for the  
24 system has been retired.
- 25 (3) On *the effective date of this Act*~~[April 13, 2022]~~, copies of any records, files, or  
26 documents, including any legal documents or memoranda, associated with  
27 functions of the Department of Fish and Wildlife Resources~~[that were previously]~~

1 performed by the Tourism, Arts and Heritage Cabinet~~[but for which it is no longer~~  
2 ~~deemed responsible,]~~ shall be transmitted to the department.

3 (4) The department shall not be subject to reorganization under KRS Chapter 12.

4 ➔Section 2. KRS 150.022 is amended to read as follows:

5 (1) The Department of Fish and Wildlife Resources Commission shall consist of nine  
6 (9) members, one (1) from each commission district, as set out by the commissioner  
7 with the approval of the commission, and not more than five (5) of the same  
8 political party.

9 (2) The Commissioner of Agriculture~~[Governor]~~ shall appoint the members of the  
10 commission subject to confirmation by the Senate as described in subsection (3) of  
11 this section. Each of the members shall be appointed for a term ending on  
12 December 31 of the fourth calendar year following his or her appointment, except  
13 that a member's term shall continue until his or her successor is duly appointed and  
14 confirmed by the Senate, but no later than one (1) year following the expiration of  
15 the member's term. If after one (1) year a successor has not been duly appointed and  
16 confirmed by the Senate, the commissioner's seat for that district shall be vacant  
17 until a successor is duly appointed and confirmed by the Senate. A member shall  
18 serve no more than two (2) full terms, not including any partial term that a member  
19 may additionally serve. A person who has been convicted of a felony offense, in  
20 Kentucky or under the law of any other state, or any other law of the United States  
21 shall not be eligible to serve on the commission.

22 (3) (a) Vacancies through the expiration of terms of the members of the commission  
23 shall be filled by appointment by the Commissioner of  
24 Agriculture~~[Governor]~~ from a list of five (5) names from each commission  
25 district, recommended and submitted by the sportsmen of each respective  
26 district.

27 (b) When the term of a member expires, the commissioner shall call a meeting of

- 1 the sportsmen in that district not later than thirty (30) days prior to the  
2 expiration of the member's term. Notice of the meeting shall be given by  
3 publication pursuant to KRS Chapter 424.
- 4 (c) At the meeting, the sportsmen in attendance shall select and submit to the  
5 Commissioner of Agriculture~~[Governor]~~ a list of five (5) residents and  
6 citizens of the district who have held hunting and fishing licenses in Kentucky  
7 or another state for at least the previous five (5) consecutive years, or who  
8 have been hunting and fishing in the Commonwealth for the previous five (5)  
9 consecutive years while license-exempt under KRS 150.170, and who are well  
10 informed on the subject of wildlife conservation and restoration. Each  
11 sportsman may vote for one (1) candidate only, and the list submitted to the  
12 Commissioner of Agriculture~~[Governor]~~ shall be made up of the names of  
13 the five (5) candidates receiving the five (5) highest vote totals.
- 14 (d) The Commissioner of Agriculture~~[Governor]~~ shall appoint a successor to the  
15 member whose term has expired no later than January 20 of the year  
16 following the year in which the member's term expired.
- 17 (4) Upon appointment to the Department of Fish and Wildlife Resources Commission,  
18 each commissioner shall execute a bond of one thousand dollars (\$1,000) in favor  
19 of the Department of Fish and Wildlife Resources, the premium on this bond to be  
20 paid out of department funds.
- 21 (5) In the event of vacancies other than by expiration, the Commissioner of  
22 Agriculture~~[Governor]~~ shall fill the vacancy for the unexpired part of the term from  
23 the names remaining on the list previously submitted for the district from which the  
24 vacancy arose. An appointee chosen under this subsection shall not serve on the  
25 commission until duly confirmed by the Senate.
- 26 (6) Each member of the commission shall take the constitutional oath of office.
- 27 (7) The Commissioner of Agriculture~~[Governor]~~ shall remove any member of the

1 commission for cause under subsection (2) of this section and may remove a  
2 member of the commission for nonfeasance, neglect of duty, or misconduct in  
3 office; but shall first deliver to the member a copy of all charges in writing and  
4 afford to him or her an opportunity for an administrative hearing to be conducted in  
5 accordance with KRS Chapter 13B.

6 (8) Each member of the commission shall be entitled to reimbursement for actual and  
7 necessary traveling and other expenses incurred by him or her in the discharge of  
8 his or her official duties and to be paid from the game and fish fund.

9 (9) A majority of the commission shall constitute a quorum for the transaction of any  
10 business, for the performance of any duty or for the exercise of any power vested in  
11 the commission.

12 (10) The department shall have its principal office in Franklin County, and is authorized  
13 to purchase all supplies, equipment, and printed forms and to issue any notices and  
14 publications as the commissioner may deem necessary to carry out the provisions of  
15 this chapter.

16 (11) The word "sportsman" as used in this section shall mean a resident hunter or  
17 fisherman who has been licensed in Kentucky for each of the past two (2)  
18 consecutive years.

19 ➔Section 3. KRS 150.061 is amended to read as follows:

20 (1) Notwithstanding any provisions of KRS Chapter 18A, 42, 45, 45A, 56, or 64 to the  
21 contrary, the commission shall have the sole authority to appoint a commissioner of  
22 the Department of Fish and Wildlife Resources, who shall be a person with  
23 knowledge of and experience in the requirements for the protection, conservation  
24 and restoration of the wildlife resources of the state. The commission shall be the  
25 sole contracting body for the purposes of KRS Chapter 45A and shall submit any  
26 proposed personal service contract with a commissioner to the Government Contact  
27 Review Committee for its review pursuant to KRS 45A.690 to 45A.725. The

1 commissioner shall serve for a defined employment contract term not to exceed  
2 four (4) years and shall be subject to:

3 (a) Annual review by the commission in closed, executive session;

4 (b) Removal by the commission for the same cause and in the same manner in  
5 which the Commissioner of Agriculture~~[Governor]~~ may remove a member of  
6 the commission; and

7 (c) Reappointment by the commission.

8 (2) The commissioner shall receive such compensation as the commission may solely  
9 determine, and shall be reimbursed for all actual and necessary travel and other  
10 expenses incurred by him or her in the performance of his or her official duties.

11 (3) Before entering upon the duties of his or her office, the commissioner shall take and  
12 subscribe to the constitutional oath of office, and shall, in addition thereto, swear or  
13 affirm that he or she holds no other public office, nor any position upon or under  
14 any political committee or party. Upon appointment by the commission, the  
15 commissioner shall execute a bond of five thousand dollars (\$5,000) in favor of the  
16 Department of Fish and Wildlife Resources, the premium on said bond to be paid  
17 out of department funds.

18 (4) Notwithstanding any provision of law to the contrary, the commissioner shall be the  
19 sole appointing authority for the department for the purposes of KRS Chapter 18A  
20 and shall have general supervision and control of all activities, functions,  
21 appointments, and employees of the department. He or she shall enforce all  
22 provisions of the laws of the state relating to wild animals, birds, fish and  
23 amphibians, and shall exercise all powers necessarily incident thereto not  
24 specifically conferred on the commission. The commissioner shall make an annual  
25 report of all receipts and disbursements and file same with the Secretary of State of  
26 the Commonwealth of Kentucky.

27 (5) If federal or other grant funds become available to pay their salaries, the

1 commissioner may appoint and employ other persons that he or she may deem  
2 necessary or desirable to accomplish the purposes of this chapter. The  
3 commissioner shall determine the compensation, duties, and terms of employment  
4 of these employees, and grant funded, time-limited positions shall be approved by  
5 the commission as needed. Employees whose salaries are funded through federal or  
6 other grant funds shall not be counted in any tally of permanent employees made  
7 for employee cap or budgetary purposes.

8 ➔Section 4. KRS 235.010 is amended to read as follows:

9 As used in this chapter, unless the context clearly requires a different meaning:

- 10 (1) "Vessel" means every description of watercraft, other than a seaplane on the water;
- 11 (2) "Motorboat" means any vessel propelled by machinery, whether or not such  
12 machinery is the principal source of propulsion, except for the following:
- 13 (a) Boats or vessels propelled totally by a direct current battery-powered motor  
14 when used on private waters;
- 15 (b) Boats propelled by human power employing the use of hand or foot operation;  
16 and
- 17 (c) Federally regulated commercial vessels;
- 18 (3) "Owner" means a person, other than a lienholder, having the property in or title to a  
19 motorboat. The term includes a person entitled to the use or possession of a  
20 motorboat subject to an interest in another person, reserved or created by agreement  
21 and securing payment or performance of an obligation, but the term excludes a  
22 lessee under a lease not intended as security;
- 23 (4) "Personal watercraft" means a vessel which uses an internal combustion engine to  
24 power a jet pump for its primary source of propulsion and is designed to be  
25 operated by a person sitting, standing, or kneeling on the vessel rather than to be  
26 operated by a person sitting or standing inside the vessel;
- 27 (5) "Safe boating certificate" means a document attesting the successful completion of

- 1 instruction, approved by the department or given by the United States Coast Guard  
2 or Coast Guard Auxiliary or the United States Power Squadron, to prepare an  
3 individual to safely operate a motorboat or personal watercraft on the waters of the  
4 Commonwealth;
- 5 (6) "Waters of this state" means any waters within the territorial limits of this state;
- 6 (7) "Person" means an individual, partnership, firm, corporation, association, or other  
7 entity;
- 8 (8) "Operate" means to navigate or otherwise use a motorboat or a vessel;
- 9 (9) ~~["Cabinet" means the Tourism, Arts and Heritage Cabinet;~~
- 10 ~~(10) "Department" means the Department of Fish and Wildlife Resources;~~
- 11 ~~(10)~~ (10) "License" and "certificate of number" as used herein are synonymous;
- 12 ~~(11)~~ (11) "Clerk" means county clerk;
- 13 ~~(12)~~ (12) "Division of Law Enforcement" means the Division of Law Enforcement,  
14 Department of Fish and Wildlife Resources administratively attached to the  
15 Department of Agriculture~~["Tourism, Arts and Heritage Cabinet];~~
- 16 ~~(13)~~ (13) "Title" means the certificate of title;
- 17 ~~(14)~~ (14) "Commissioner" means the commissioner of the Department of Fish and  
18 Wildlife Resources;
- 19 ~~(15)~~ (15) "Federally regulated commercial vessel" means any vessel holding a United  
20 States certificate of documentation with a coastwise trade endorsement;
- 21 ~~(16)~~ (16) "Marina" means a dock or basin providing moorings for motorboats and  
22 offering supply, repair, or other services for remuneration; and
- 23 ~~(17)~~ (17) "Marine sanitation device" means equipment that is identified by the United  
24 States Coast Guard as meeting the standards of the United States Environmental  
25 Protection Agency or that is approved by the Energy and Environment Cabinet, to  
26 eliminate the discharge of untreated sewage from vessels into the waters of the  
27 Commonwealth and is a device that receives, treats, retains, or discharges sewage.

1           ➔Section 5. KRS 235.030 is amended to read as follows:

2       This chapter shall be known as the State Boating Act and shall be administered by the  
3       Department of Fish and Wildlife Resources, which is administratively attached to the  
4       Department of Agriculture~~[Tourism, Arts and Heritage Cabinet only for those limited~~  
5       ~~functions and purposes expressly requested by the department to be performed by the~~  
6       ~~Tourism, Arts and Heritage Cabinet. The department shall have sole discretion as to~~  
7       ~~which functions shall be deemed necessary for the efficient operation of the department~~  
8       ~~and the properties in its custody and control].~~ The Transportation Cabinet shall be  
9       responsible for administering the boat numbering, registration, and titling requirements.

10          ➔Section 6. KRS 235.130 is amended to read as follows:

11       (1) No person acting for himself or another shall buy or trade for any motorboat  
12       without receiving the certificate of title issued for that boat with a certificate of  
13       transfer endorsed thereon. If the motorboat has not been issued a certificate of title  
14       as noted on the certificate of registration, the person shall receive a completed  
15       assignment of title on a boat transaction record and the certificate of registration.

16       (2) It shall be the duty of the purchaser to promptly submit the endorsed certificate of  
17       title or boat transaction record and certificate of registration to the county clerk of  
18       the county of the purchaser's residence or in which the motorboat is to be  
19       principally operated. The purchaser shall apply for a new certificate of title and  
20       registration pursuant to KRS 235.050. The county clerk shall thereupon issue to the  
21       purchaser a transfer of registration bearing the same data and information. The clerk  
22       shall forward the endorsed certificate of title or boat transaction record and  
23       certificate of registration and new application for title and registration to the  
24       Transportation Cabinet. Except when registration is prohibited by law, any  
25       unexpired registration shall remain valid after transfer until expiration occurs  
26       according to law.

27       (3) For transferring the registration, the clerk shall collect a fee of five dollars (\$5). The

1 clerk shall retain two dollars (\$2), the Transportation Cabinet shall receive two  
2 dollars (\$2) and the Department of Fish and Wildlife Resources administratively  
3 attached to the Department of Agriculture~~[Tourism, Arts and Heritage Cabinet]~~  
4 shall receive one dollar (\$1). The fee received by the Transportation Cabinet shall  
5 be deposited in a trust and agency account for use by the Transportation Cabinet in  
6 defraying the cost of implementing and operating the boat titling and registration  
7 program. The fee for transferring the title shall be as required by KRS 235.085.

8 (4) If a transferee does not promptly submit the necessary documents to the county  
9 clerk as required by law in order to complete the transfer transaction, a transferor  
10 may submit to the county clerk, after the passage of fifteen (15) calendar days, in  
11 his or her county of residence, an affidavit that he or she has transferred his or her  
12 interest in a specific motorboat and the clerk may enter appropriate data into the  
13 AVIS system which would restrict any registration transaction from occurring on  
14 that vehicle until the transfer was processed.

15 (5) If the owner junks or otherwise renders a motorboat unfit for future use, he or she  
16 shall deliver the title to the county clerk of the county in which the motorboat is  
17 junked. The county clerk shall immediately return the title to the Transportation  
18 Cabinet. The owner shall pay to the county clerk fifty cents (\$0.50) for his or her  
19 services.

8 that this enumeration of administrative bodies be all-inclusive. Every authority, board,

5 ➔Section 11. The appointments made by executive orders under KRS 150.022  
6 before the effective date of this Act, of commissioners to represent the Second, Third,  
7 Seventh, Eighth, and Ninth Commission Districts shall expire and be vacated as of the  
8 effective date of this Act. The lists of candidates for appointment generated as a result of

17 ➔Section 12. Whereas the orderly administration of the Department of Fish and  
18 Wildlife Resources and the interests of Kentuckians who enjoy hunting, fishing, boating,  
19 and other outdoor activities supported by the department deserve to be free from  
20 executive branch decisions based on considerations other than the best interests of the  
21 department and the Kentuckians it serves, an emergency is declared to exist, and this Act  
22 takes effect upon its passage and approval by the Governor or upon its otherwise  
23 becoming a law.
