5	(6)	A conviction of a corporation of violating any of the provisions of KRS 365.210 or
6		365.220 shall operate to forfeit its charter or right to do business in this state.
7		Proceedings may be instituted by the Commonwealth's attorney in any district in
8		this state to forfeit the charter or right to do business in this state of any corporation

18		or sells any goods, wares, or merchandise in violation of the provisions of KRS
19		365.650 to 365.695, is guilty of a misdemeanor and shall, upon conviction, be fined
20		not more than five hundred dollars (\$500) or shall be imprisoned in the county jail

for not more than six (6) months, or both.
