3	Be it enacted by the General Assembly of the Commonwealth of Kentucky:
4	→SECTION 1. A NEW SECTION OF KRS CHAPTER 205 IS CREATED TO
5	READ AS FOLLOWS:
6	(1) As used in this section, "public ground ambulance provider" means a ground
7	ambulance provider licensed in accordance with administrative regulations
8	promulgated by the Kentucky Board of Emergency Medical Services, which is
9	owned or operated by a city, county, urban-county government, consolidated local
10	government, charter county government, unified local government, or special
11	district, except for a local rescue squad district created under KRS Chapter 39F.
12	(2) (a) The Department for Medicaid Services shall submit a Medicaid preprint
13	with a January 1, 2026, effective date to the Centers for Medicare and
14	Medicaid Services seeking authorization to establish and administer a
15	supplemental payment program to provide state-directed Medicaid managed
16	care payments to eligible public ground ambulance providers.
17	(b) If approved by the Centers for Medicare and Medicaid Services, the
18	department shall:
19	1. Establish and administer the program to provide state-directed
20	Medicaid payments to eligible public ground ambulance providers for
21	services provided under the managed care component of the Medicaid
22	program;
23	2. Operate the supplemental payment program described in this section
24	separately from the assessment and directed payment program
25	established under KRS 142.318, 205.5601, 205.5602, and 205.5603;
26	3. Utilize a cost report to determine the average cost per transport, which
27	shall be used in the upper payment limit calculation for the Medicaid

I		managed care-directed payments;
2		4. Establish a cost-based payment methodology in accordance with the
3		Centers for Medicare and Medicaid Services' rules and regulations;
4		<u>and</u>
5		5. Promulgate administrative regulations necessary to carry out this
6		section.
7	(3) (a)	The state match funds required for the supplemental payment program for
8		public ground ambulance providers shall:
9		1. Be provided by public ground ambulance providers participating in
10		the supplemental payment program via intergovernmental transfers or
11		similar government fund transfers; and
12		2. Include a total of two hundred thousand dollars (\$200,000) annually
13		that shall be retained by the department to offset administrative
14		expenses related to the supplemental payment program for public
15		ground ambulance providers. Each participating public ground
16		ambulance provider shall be responsible for a percentage of the
17		administrative fee retained by the department under this subparagraph
18		equal to the percentage of the total number of qualifying ambulance
19		runs a participating public ground ambulance provider made during
20		the previous year.
21	<u>(b)</u>	Participating public ground ambulance providers shall identify and utilize a
22		source of funding for the intergovernmental fund transfers required by
23		paragraph (a) of this subsection, which shall:
24		1. Be separate from the assessment authorized under KRS 205.6406;
25		2. Not be from the state general fund; and
26		3. Comply with the requirements of the Centers for Medicare and
27		Medicaid Services.

1	(c) A continued local source of funding shall be identified for the nonfederal
2	share, which shall:
3	1. Be separate from the assessment authorized under KRS 142.318;
4	2. Not be from the state general fund; and
5	3. Comply with the requirements of the Centers for Medicare and
6	Medicaid Services.
7	(4) To be eligible to receive state-directed payments under this section, a public
8	ground ambulance provider shall:
9	(a) Hold a valid Medicaid provider agreement;
10	(b) Submit an annual cost report in accordance with administrative regulations
11	promulgated by the department; and
12	(c) Provide emergency medical transportation services to Medicaid
13	beneficiaries.
