On page 2, after line 8, insert the following:

"➔Section 2. The Legislative Research Commission is hereby directed to establish the Nontraditional Instruction and Virtual Instruction Models Task Force. The task force shall investigate and make recommendations regarding:

(1) How effective are nontraditional instruction days and virtual instruction models for students in each of the grade ranges, primary through fifth grade, sixth through eighth grade, and ninth through twelfth grade;

(2) How prevalent are the use of nontraditional instruction days and virtual instruction models in districts throughout the state and are those nontraditional days used efficiently and effectively;

(3) How equipped are teachers to provide appropriate instruction on nontraditional instruction days and using virtual instruction models;

(4) How do nontraditional instruction days and virtual instruction models impact learning outcomes for various groups of students, including but not limited to English language learners, exceptional children, and at-risk students; and

(5) What adjustments to the support education excellence in Kentucky program are needed to accurately reflect actual costs, including possible cost savings incurred, by school

➔Section 3. (1) The task force shall be composed of the following eight members with final membership of the task force being subject to the consideration and approval of the Legislative Research Commission:

(a) Four members of the Senate, three of whom are appointed by the President of the Senate and one of whom is appointed by the Minority Floor Leader of the Senate; and

(b) Four members of the House of Representatives, three of whom are appointed by the Speaker of the House of Representatives and one of whom is appointed by the Minority Floor Leader of the House.

(2) The President of the Senate and the Speaker of the House of Representatives shall each select a co-chair of the task force from the selected members of their respective chambers.

➔Section 4. The task force shall meet at least monthly during the 2025 Interim of the General Assembly and shall submit its findings and recommendations to the Legislative Research Commission for referral to the appropriate committee or committees by December 1, 2025.

➔Section 5. Provisions of Sections 2 to 4 of this Act to the contrary notwithstanding, the Legislative Research Commission shall have the authority to alternatively assign the issues identified herein to an interim joint committee or subcommittee thereof, and to designate a study completion date.

➔Section 6. Sections 2 to 5 of this Act shall have the same legal status as a House Concurrent Resolution."; and
