| 5 | (1) There is hereby established a Unit of Election Investigations and Security within |
| 6 | the Office of the Attorney General, which shall enforce state election laws in |
| 7 | accordance with KRS 15.243 and: |
| 8 | (a) Receive complaints from election officials or any other person alleging a |
| 9 | violation of the state election law; |
| 10 | (b) Review notices and reports of an alleged violation of the state election law |
| 11 | and conduct investigations of any incidents that it determines require |
| 12 | further investigation; |
| 13 | (c) Initiate independent inquiries or conduct preliminary investigations into |
| 14 | any alleged violation of the state election law in any jurisdiction of this state |
| 15 | that it determines requires investigation; |
| 16 | (d) Employ investigators to conduct any investigations; |
| 17 | (e) Oversee the voter fraud hotline; and |
| 18 | (f) For purposes of investigation, have the authority to receive sworn |
| 19 | statements and issue subpoenas to compel the production of records and |
| 20 | other documents. |
| 21 | (2) If the unit determines there may be a violation of any criminal law or state |
| 22 | election law, it shall inform the Attorney General or refer the findings of its |
| 23 | investigation to the appropriate Commonwealth's or county attorney for further |
| 24 | investigation or prosecution. |
| 25 | (3) The unit shall submit a report by July 1 of each year to the Legislative Research |
| 26 | Commission, which provides detailed information on investigations of alleged |
| 27 | violations of the state election laws during the prior calendar year and includes: |

| 9 | 4. The current status of the investigation or resulting criminal case, |

| 11 | (4) All reports of alleged election law violations made by election officials or any |
| 12 | other person to the Secretary of State or the State Board of Elections shall be |
| 13 | forwarded to the Unit of Election Investigations and Security. |
| 14 | (5) This section shall not be construed to limit or restrict the jurisdiction of any other |
| 15 | office or agency of the state empowered by law to investigate, act upon, or dispose |
| 16 | of alleged state election law violations. |
