

1 AN ACT relating to education.

2 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

3 ➔Section 1. KRS 156.557 is amended to read as follows:

4 (1) As used in this section:

5 (a) "Formative evaluation" means a continuous cycle of collecting evaluation
6 information and providing feedback with suggestions regarding the certified
7 employee's professional growth and performance; and

8 (b) "Summative evaluation" means the summary of, and conclusions from, the
9 evaluation data, including formative evaluation data that:

10 1. Occur at the end of an evaluation cycle; and

11 2. Include a conference between the evaluator and the evaluated certified
12 employee and a written evaluation report.

13 (2) The Kentucky Department of Education, in consultation with the Kentucky teacher
14 and principal steering committees and other groups deemed appropriate by the
15 commissioner of education, shall develop a statewide framework for teaching that
16 shall promote the continuous professional growth and development of skills needed
17 to be a highly effective teacher or a highly effective administrator in a school or
18 district.

19 (3) Each district shall develop and implement a personnel evaluation system aligned
20 with the statewide framework for teaching established in subsection (2) of this
21 section that shall:

22 (a) Use multiple measures of effectiveness;

23 (b) Include both formative and summative evaluation components;

24 (c) Measure professional effectiveness;

25 (d) Support professional growth;

26 (e) Have at least four (4) performance levels;

27 (f) Be used to inform personnel decisions;

- 1 (g) Be considerate of the time requirements of evaluators at the local level and
2 shall not require that all certified school personnel have a formal summative
3 evaluation each year; and
- 4 (h) Rate teachers or administrators by multiple measures instead of a single
5 measure.
- 6 (4) The performance criteria by which teachers and administrators shall be evaluated
7 shall include but not be limited to:
- 8 (a) Performance of professional responsibilities related to his or her assignment,
9 including attendance and punctuality and evaluating results;
- 10 (b) Demonstration of effective planning of curricula, classroom instruction, and
11 classroom management, based on research-based instructional practices, or
12 school management skills based on validated managerial practices;
- 13 (c) Demonstration of knowledge and understanding of subject matter content or
14 administrative functions and effective leadership techniques;
- 15 (d) Promotion and incorporation of instructional strategies or management
16 techniques that are fair and respect diversity and individual differences;
- 17 (e) Demonstration of effective interpersonal, communication, and collaboration
18 skills among peers, students, parents, and others;
- 19 (f) Performance of duties consistent with the goals for Kentucky students and
20 mission of the school, the local community, laws, and administrative
21 regulations;
- 22 (g) Demonstration of the effective use of resources, including technology;
- 23 (h) Demonstration of professional growth;
- 24 (i) Adherence to the professional code of ethics; and
- 25 (j) Attainment of the teacher standards or the administrator standards as
26 established by the Education Professional Standards Board that are not
27 referenced in paragraphs (a) to (i) of this subsection.

- 1 (5) The following provisions shall apply to each school district's personnel evaluation
2 system:
- 3 (a) Certified school personnel, below the level of superintendent, shall be
4 evaluated;
- 5 (b) The evaluation system shall include formative evaluation and summative
6 evaluation components; and
- 7 (c) The Kentucky Board of Education shall adopt administrative regulations
8 incorporating written guidelines for a local school district to follow in
9 implementing the personnel evaluation system and shall require the following:
- 10 1. All evaluations of certified school personnel below the level of the
11 district superintendent shall be in writing on evaluation forms and under
12 evaluation procedures developed by a committee composed of an equal
13 number of teachers and administrators;
- 14 2. The immediate supervisor of the certified school personnel member
15 shall be designated as the primary evaluator. At the request of a teacher,
16 observations by other teachers trained in the teacher's content area or
17 curriculum content specialists may be incorporated into the formative
18 process for evaluating teachers;
- 19 3. All monitoring or observation of performance of a certified school
20 personnel member shall be conducted openly and with full knowledge of
21 the personnel member;
- 22 4. Evaluators shall be trained, tested, and approved in accordance with
23 administrative regulations adopted by the Kentucky Board of Education
24 in the proper techniques for effectively evaluating certified school
25 personnel. Evaluators shall receive support and resources necessary to
26 ensure consistent and reliable ratings;
- 27 5. The personnel evaluation system shall include a plan whereby the

1 person evaluated is given assistance for professional growth as a teacher
 2 or administrator. The system shall also specify the processes to be used
 3 when corrective actions are necessary in relation to the performance of
 4 one's assignment;

5 6. The system shall require annual summative evaluations for each teacher
 6 or other professional who has not attained continuing service status
 7 under KRS 161.740 or continuing status under KRS 156.800(7). The
 8 system shall require summative evaluations ~~{at least}~~ once every five
 9 (5)~~{three (3)}~~ years for a teacher or other professional who has attained
 10 continuing service status under KRS 161.740 or continuing status under
 11 KRS 156.800(7), principals, assistant principals, and other certified
 12 administrators. Additional summative evaluations may be performed at
 13 the discretion of the immediate supervisor of a teacher or other
 14 professional based upon a case-by-case analysis of the performance
 15 criteria set forth in subsection (4) of this section but shall not be
 16 imposed as a uniform requirement across the system; and

17 7. The training requirement for evaluators contained in subparagraph 4. of
 18 this paragraph shall not apply to district board of education members.

19 (6) (a) Each superintendent shall be evaluated according to a policy and procedures
 20 developed by the local board of education and approved by the department.

21 (b) The summative evaluation of the superintendent shall be in writing, discussed
 22 and adopted in an open meeting of the board and reflected in the minutes, and
 23 made available to the public upon request.

24 (c) Any preliminary discussions relating to the evaluation of the superintendent
 25 by the board or between the board and the superintendent prior to the
 26 summative evaluation shall be conducted in closed session.

27 (7) The Kentucky Board of Education shall establish an appeals procedure for certified

1 school personnel who believe that the local school district failed to properly
2 implement the evaluation system. The appeals procedure shall not involve requests
3 from individual certified school personnel members for review of the judgmental
4 conclusions of their personnel evaluations.

5 (8) The local board of education shall establish an evaluation appeals panel for certified
6 school personnel that shall consist of two (2) members elected by the certified
7 employees of the local district and one (1) member appointed by the board of
8 education who is a certified employee of the local board of education. Certified
9 school personnel who think they were not fairly evaluated may submit an appeal to
10 the panel for a timely review of their evaluation.

11 (9) The Kentucky Department of Education may annually provide for on-site visits by
12 trained personnel to review and ensure appropriate implementation of the
13 evaluation system by the local school district. The department shall provide
14 technical assistance to local districts to eliminate deficiencies and to improve the
15 effectiveness of the evaluation system.

16 (10) The disclosure, pursuant to KRS Chapter 61, of any data or information, including
17 student growth data, that local school districts or the Kentucky Department of
18 Education collect on individual classroom teachers under this section is prohibited.

19 (11) The results of evaluations conducted under this section shall not be included in the
20 accountability system described in KRS 158.6455 and no reporting requirements
21 related to these results shall be imposed upon the local school districts by the
22 Kentucky Department of Education.

23 ➔Section 2. KRS 158.060 is amended to read as follows:

24 (1) **Each teacher shall be provided access to a copy of his or her employment contract**
25 **upon request.**

26 (2) Twenty (20) school days, or days in which teachers are actually employed in the
27 schoolroom, shall constitute a school month in the common schools.

1 ~~(3)~~~~(2)~~ Each full-time teacher shall be provided with a duty-free lunch period each
2 day during the regularly scheduled student lunch period. The duty-free lunch period
3 shall be not less than the length of the lunch period specified in the school calendar
4 approved by the chief state school officer. A full-time teacher may be assigned to
5 lunch room duty during the regularly scheduled student lunch period only for an
6 amount of time equal to the noninstructional time in excess of fifty-five (55)
7 minutes included in the teacher's daily schedule. The calculation of noninstructional
8 time shall not include the teacher's duty-free lunch period, the time teachers are
9 required to be at school prior to the start of the student's instructional day, or the
10 time teachers are required to remain at school after the students are dismissed.

11 ~~(4)~~~~(3)~~ Except for children with disabilities and children attending the primary school
12 program who may attend a program of less than six (6) hours per day under policy
13 adopted by the local school district board of education and approved by the
14 commissioner of education and children attending a school district where the local
15 board has approved a schedule that provides at least the equivalent of six (6) hours
16 of daily instruction during the school year, a minimum of six (6) hours of actual
17 school work shall constitute a school day. Kindergarten programs may be operated
18 for less than six (6) hours without state board approval. The Kentucky Board of
19 Education, upon recommendation of the chief state school officer, shall develop and
20 approve regulations governing make up by school districts of whole days missed
21 due to emergencies, or partial days missed as a result of shortening regularly
22 scheduled school days due to emergencies.

23 ~~(5)~~~~(4)~~ Teachers shall be provided additional time for nonteaching activities. The
24 nonteaching time shall be used to provide teachers opportunities for professional
25 development activities as provided in KRS 156.095, instructional planning, school-
26 based decision making as provided in KRS 160.345, curriculum development, and
27 outreach activities involving their students' families and the community.

1 ~~(6)~~~~(5)~~ Character education programs and activities shall be considered valuable and
2 legitimate components of the actual school work constituting a school day under
3 subsection ~~(4)~~~~(3)~~ of this section.

4 ➔Section 3. KRS 156.095 is amended to read as follows:

5 (1) (a) The Kentucky Department of Education shall establish, direct, and maintain a
6 statewide program of professional development to improve instruction in the
7 public schools.

8 (b) By August 1, 2025, the department shall create a four (4) year recurring
9 professional development training schedule that includes all professional
10 development for certified personnel required by subsection (2) of this
11 section and federal law.

12 (c) Each local school district shall implement the professional development
13 training schedule created by the department.

14 (2) All certified school district employees and public charter school employees shall
15 complete at least one (1) hour of each of the following trainings within twelve
16 (12) months of initial hire and at least once every four (4) years thereafter:

17 (a) How to respond to an active shooter situation training prepared by the
18 Department of Criminal Justice Training in collaboration with the
19 department, the Kentucky Law Enforcement Council, and the Center for
20 School Safety;

21 (b) Child abuse and neglect prevention, recognition, and reporting training
22 from the list of trainings approved by the department in accordance with
23 subsection (7) of this section;

24 (c) 1. High-quality, evidence-based suicide prevention training, including
25 risk factors, warning signs, protective factors, response procedures,
26 referral, postvention, and the recognition of signs and symptoms of
27 possible mental illness.

1 2. As used in this paragraph, "postvention" means a series of planned
 2 supports and interventions with persons affected by a suicide for the
 3 purpose of facilitating the grieving or adjustment process, stabilizing
 4 the environment, reducing the risk of negative behaviors, and limiting
 5 the risk of further suicides through contagion; and
 6 (d) Self-study review of seizure disorder materials.

7 (3) (a) [(2)] Each local school district superintendent shall appoint a certified school
 8 employee to fulfill the role and responsibilities of a professional development
 9 coordinator who shall disseminate professional development information to
 10 schools and personnel. Upon request by a school council or any employees of
 11 the district, the coordinator shall provide technical assistance to the council or
 12 the personnel that may include assisting with needs assessments, analyzing
 13 school data, planning and evaluation assistance, organizing districtwide
 14 programs requested by school councils or groups of teachers, or other
 15 coordination activities.

16 (b) [(a)] The manner of appointment, qualifications, and other duties of the
 17 professional development coordinator shall be established by the local board
 18 of education [~~Kentucky Board of Education through promulgation of~~
 19 ~~administrative regulations~~].

20 (c) [(b)] The local district professional development coordinator may [~~shall~~]
 21 participate in the Kentucky Department of Education annual training program
 22 for local school district professional development coordinators. The training
 23 program may include, but not be limited to, the demonstration of various
 24 approaches to needs assessment and planning; strategies for implementing
 25 long-term, school-based professional development; strategies for
 26 strengthening teachers' roles in the planning, development, and evaluation of
 27 professional development; and demonstrations of model professional

1 development programs. The training shall include information about teacher
2 learning opportunities relating to the core content standards. The
3 department~~[Kentucky Department of Education]~~ shall regularly collect and
4 distribute this information.

5 ~~(4)~~~~(3)~~ The department~~[Kentucky Department of Education]~~ shall provide or
6 facilitate optional, professional development programs for certified personnel
7 throughout the Commonwealth that are based on the statewide needs of teachers,
8 administrators, and other education personnel. Programs may include classified
9 staff and parents when appropriate. Programs offered or facilitated by the
10 department shall be at locations and times convenient to local school personnel and
11 shall be made accessible through the use of technology when appropriate. They
12 shall include programs that: address the goals for Kentucky schools as stated in
13 KRS 158.6451, including reducing the achievement gaps as determined by an
14 equity analysis of the disaggregated student performance data from the state
15 assessment program developed under KRS 158.6453; engage educators in effective
16 learning processes and foster collegiality and collaboration; and provide support for
17 staff to incorporate newly acquired skills into their work through practicing the
18 skills, gathering information about the results, and reflecting on their efforts.
19 Professional development programs shall be made available to teachers based on
20 their needs which shall include but not be limited to the following areas:

- 21 (a) Strategies to reduce the achievement gaps among various groups of students
22 and to provide continuous progress;
- 23 (b) Curriculum content and methods of instruction for each content area,
24 including differentiated instruction;
- 25 (c) School-based decision making;
- 26 (d) Assessment literacy;
- 27 (e) Integration of performance-based student assessment into daily classroom

- 1 instruction;
- 2 (f) Nongraded primary programs;
- 3 (g) Research-based instructional practices;
- 4 (h) Instructional uses of technology;
- 5 (i) Curriculum design to serve the needs of students with diverse learning styles
6 and skills and of students of diverse cultures;
- 7 (j) Instruction in reading, including phonics, phonemic awareness,
8 comprehension, fluency, and vocabulary;
- 9 (k) Educational leadership; and
- 10 (l) Strategies to incorporate character education throughout the curriculum.

11 ~~(5)~~~~(4)~~ The department shall assist school personnel in assessing the impact of
12 professional development on their instructional practices and student learning.

13 ~~(6)~~ ~~(a)~~~~(5)~~ **Upon the request of a school district or school council,** the department
14 shall assist ~~[districts and school councils]~~ with the development of long-term
15 school and district improvement plans that include multiple strategies for
16 professional development based on the assessment of needs at the school
17 level.

18 ~~(b)~~~~(a)~~ Professional development strategies may include but are not limited to
19 participation in subject matter academies, teacher networks, training institutes,
20 workshops, seminars, and study groups; collegial planning; action research;
21 mentoring programs; appropriate university courses; and other forms of
22 professional development.

23 ~~(c)~~~~(b)~~ In planning the use of the four (4) days for professional development
24 under KRS 158.070, school councils and districts shall give priority to
25 programs that increase teachers' understanding of curriculum content and
26 methods of instruction appropriate for each content area based on individual
27 school plans. The district may use up to one (1) day to provide district-wide

1 training and training that is mandated by state or federal law. Only those
2 employees identified in the mandate or affected by the mandate shall be
3 required to attend the training.

4 ~~(d)~~~~(e)}~~ State funds allocated for professional development shall be used to
5 support professional development initiatives that are consistent with local
6 school improvement and professional development plans and teachers'
7 individual growth plans. The funds may be used throughout the year for all
8 staff, including classified and certified staff and parents on school councils or
9 committees. A portion of the funds allocated to each school council under
10 KRS 160.345 may be used to prepare or enhance the teachers' knowledge and
11 teaching practices related to the content and subject matter that are required
12 for their specific classroom assignments.

13 ~~{(6) (a) The Kentucky Cabinet for Health and Family Services shall post on its web~~
14 ~~page evidence based suicide prevention awareness information, to include~~
15 ~~recognizing the warning signs of a suicide crisis. The web page shall include~~
16 ~~information related to suicide prevention training opportunities offered by the~~
17 ~~cabinet or an agency recognized by the cabinet as a training provider.~~

18 ~~(b) Every public school and public charter school shall provide two (2) evidence-~~
19 ~~based suicide prevention awareness lessons each school year, the first by~~
20 ~~September 15 and the second by January 15, either in person, by live~~
21 ~~streaming, or via a video recording to all students in grades six (6) through~~
22 ~~twelve (12). Every public school shall provide an opportunity for any student~~
23 ~~absent on the day the evidence based suicide prevention awareness lesson was~~
24 ~~initially presented to receive the lesson at a later time. The information may~~
25 ~~be obtained from the Cabinet for Health and Family Services or from a~~
26 ~~commercially developed suicide prevention training program.~~

27 ~~(c) 1. Each school year, a minimum of one (1) hour of high quality evidence-~~

1 based suicide prevention training, including risk factors, warning signs,
2 protective factors, response procedures, referral, postvention, and the
3 recognition of signs and symptoms of possible mental illness, shall be
4 required for all school district employees with job duties requiring direct
5 contact with students in grades four (4) through twelve (12). The
6 training shall be provided either in person, by live streaming, or via a
7 video recording and may be included in the four (4) days of professional
8 development under KRS 158.070. As used in this subparagraph,
9 "postvention" means a series of planned supports and interventions with
10 persons affected by a suicide for the purpose of facilitating the grieving
11 or adjustment process, stabilizing the environment, reducing the risk of
12 negative behaviors, and limiting the risk of further suicides through
13 contagion.

14 2. ~~When a staff member subject to the training under subparagraph 1. of~~
15 ~~this paragraph is initially hired during a school year in which the~~
16 ~~training is not required, the local district shall provide suicide prevention~~

18 (d) ~~The requirements of paragraphs (b) and (c) of this subsection shall apply to~~
19 ~~public charter schools as a health and safety requirement under KRS~~
20 ~~160.1592(1).~~

21 (7) (a) ~~By November 1 of each year, a minimum of one (1) hour of training on how~~
22 ~~to respond to an active shooter situation shall be required for all school district~~
23 ~~employees with job duties requiring direct contact with students. The training~~
24 ~~shall be provided either in person, by live streaming, or via a video recording~~
25 ~~prepared by the Kentucky Department of Criminal Justice Training in~~
26 ~~collaboration with the Kentucky Law Enforcement Council, the Kentucky~~
27 ~~Department of Education, and the Center for School Safety and may be~~

1 included in the four (4) days of professional development under KRS
2 158.070.

3 (b) ~~When a staff member subject to the training requirements of this subsection is~~
4 ~~initially hired after the training has been provided for the school year, the~~
5 ~~local district shall provide materials on how to respond to an active shooter~~
6 ~~situation.~~

7 (c) ~~The requirements of this subsection shall also apply to public charter schools~~
8 ~~as a health and safety requirement under KRS 160.1592(1).]~~

9 ~~(7)~~~~(8)~~ (a) The department~~[Kentucky Department of Education]~~ shall develop and
10 maintain a list of approved comprehensive evidence-informed trainings on
11 child abuse and neglect prevention, recognition, and reporting that encompass
12 child physical, sexual, and emotional abuse and neglect.

13 (b) The trainings shall be web-based or in-person and cover, at a minimum, the
14 following topics:

- 15 1. Recognizing child physical, sexual, and emotional abuse and neglect;
- 16 2. Reporting suspected child abuse and neglect in Kentucky as required by
17 KRS 620.030 and the appropriate documentation;
- 18 3. Responding to the child; and
- 19 4. Understanding the response of child protective services.

20 (c) The trainings shall include a questionnaire or other basic assessment tool upon
21 completion to document basic knowledge of training components.

22 (d) Each local board of education shall adopt one (1) or more trainings from the
23 list approved by the department~~[Department of Education]~~ to be implemented
24 by schools.}

25 (e) ~~All school administrators, certified personnel, office staff, instructional~~
26 ~~assistants, and coaches and extracurricular sponsors who are employed by the~~
27 ~~school district shall complete the implemented training or trainings within~~

1 ninetly ~~(90)~~ days of being hired and then every two ~~(2)~~ years after.

2 ~~(f) Every public school shall prominently display the statewide child abuse~~
3 ~~hotline number administered by the Cabinet for Health and Family Services,~~
4 ~~the National Human Trafficking Reporting Hotline number administered by~~
5 ~~the United States Department for Health and Human Services, and the Safe~~
6 ~~Haven Baby Boxes Crisis Line number administered by the Safe Haven Baby~~
7 ~~Boxes national organization or any equivalent successor entity.~~

8 ~~(g) The requirements of this subsection shall also apply to public charter schools~~
9 ~~as a health and safety requirement under KRS 160.1592(1).]~~

10 ~~(8)~~~~(9)~~ The department~~[Department of Education]~~ shall establish an electronic
11 consumer bulletin board that posts information regarding professional development
12 providers and programs as a service to school district central office personnel,
13 school councils, teachers, and administrators. Participation on the electronic
14 consumer bulletin board shall be voluntary for professional development providers
15 or vendors, but shall include all programs sponsored by the department. Participants
16 shall provide the following information: program title; name of provider or vendor;
17 qualifications of the presenters or instructors; objectives of the program; program
18 length; services provided, including follow-up support; costs for participation and
19 costs of materials; names of previous users of the program, addresses, and
20 telephone numbers; and arrangements required. Posting information on the bulletin
21 board by the department shall not be viewed as an endorsement of the quality of
22 any specific provider or program.

23 ~~(9)~~~~(10)~~ The department~~[Department of Education]~~ shall provide voluntary training to
24 address the characteristics and instructional needs of students at risk of school
25 failure and most likely to drop out of school. The training shall be developed to
26 meet the specific needs of all certified and classified personnel depending on their
27 relationship with these students. The training for instructional personnel shall be

1 designed to provide and enhance skills of personnel to:

- 2 (a) Identify at-risk students early in elementary schools as well as at-risk and
3 potential dropouts in the middle and high schools;
- 4 (b) Plan specific instructional strategies to teach at-risk students;
- 5 (c) Improve the academic achievement of students at risk of school failure by
6 providing individualized and extra instructional support to increase
7 expectations for targeted students;
- 8 (d) Involve parents as partners in ways to help their children and to improve their
9 children's academic progress; and
- 10 (e) Significantly reduce the dropout rate of all students.

11 ~~(10)~~~~(11)~~ The department shall establish teacher academies to the extent funding is
12 available in cooperation with postsecondary education institutions for elementary,
13 middle school, and high school faculty in core disciplines, utilizing facilities and
14 faculty from universities and colleges, local school districts, and other appropriate
15 agencies throughout the state. Priority for participation shall be given to those
16 teachers who are teaching core discipline courses for which they do not have a
17 major or minor or the equivalent. Participation of teachers shall be voluntary.

18 ~~(11)~~~~(12)~~ The department shall annually provide to the oversight council established in
19 KRS 15A.063, the information received from local schools pursuant to KRS
20 158.449.

21 ➔SECTION 4. A NEW SECTION OF KRS CHAPTER 158 IS CREATED TO
22 READ AS FOLLOWS:

23 **Every public school shall prominently display the statewide child abuse hotline number**
24 **administered by the Cabinet for Health and Family Services, the National Human**
25 **Trafficking Hotline number administered by the United States Department for Health**
26 **and Human Services, and the Safe Haven Baby Boxes Crisis Line number**
27 **administered by the Safe Haven Baby Boxes national organization or any equivalent**

1 successor entity. The requirements of this section shall also apply to public charter
 2 schools as a health and safety requirement under KRS 160.1592(1).

3 ➔SECTION 5. A NEW SECTION OF KRS CHAPTER 158 IS CREATED TO
 4 READ AS FOLLOWS:

5 (1) The Cabinet for Health and Family Services shall post on its website high-
 6 quality, evidence-based suicide prevention awareness information, which shall
 7 include information on recognizing the warning signs of a suicide crisis. The
 8 website shall include information related to suicide prevention training
 9 opportunities offered by the cabinet or an agency recognized by the cabinet as a
 10 training provider.

11 (2) Every public school and public charter school shall provide two (2) high quality,
 12 evidence-based suicide prevention awareness lessons each school year, the first
 13 by September 15 and the second by January 15, either in person, by live
 14 streaming, or via a video recording to all students in grades six (6) through twelve
 15 (12). Every public school shall provide an opportunity for any student absent on
 16 the day the high quality, evidence-based suicide prevention awareness lesson was
 17 initially presented to receive the lesson at a later time. The information may be
 18 obtained from the Cabinet for Health and Family Services or from a
 19 commercially developed suicide prevention training program.

20 ➔Section 6. KRS 158.070 is amended to read as follows:

21 (1) As used in this section:

- 22 (a) "Election" has the same meaning as in KRS 121.015;
- 23 (b) "Minimum school term" or "school term" means not less than one hundred
 24 eighty-five (185) days composed of the student attendance days, teacher
 25 professional days, and holidays;
- 26 (c) "School calendar" means the document adopted by a local board of education
 27 that establishes the minimum school term, student instructional year or

- 1 variable student instructional year, and days that school will not be in session;

13 (9) The Education Professional Standards Board shall accumulate long-term data for

16 ➔Section 9. KRS 156.492 is amended to read as follows:

17 (1) The Kentucky Department of Education may enter into an agreement with any
18 building and construction trade organization to develop a training program for
19 school counselors providing services to students in the Commonwealth. The
20 purpose of the training program shall be to promote building and construction
21 trades and training facilities available to students by making school counselors
22 aware of what is available to students participating in the building and construction
23 trade. The training program shall include information relating to:

- 19 (1) (a) In determining the cost of the program to support education excellence in

7 instrumental music, and physical education classes. Except as provided in

9 class shall be as follows:

- 10 1. Twenty-four (24) in primary grades (kindergarten through third grade);

14 (b) Except for those schools which have implemented school-based decision

23 (12) (a) Instructional salaries for vocational agriculture classes shall be for twelve (12)
24 months per year. Vocational agriculture teachers shall be responsible for the

26 school term established by the local board of education: supervision and
27 instruction of students in agriculture experience programs; group and

1 individual instruction of farmers and agribusinessmen; supervision of student

13 (1) The Kentucky Board of Education shall have the management and control of the
14 common schools and all programs operated in these schools, including
15 interscholastic athletics, the Kentucky School for the Deaf, the Kentucky School for
16 the Blind, and community education programs and services.

17 (2) The Kentucky Board of Education may designate an organization or agency to
18 manage interscholastic athletics in the common schools, provided that the rules,
19 regulations, and bylaws of any organization or agency so designated shall be
20 approved by the board, and provided further that any administrative hearing
21 conducted by the designated managing organization or agency shall be conducted in
22 accordance with KRS Chapter 13B.

23 (a) The state board or its designated agency shall assure through promulgation of
24 administrative regulations that if a secondary school sponsors or intends to

26 National Collegiate Athletic Association members offer an athletic
27 scholarship, the school shall sponsor the athletic activity or sport for which a

2 athletic activities are similar to sports for which National Collegiate Athletic
3 Association members offer scholarships.

4 (b) Beginning with the 2003-2004 school year, the state board shall require any
5 agency or organization designated by the state board to manage interscholastic

- 7 2. A nonmember at-home private school's team and students shall comply
8 with the rules for student-athletes, including rules concerning:
- 9 a. Age;
- 10 b. School semesters;
- 11 c. Scholarships;
- 12 d. Physical exams;
- 13 e. Foreign student eligibility; and
- 14 f. Amateurs.
- 15 3. A coach of a nonmember at-home private school's team shall comply
16 with the rules concerning certification of member school coaches as
17 required by the state board or any agency designated by the state board
18 to manage interscholastic athletics.
- 19 4. This subsection shall not allow a nonmember at-home private school's
20 team to participate in a sanctioned:
- 21 a. Conference;
- 22 b. Conference tournament;
- 23 c. District tournament;
- 24 d. Regional tournament; or
- 25 e. State tournament or event.
- 26 5. This subsection does not allow eligibility for a recognition, award, or
27 championship sponsored by the state board or any agency designated by

1 the state board to manage interscholastic athletics.

2 6. A nonmember at-home private school's team or students may participate
3 in interscholastic athletics permitted, offered, or sponsored by the state
4 board or any agency designated by the state board to manage
5 interscholastic athletics.

6 (e) Every local board of education shall require an annual medical examination
7 performed and signed by a physician, physician assistant, advanced practice
8 registered nurse, or chiropractor, if performed within the professional's scope
9 of practice, for each student seeking eligibility to participate in any school
10 athletic activity or sport. The Kentucky Board of Education or any
11 organization or agency designated by the state board to manage interscholastic
12 athletics shall not promulgate administrative regulations or adopt any policies
13 or bylaws that are contrary to the provisions of this paragraph.

14 (f) Any student who turns nineteen (19) years of age prior to August 1 shall not
15 be eligible for high school athletics in Kentucky. Any student who turns
16 nineteen (19) years of age on or after August 1 shall remain eligible for that

13 unedited birth certificate issued at the time of birth; or
 - 14 b. An affidavit signed and sworn to by the physician, physician

17 (e) of this subsection under penalty of perjury establishing the
18 student's biological sex at the time of birth;
 - 19 3.
 - 20 a. An athletic activity or sport designated as "girls" for students in
21 grades six (6) through twelve (12) shall not be open to members of
22 the male sex.
 - 23 b. Nothing in this section shall be construed to restrict the eligibility
24 of any student to participate in an athletic activity or sport
25 designated as "boys" or "coed"; and
 - 26 4. Neither the state board, any agency designated by the state board to
27 manage interscholastic athletics, any school district, nor any member
school shall entertain a complaint, open an investigation, or take any

1 other adverse action against a school for maintaining separate
2 interscholastic or intramural athletic teams, activities, or sports for
3 students of the female sex.

- 4 (h) 1. The state board or any agency designated by the state board to manage
5 interscholastic athletics shall promulgate administrative regulations that
6 permit a school district to employ or assign nonteaching or noncertified
7 personnel or personnel without postsecondary education credit hours to
8 serve in a coaching position. The administrative regulations shall give
9 preference to the hiring or assignment of certified personnel in coaching
10 positions.
- 11 2. A person employed in a coaching position shall be a high school
12 graduate and at least twenty-one (21) years of age and shall submit to a
13 criminal background check in accordance with KRS 160.380.
- 14 3. The administrative regulations shall specify post-hire requirements for

1 participating in a varsity sport shall be ineligible to participate in
2 interscholastic athletics for one (1) calendar year from the date of the transfer.

11 state board or any agency designated by the state board to manage

14 (3) (a) The Kentucky Board of Education is hereby authorized to lease from the State
15 Property and Buildings Commission or others, whether public or private, any
16 lands, buildings, structures, installations, and facilities suitable for use in
17 establishing and furthering television and related facilities as an aid or
18 supplement to classroom instruction throughout the Commonwealth and for
19 incidental use in any other proper public functions. The lease may be for any
20 initial term commencing with the date of the lease and ending with the next
21 ensuing June 30, which is the close of the then-current fiscal biennium of the
22 Commonwealth, with exclusive options in favor of the board to renew the
23 same for successive ensuing bienniums, July 1 in each even year to June 30 in
24 the next ensuing even year; and the rentals may be fixed at the sums in each
25 biennium, if renewed, sufficient to enable the State Property and Buildings
26 Commission to pay therefrom the maturing principal of and interest on, and
27 provide reserves for, any revenue bonds which the State Property and

1 Buildings Commission may determine to be necessary and sufficient, in
2 agreement with the board, to provide the cost of acquiring the television and
3 related facilities with appurtenances and costs as may be incident to the
4 issuance of the bonds.

5 (b) Each option of the Kentucky Board of Education to renew the lease for a
6 succeeding biennial term may be exercised at any time after the adjournment
7 of the session of the General Assembly at which appropriations shall have
8 been made for the operation of the state government for such succeeding
9 biennial term, by notifying the State Property and Buildings Commission in
10 writing, signed by the chief state school officer, and delivered to the secretary
11 of the Finance and Administration Cabinet as a member of the commission.
12 The option shall be deemed automatically exercised, and the lease
13 automatically renewed for the succeeding biennium, effective on the first day
14 thereof, unless a written notice of the board's election not to renew shall have
15 been delivered in the office of the secretary of the Finance and Administration

18 (c) The Kentucky Board of Education shall not itself operate leased television
19 facilities, or undertake the preparation of the educational presentations or
20 films to be transmitted thereby, but may enter into one (1) or more contracts
21 to provide therefor, with any public agency and instrumentality of the
22 Commonwealth having, or able to provide, a staff with proper technical
23 qualifications, upon which agency and instrumentality the board, through the
24 chief state school officer and the Department of Education, is represented in
25 such manner as to coordinate matters of curriculum with the curricula
26 prescribed for the public schools of the Commonwealth. Any contract for the
27 operation of the leased television or related facilities may permit limited and

1 special uses of the television or related facilities for other programs in the
2 public interest, subject to the reasonable terms and conditions as the board and
3 the operating agency and instrumentality may agree upon; but any contract
4 shall affirmatively forbid the use of the television or related facilities, at any
5 time or in any manner, in the dissemination of political propaganda or in
6 furtherance of the interest of any political party or candidate for public office,
7 or for commercial advertising. No lease between the board and the State
8 Property and Buildings Commission shall bind the board to pay rentals for
9 more than one (1) fiscal biennium at a time, subject to the aforesaid renewal
10 options. The board may receive and may apply to rental payments under any
11 lease and to the cost of providing for the operation of the television or related
12 facilities not only appropriations which may be made to it from state funds,
13 from time to time, but also contributions, gifts, matching funds, devises, and
14 bequests from any source, whether federal or state, and whether public or
15 private, so long as the same are not conditioned upon any improper use of the
16 television or related facilities in a manner inconsistent with the provisions of
17 this subsection.

18 (4) The state board may, on the recommendation and with the advice of the chief state
19 school officer, prescribe, print, publish, and distribute at public expense such
20 administrative regulations, courses of study, curriculums, bulletins, programs,
21 outlines, reports, and placards as each deems necessary for the efficient
22 management, control, and operation of the schools and programs under its
23 jurisdiction. All administrative regulations published or distributed by the board
24 shall be enclosed in a booklet or binder on which the words "informational copy"
25 shall be clearly stamped or printed.

26 (5) Upon the recommendation of the chief state school officer or his or her designee,
27 the state board shall establish policy or act on all matters relating to programs,

1 services, publications, capital construction and facility renovation, equipment,
2 litigation, contracts, budgets, and all other matters which are the administrative
3 responsibility of the Department of Education.

4 **(6) On or after the effective date of this Act, the state board shall not impose any new**
5 **reporting requirement upon public schools or public school districts that is not**
6 **expressly authorized by state statute or federal law.**

7 ➔Section 12. (1) No later than August 1, 2025, the Kentucky Department of
8 Education shall submit a report to the Legislative Research Commission for referral to
9 the Education Assessment and Accountability Review Subcommittee on continuous
10 school and district improvement plans. The report shall identify each submission request
11 contained in the Cognia software interface used by public schools to complete continuous
12 school improvement plans and school districts to complete continuous district
13 improvement plans. For each submission request, the report shall:

14 (a) Include a screenshot of the full submission request;

15 (b) Identify the specific federal law or state statute that directly requires the
16 submission request. If no federal law or state statute directly requires a specific
17 submission request, the report shall clearly indicate that fact;

18 (c) Identify the criteria used by the department to evaluate a school or school
19 district's response to the submission request; and

20 (d) If the federal law or state statutory requirement for a specific submission
21 request does not apply equally to all schools:

22 1. Identify the criteria used to identify schools and districts subject to that
23 submission request;

24 2. State the number and percentage of schools and districts that met the criteria
25 used to identify schools and districts subject to each specific submission request during
26 the 2024-2025 school year; and

27 3. State whether the Cognia software permits schools and districts not subject to

1 the submission request a clear opportunity to bypass the submission request. If so, the
2 report shall provide screenshots of the instructions provided to the software user on the
3 procedure to bypass a submission request not required from a particular school or district.

4 (2) No later than October 1, 2025, the department shall submit report to the
5 Legislative Research Commission for referral to the Education Assessment and
6 Accountability Review Subcommittee that lists each submission request that is not
7 directly required by a specific federal law or state statute that the department
8 recommends the General Assembly to authorize in statute during the 2026 Regular
9 Session.

10 (3) No later than August 1, 2026, each submission request that is not directly
11 required by a specific federal law or state statute on that date shall be eliminated from the
12 school and district planning process and removed from the designated school planning
13 software interface.

14 (4) No later than August 1, 2026, the designated school planning software
15 interface shall be replaced or updated to provide schools or districts not subject to a
16 specific federal law or state statutory requirement a clear opportunity to bypass the
17 submission request. The department, in their role as the designated state education agency
18 responsible for the oversight and management of school assessment and accountability,
19 shall be responsible for auditing school and school district compliance with federal
20 reporting requirements and ensure that each school and district has satisfied the reporting
21 requirements of federal law and state statute.

22 ➔Section 13. (1) The Kentucky Department of Education shall conduct a
23 review of the reporting requirements imposed upon public schools and school districts.
24 No later than October 1, 2025, the department shall submit a written report to the to the
25 Legislative Research Commission for referral to the appropriate Interim Joint Committee
26 on Education which describes each reporting requirement imposed upon public schools
27 and school districts. The report shall include:

- 1 (a) The nature and purpose of each reporting requirement;
- 2 (b) The specific legal authority of each reporting requirement;
- 3 (c) The required contents of each required report;
- 4 (d) The function or purpose of each required report;
- 5 (e) The frequency of each required report;
- 6 (f) The year the reporting requirement was implemented;
- 7 (g) Whether and how each required report is leveraged to improve the quality of
- 8 public education in the Commonwealth; and

9 (h) An analysis of whether the reporting requirement is conducive to an efficient

10 and effective system of common schools.

11 (2) The report required by subsection (1) of this section shall be organized by the

12 specific legal source of authority of each reporting requirement. The report shall clearly

13 distinguish between reporting requirements expressly required pursuant to federal law,

14 state statute, and all other reporting requirements.

15 (3) All reporting requirements identified under this section imposed upon public

16 schools and school districts that are not expressly required by state statute or federal law

17 shall have no force and effect after June 30, 2026, unless preserved in statute by an act of

18 the General Assembly. No later than July 1, 2026, the Kentucky Department of Education

19 shall eliminate all reporting requirements not expressly required by state statute or federal

20 law. The department shall promptly notify each public school, school district, and the

21 Legislative Research Commission of the reporting requirements eliminated in accordance

22 with this section.

23 ➔Section 14. This Act may be cited as the Red Tape Reduction Act.
