1	AN ACT relating to nuclear energy development, making an appropriation therefor,
2	and declaring an emergency.
3	Be it enacted by the General Assembly of the Commonwealth of Kentucky:
4	→ SECTION 1. A NEW SECTION OF KRS CHAPTER 164 IS CREATED TO
5	READ AS FOLLOWS:
6	(1) The Kentucky Nuclear Energy Development Authority established in Section 2 of
7	this Act shall create and implement the Nuclear Energy Development Grant
8	Program for the advancement and location of nuclear energy-related projects to
9	support the entire nuclear energy ecosystem in the Commonwealth, including
10	utility and private sector economic development activities. The nuclear energy
11	ecosystem includes but is not limited to:
12	(a) The nuclear fuel cycle, which includes fuel conversion, enrichment, and
13	fabrication, as well as potential future spent fuel recycling and
14	reprocessing;
15	(b) Reactor design and component manufacturing;
16	(c) Component supply chain manufacturing and distribution;
17	(d) Facility siting and development;
18	(e) Radioisotope production;
19	(f) Facility operation and maintenance;
20	(g) Decommissioning waste storage, transport, and management; and
21	(h) End uses of nuclear energy and co-products.
22	(2) The membership of the Kentucky Nuclear Energy Development Authority shall
23	select five (5) of its voting members to serve on the nuclear energy development
24	grant administration subcommittee. A majority of the members of the grant
25	administration subcommittee shall constitute a quorum for the purposes of doing
26	business. The subcommittee shall:
27	(a) Create grant applications;

1		<u>(D)</u>	Establish grant applicant eligibility requirements;
2		<u>(c)</u>	Establish objective scoring criteria to evaluate grant applications, including
3			but not limited to:
4			1. The likelihood that the proposed project funded by the grant will

6			2. The economic impact of the grant funding on the community and
7			region where the proposed project will be located;
8			3. The readiness of the community where the proposed project will be
9			located to host nuclear-related investments, including whether the
10			community has been awarded a nuclear-ready community designation
11			under KRS 164.2804; and
12			4. The amount of additional investment that would be made in the
13			proposed project by the grant applicant and other sources; and
14		<u>(d)</u>	Make determinations on grant eligibility and funding and make grant
15			awards based on those determinations, not to exceed two million dollars
16			(\$2,000,000) per individual grant.

- 2 (4) A majority of the voting members of the advisory board shall constitute a quorum
- for the purposes of conducting business. The advisory board shall meet at least
- 4 quarterly, or more often at the call of the chair.
- 5 (5) Members of the advisory board shall not be paid for their service as board
- 6 members, and they shall not be reimbursed for any expenses relating to their
- 7 attendance of board meetings.
- 8 (6) The advisory board shall hire a director of the authority who shall possess the skills
- 9 and experience necessary to lead the authority effectively, promote the safe and
- responsible development of nuclear energy, *publicize and encourage application to*
- 11 the Nuclear Energy Development Grant Program established in Section 1 of this
- 12 <u>Act</u>, and achieve the authority's purposes described in subsection (7) of this section.
- 13 (7) The purposes of the authority shall be to:
- 14 (a) Assist interested communities in understanding advanced nuclear

- 19 (b) Provide information to the public on the history of nuclear energy
- 20 technologies in the Commonwealth, the status of existing nuclear energy
- 21 projects within the Commonwealth, and the potential benefits and concerns
- 22 associated with nuclear energy technologies;
- 23 (c) Develop the capacity for nuclear energy economic development in the
- 24 Commonwealth, which shall include providing information to educational
- institutions on the types of career opportunities that will be available with the
- development of nuclear energy, building strong relationships with economic
- 27 development professionals, promoting existing economic development

1 incentives applicable to nuclear energy development, and seeking out new 2 grants and other financial support for nuclear energy development; 3 (d) Seek greater clarity and certainty with stakeholders on financial support for early nuclear site permitting, the process for obtaining a nuclear power facility 4 certificate of public convenience and necessity, and the recovery of 5 6 construction work in progress for nuclear energy projects; 7 Work with communities that have previously hosted nuclear-related activities (e) 8 and other communities facing a transition away from fossil fuels to empower 9 those communities with the resources and information necessary to engage 10 with regulators, developers, and decisionmakers on new nuclear power 11 facilities, nuclear component manufacturing facilities, and fuel cycle facilities; 12 (f) Strengthen engagement with the federal Nuclear Regulatory Commission by reviewing current safety and security practices implemented at different types 13 14 of nuclear energy facilities under their purview, promoting the streamlining of 15 permitting efforts, and supporting the siting of interim and permanent nuclear 16 storage facilities via the continued use of consent-based siting; 17 Build the organizational capacity to engage and potentially convene a (g) 18 consortium of stakeholders interested in nuclear energy technologies that 19 would consist of utilities, environmental advocates, electric cooperatives, and 20 major industrial companies in order to share best practices, including how to 21 share risk associated with developing and constructing new nuclear power 22 plants within the Commonwealth; 23 Engage with the United States Department of Energy National Laboratories, (h) 24 academic institutions, and private companies on efforts to develop deployable 25 technologies to reprocess or recycle spent nuclear fuel; and 26 (i) Maintain awareness of potential events that could initiate or accelerate the

development of new nuclear energy technologies within the Commonwealth

7			including for the Nuclear Energy Development Grant Program established
8			in Section 1 of this Act;
9		(b)	Develop and adopt a strategic plan for carrying out the purposes of the
10			authority described in subsection (7) of this section;
11		(c)	Create and update at least once every two (2) years a nuclear energy economic
12			impact analysis for the Commonwealth;
13		(d)	Employ necessary staff to carry out the functions of the authority; and
14		(e)	By December 1, 2025, and each December 1 thereafter, submit a report to the
15			Governor and the Legislative Research Commission for referral to the Interim
16			Joint Committees on Natural Resources and Energy, Appropriations and
17			Revenue, and Economic Development and Workforce Investment providing:
18			1. A summary of the authority's activities and achievements since its last
19			report <u>:</u>
20			2. The evaluations and scores of all nuclear energy development grant
21			applications received and all grant awards made pursuant to Section 1
22			of this Act since its last report; and
23			<u>3.</u> [offering ]Recommendations for the support and expansion of the
24			nuclear energy ecosystem in the Commonwealth.
25		<b>→</b> Se	ection 3. 2024 Ky. Acts ch. 173, sec. 1, (207), at page 1766, is amended to
26	read	as fol	llows:

be invested as a quasi-endowment by the University. *Of this amount, \$8,000,000 may be*

- 4 Program at the Pigman College of Engineering in Paducah, Kentucky. The interest
- 5 earned on the investment shall be used for the Center for Applied Energy Research's

- 7 the Energy Planning and Inventory Commission;
- 8 → Section 4. The following KRS section is repealed:
- 9 154.12-340 Financial assistance program for nuclear energy-related projects -- Cabinet

- → Section 5. Whereas it is critical to the economic development and energy
- reliability goals of the Commonwealth that grant funding be made available to contribute
- 13 to the advancement and location of nuclear energy-related projects in Kentucky, an
- emergency is declared to exist, and this Act takes effect upon its passage and approval by
- the Governor or upon its otherwise becoming a law.
