11			5.	Natural gas processing, fractionation, stabilization, and compressor
12				station facilities, as well as above-ground natural gas or petroleum
13				pipelines and related facilities;
14			6.	Railroad yards and railroad tunnel portals;
15			7.	A drinking water collection, treatment, or storage facility;
16			8.	Grounds or property of a state prison, juvenile justice facility, jail, or
17				other facility for the detention of persons charged with or convicted of
18				crimes;
19			9.	A facility used for research, development, design, production, delivery,
20				or maintenance of military weapons systems, subsystems, and
21				components or parts to meet military requirements of the United States;

9		(b)	"Unmanned aircraft system" means an aircraft that is operated without the
10			possibility of direct human interaction from within or on the aircraft and
11			includes everything that is on board or otherwise attached to the aircraft and
12			all associated elements, including communication links and the components
13			that control the small unmanned aircraft, that are required for the safe and
14			efficient operation of the unmanned aircraft in the national airspace system.
15	(2)	(a)	A person commits the offense of trespass upon key infrastructure assets if he
16			or she knowingly enters or remains unlawfully in or upon real property on
17			which key infrastructure assets are located.
18		(b)	A person commits the offense of trespass upon key infrastructure assets if he
19			or she knowingly uses, or retains or authorizes a person to use, an unmanned
20			aircraft system to fly above real property on which key infrastructure assets
21			are located with the intent to cause harm or damage to or conduct surveillance
22			of the key infrastructure asset without the prior consent of the owner, tenant,
23			or lessee of the real property.
24		(c)	A person commits the offense of trespass upon key infrastructure assets if he
25			or she knowingly, without consent of the owner or authorized representative:
26			1. Operates an unmanned aircraft system, video recording device, audio
27			recording device, or photography equipment on or above property

1			containing a key infrastructure asset referenced in subsection (1)(a)12.,
2			13., or 14. of this section; or
3			2. Records or distributes, photographically, electronically, or otherwise,
4			any part, procedure, or action of a key infrastructure asset referenced in

12		→ S	ection 2. KRS 512.020 is amended to read as follows:
13	(1)	A pe	erson is guilty of criminal mischief in the first degree when, having no right to
14		do s	o or any reasonable ground to believe that he or she has such right, he or she
15		inter	ntionally or wantonly:
16		(a)	Defaces, destroys, or damages any property causing pecuniary loss of five
17			hundred dollars (\$500) or more;
18		(b)	<u>Damages</u> , <u>possesses</u> , <u>or</u> tampers with the operations of a key infrastructure
19			asset, as defined in KRS 511.100, in a manner that renders the <u>asset</u>
20			inoperable, in whole or in part, or renders the operation of the
21			asset [operations] harmful or dangerous; or
22		(c)	As a tenant, intentionally or wantonly defaces, destroys, or damages
23			residential rental property causing pecuniary loss of five hundred dollars
24			(\$500) or more.
25	(2)	Crin	ninal mischief in the first degree is a Class D felony, unless:
26		(a)	The offense occurs during a declared emergency as defined by KRS 39A.020
27			arising from a natural or man-made disaster, within the area covered by the

emergency declaration, and within the area impacted by the disaster, in which case it is a Class C felony;

- (b) For the first offense, if the defendant at any time prior to trial effects repair or replacement of the defaced, destroyed, or damaged property, makes complete restitution in the amount of the damage, or performs community service as required by the court, in which case it is a Class B misdemeanor. The court shall determine the number of hours of community service commensurate with the total amount of monetary damage caused by or incidental to the commission of the crime, of not less than sixty (60) hours; or
- (c) For the second or subsequent offense, if the defendant at any time prior to trial effects repair or replacement of the defaced, destroyed, or damaged property, makes complete restitution in the amount of the damage, or performs community service as required by the court, in which case it is a Class A misdemeanor. The court shall determine the number of hours of community service commensurate with the total amount of monetary damage caused by or incidental to the commission of the crime, of not less than sixty (60) hours.
- → Section 3. Whereas threats to key infrastructure assets represent an ongoing danger to communities in the Commonwealth, an emergency is declared to exist, and this Act takes effect upon its passage and approval by the Governor or upon its otherwise becoming a law.
