5			regarding the possession and use of a personal telecommunications device by
6			a student while on school property or while attending a school-sponsored or
7			school-related activity on or off school property, and shall include the policy
8			in the district's written standards of student conduct.
9		<u>(b)</u>	The policy shall, at a minimum, prohibit a student's use of a personal
10			telecommunications device during instructional time, except during an
11			emergency, if directed to do so by a teacher for an instructional purpose, or
12			if authorized by a teacher.
13		<u>(c)</u>	A student who violates the policy shall be subject to discipline as provided by
14			board policy.
15	(2)	<u>As u</u>	esed in this section, "personal telecommunications device":
16		<u>(a)</u>	Means a device that emits an audible signal, vibrates, displays a message, or

1 (2)Each local school district and school shall utilize the latest available filtering 2 technology to ensure that social media and sexually explicit material is not made 3 available to students. 4 (3) The Kentucky Department of Education shall make available to school districts and 5 schools upon request and without cost, state-of-the-art software products that enable 6 local districts and schools to prevent access to social media and sexually explicit 7 material. The department shall also notify all school districts and schools of the 8 availability of the software. Any product provided or obtained by a district or 9 school shall meet the requirements of subsection (2) of this section. 10 Each local school district shall establish a policy regarding student internet access (4) 11 that shall include [,] but not be limited to [,] parental consent for student internet use, 12 teacher supervision of student computer use, and auditing procedures to determine 13 whether education technology is being used for the purpose of accessing social 14 *media or* sexually explicit or other objectionable material.

The provisions of subsections (1) to (4) of this section shall only apply to social *(*5*)* media that a student is not authorized by a teacher to access for an instructional 16 purpose.
