5			regarding the possession and use of a personal telecommunications device by
6			a student while on school property or while attending a school-sponsored or
7			school-related activity on or off school property, and shall include the policy
8			in the district's written standards of student conduct.
9		<u>(b)</u>	The policy shall, at a minimum, forbid a student's use of a personal
10			telecommunications device during the school day, except during an
11			emergency or if directed to do so by a teacher for an instructional purpose.
12		<u>(c)</u>	A student who violates the policy shall be subject to discipline as provided by
13			board policy.
14	(2)	<u>As u</u>	used in this section, "personal telecommunications device":
15		<u>(a)</u>	Means a device that emits an audible signal, vibrates, displays a message, or
16			otherwise summons or delivers a communication to the possessor, including[,,
17			but not limited to [,] a paging device and a cellular telephone; and
18		<u>(b)</u>	Does not include any device a student is authorized to use pursuant to the
19			Individuals with Disabilities Education Act, 20 U.S.C. sec. 1400 et seq., the
20			Americans with Disabilities Act, 42 U.S.C. sec. 12101 et seq., or the
21			Rehabilitation Act of 1973, 29 U.S.C. sec. 701 et seq., or successor acts.

3	(3)	The Kentucky Department of Education shall make available to school districts and
4		schools upon request and without cost, state-of-the-art software products that enable
5		local districts and schools to prevent access to social media and sexually explicit
6		material. The department shall also notify all school districts and schools of the
7		availability of the software. Any product provided or obtained by a district or
8		school shall meet the requirements of subsection (2) of this section.
9	(4)	Each local school district shall establish a policy regarding student internet access
10		that shall include[,] but not be limited to[,] parental consent for student internet use,
11		teacher supervision of student computer use, and auditing procedures to determine
12		whether education technology is being used for the purpose of accessing social
13		<u>media or</u> sexually explicit or other objectionable material.
14	<u>(5)</u>	The provisions of subsections (1) to (4) of this section shall only apply to social
15		media that a student is not authorized by a teacher to access for an instructional
16		purpose.
