AN ACT relating to postsecondary education.

2 Be it enacted by the General Assembly of the Commonwealth of Kentucky:

→ Section 1. KRS 164.2951 is amended to read as follows:

- (1) [Beginning with the 2012-2013 academic year and each academic year thereafter
 JFor first-time students enrolling in a public college or university, postsecondary
 education institutions <u>shall</u>[are encouraged to] limit the credit-hour requirements to
 sixty (60) credit hours for each associate [of science or associate of arts]degree
 program and to one hundred twenty (120) credit hours for each bachelor [of arts or
 bachelor of science]degree program, except in situations in which:
- 10 (a) [Quality and content of a program would be negatively impacted; or
- (b)]A program must comply with specific program standards established by
 external accreditation bodies;

 (b) The program has submitted appropriate documentation from the external

 accreditation body to the council demonstrating the necessity of the

15 additional hours required for the specific program; and

- 16 (c) The council affirms the necessity of the additional hours required for the
 17 specific program.
- 18 (2) The council[<u>on Postsecondary Education</u>], in collaboration with the public
 19 universities and community and technical colleges, shall:
- 20 Facilitate the development and implementation of a statewide agreement for (a) 21 alignment of Kentucky Community and Technical College System lower-22 division associate of arts and associate of science coursework that shall be 23 accepted and fully credited to related bachelors degree programs by all public 24 universities. The agreement shall specify the general education learning 25 outcomes and program-specific prerequisite learning outcomes of the 26 coursework. Where applicable, curricula shall be reviewed to determine 27 comparability of core content standards required under KRS 164.302. The

1		agreement shall direct that the associate of arts and associate of science
2		coursework meeting the learning outcomes specified shall be accepted for
3		transfer and degree credit, whether earned as individual courses or within
4		block programs;
5	(b)	Develop, implement, and maintain a Kentucky Community and Technical
6		College System statewide course numbering system for lower-division
7		general education and program-specific prerequisite courses that include the
8		same learning outcomes;
9	(c)	By July 1, 2026, develop, implement, and maintain statewide transfer
10		pathways consisting of sixty (60) credit hours that shall be applied to the
11		requirements of high-demand baccalaureate degree programs at any
12		institution.
13		1. High-demand baccalaureate degree programs shall be defined by the
14		council based on student and workforce demands. Once a statewide
15		transfer pathway has been developed and implemented by the council,
16		<u>it shall be maintained, even if the council determines the pathway is</u>
17		no longer in a high-demand baccalaureate program. The council shall
18		publish on its website a list of the existing statewide transfer pathways
19		available to students.
20		2. Each statewide transfer pathway shall consist of sixty (60) credit hours
21		that shall be available for transfer and application to degree
22		requirements in the corresponding degree program at each institution.
23		Students may earn credit in statewide transfer pathways through any
24		means prescribed by the institution, including but not limited to credit
25		for prior learning and dual credit as defined by the council.
26	<u>(d)</u>	Establish a statewide course classification system and procedures to monitor
27		the transfer and crediting of lower-division coursework, including a system of

2	(\underline{e}) [(d)] Establish a procedure for approval of changes in learning outcomes at
3	public universities as described in subsection (3) of this section;
4	(f)[(e)] Standardize credit-by-exam equivalencies and common passing scores
5	for national exams transferable for general education courses and program-
6	specific prerequisites courses;
7	(\underline{g}) [(f)] Develop policies to align statewide articulation and transfer procedures
8	across educational institutions, including admissions criteria, student
9	declaration of major, and student guidance and counseling policies designed
10	to ensure that students pursuing an associate of arts or associate of science
11	degree program provide timely notification of their intention to transfer to a
12	public university;
13	$(\underline{h})[(\underline{g})]$ Develop uniform data collection and reporting methods to facilitate and
14	ensure statewide and institutional compliance with course transfer and credit
15	requirements;
16	(<i>i</i>)[(h)] Guarantee that, upon admission to a public university, graduates of an
17	associate of arts or an associate of science degree program approved by the
18	council in consultation with public universities shall be deemed to have met
19	all general education requirements;
20	(i) [(i)] Provide that graduates of approved associate of arts and associate of
21	science degree programs of Kentucky public postsecondary institutions who
22	complete the prerequisite learning outcomes for a bachelor of arts or bachelor
23	of science program while fulfilling the requirements for an associate of art or
24	associate of science degree, shall not be required to repeat or to take any
25	additional lower-level courses to fulfill bachelor degree requirements in the
26	same major, and these students shall be granted admission to related upper-
27	division bachelors degree programs of a state public college or university on

1		the same criteria as those students earning lower-division credits at the
2		university to which the student transferred;
3		(k)[(j)] Provide that graduates of approved associate of arts and associate of
4		science degree programs shall receive priority for admission to a state public
5		university over out-of-state students if they meet the same admission criteria;
6		$(\underline{l})_{[(k)]}$ Establish a commonality in college transcripts to be used in all public
7		colleges and universities to facilitate transfer from community and technical
8		colleges;
9		(\underline{m}) [(1)] Encourage private colleges and universities to collaborate with public
10		educational institutions in developing programs and agreement to expedite the
11		transfer of students and credits between institutions;
12		(\underline{n}) [(m)] Establish an appeals process to resolve disagreements between
13		transferring students and receiving educational institutions regarding the
14		transfer and acceptance of credits earned at another institution;
15		$(\underline{o})[(n)]$ Ensure that all articulation and transfer policies are consistent with the
16		rules and regulations established by all appropriate discipline-specific
17		accrediting bodies and institutional accrediting agencies as recognized by the
18		United States Department of Education; and
19		$(\underline{p})[(\mathbf{o})]$ Facilitate the development and implementation of a statewide
20		standardized articulation agreement to be executed [by July 1, 2021,]between
21		public colleges and universities and the Kentucky Department of Education
22		for each approved high school career pathway that leads to a postsecondary
23		credential, certification, license, or degree. Upon meeting the requirements of
24		the standardized articulation agreement, a student shall be awarded
25		postsecondary credit for prior learning at any public college or university.
26	(3)	When an institution seeks to change learning outcomes for a bachelor of arts or
27		bachelor of science program that affect lower-division courses, the university shall

1		notify the council [on Postsecondary Education and the Kentucky Community and
2		Technical College System] of the proposed changes at the same time as the
3		initiation of the university's approval process. If it is determined that the proposed
4		change will have an adverse effect on transferability, the university proposing the
5		change shall enter into discussion with the council, the other public universities,
6		and the Kentucky Community and Technical College System to verify there
7		remains a clearly defined path to transfer credits[a bachelor's degree] for those
8		students who plan to transfer from the Kentucky Community and Technical College
9		System or another public university to the public university.
10	<u>(4</u>)	Beginning July 1, 2026, any student who transfers among public postsecondary
11		institutions shall be awarded credit by the receiving institution for courses
