6		(a) "Automated speed enforcement device" means a photographic, radar, lidar,		
7		laser, or other device with one (1) or more vehicle sensors that transmits a		
8		vehicle's speed and an image of the rear license plate of a vehicle exceeding		
9		the speed limit; and		
10		(b) "Images" means images transmitted by an automated speed enforcement		
11		device showing the speed and rear license plate of a motor vehicle.		
12	<u>(2)</u>	In a highway work zone, a peace officer may issue a citation at the time of an		
13		offense based on images transmitted by an automated speed enforcement device		
14		<u>if:</u>		
15		(a) A motor vehicle is detected traveling in excess of ten (10) miles per hour		
16		over the posted speed limit;		
17		(b) At least one (1) bona fide worker is present in the highway work zone; and		
18		(c) There is a peace officer certified under KRS 15.380 to 15.404 present in or		
19		near the end of the highway work zone in a marked vehicle.		
20	<u>(3)</u>	The cabinet shall:		
21		(a) 1. Install signage in highway work zones notifying the public that vehicle		
22		speed within the work zone may be enforced by an automated speed		
23		enforcement device; and		
24		2. Require the signage to be affixed with lights that shall be flashing at		
25		all times when the automated speed enforcement device is active; and		
26		(b) Calibrate the automated speed enforcement device on an annual basis.		
27	<i>(4)</i>	An image transmitted by an automated speed enforcement device under this

2	<u>(5)</u>	The cabinet shall promulgate administrative regulations in accordance with KRS			
3		<u>Cha</u>	pter 13A relating to any matters necessary for the efficient administration of		
4		automated speed enforcement under this section.			
5		→ Section 2. KRS 189.2327 is amended to read as follows:			
6	(1)	Subject to the requirements of subsection (2) of this section, if a violation of KRS			
7		189.290 to 189.575, [or] 189.910 to 189.960, or Section 1 of this Act occurred in a			
8		highway work zone, the fine shall be:			
9		(a)	1. Five hundred dollars (\$500) if no person is physically injured or dies as		
10			a result of the violation. Notwithstanding the provisions of KRS		
11			189.999, the fine under this paragraph is prepayable; and		
12			2. A driver may attend a state traffic school or a county attorney-		
13			operated traffic safety program established pursuant to KRS 186.574		
14			for a violation of Section 1 of this Act; and		
15		(b)	Not less than five hundred dollars (\$500) nor more than ten thousand dollars
