6		(a)	"Boa	ard" means the Kentucky Infrastructure Authority board established in

8		(b)	"Eliş	gible funding recipient" means a public water or wastewater system that		
9			mee	ts $\underline{three (3)}$ {one (1)} or more of the criteria listed in subsection (7)(d)1. to		
10			<u>8. [9.</u>	for this section;		
11		(c)	"Eliş	gible project" means a project that would require capital or non-capital		
12			expe	enses including but not limited to expenses relating to:		
13			1.	Developing technical, operational, and maintenance resources and		
14				expertise;		
15			2.	Improving utility infrastructure planning, repair, maintenance,		
16				renovation, and management of plants and assets;

4		(d)	"Kentucky Water and Wastewater Assistance for Troubled or Economically
5			Restrained Systems Program" or "Kentucky WWATERS Program" means the
6			program established under this section and administered by the Kentucky
7			Infrastructure Authority under the direction of its board; and
8		(e)	"Public water or wastewater system" means any of the following that serve a
9			community:
10			1. A water district, water association, or joint water commission formed
11			under KRS Chapter 74;
12			2. A sewer district or sanitation district formed under KRS Chapter 67, 76,
13			or 220;
14			3. A municipal water utility and water works, sewer utility, sewage system
15			or works, or combined electric and water plant formed under KRS
16			Chapter 96; and
17			4. Any combination of two (2) or more of the entities listed in
18			subparagraphs 1. to 3. of this paragraph.
19	(2)	The	Kentucky WWATERS Program is hereby established under the authority to
20		prov	ide for an orderly process for eligible public water or wastewater systems to
21		appl	y for funds for eligible projects and for those applications to be evaluated,
22		scor	ed, and presented to the General Assembly for consideration for funding. The
23		adm	inistration of the program by the authority, under the direction of the board,
24		inclu	ndes but is not limited to the following:
25		(a)	Creating and making available standardized funding applications and regional
26			funding applications;
27		(b)	Verifying the eligibility of proposed funding recipients, including but not

1			limited to engaging in financial reviews of proposed funding recipients to
2			ensure that they will be able to repay the requested amounts;
3		(c)	Verifying that the proposed funding recipient seeks money for an eligible
4			project;
5		(d)	Awarding funding to selected eligible funding recipients, which shall be
6			accomplished within sixty (60) days of the effective date of legislation
7			enacted by the General Assembly that authorizes and appropriates the
8			funding;
9		(e)	Administering the funding and monitoring funding recipients for their success
10			in improving on any of the performance criteria described in subsection
11			(7)(d)1. to <u>8.[9.]</u> of this section;
12		(f)	Enforcing compliance with the requirements of this section for eligible
13			funding recipients; and
14		(g)	On or before October 1, 2025, and each quarter thereafter, submitting a report
15			on the status of all funding awarded and administered by the authority
16			pursuant to this section and KRS 224A.322 to the Legislative Research
17			Commission for referral to the Interim Joint Committee on Appropriations
18			and Revenue, or to the House and Senate Standing Committees on
19			Appropriations and Revenue when the General Assembly is in session.
20	(3)	(a)	To participate in the Kentucky WWATERS Program, a funding applicant
21			shall submit an application to the board, which shall include a corrective
22			action plan detailing how the requested funds would be used to address the
23			performance deficiencies that made the applicant eligible for the funding.
24		(b)	Funding applications may be shared with third-party independent consultants,
25			state agencies, or special purpose governmental entities in reviewing the
26			funding application as allowed under subsection (4) of this section. Once the
27			application process is complete and the funding application is ready for

1			review, it shall be made available to the public.
2		(c)	Funding applicants wishing to engage in a regional project shall submit a
3			single application.
4		<u>(d)</u>	A funding application for a capital construction project shall include cost
5			and timeline estimates prepared and signed with an attestation of veracity by
6			a licensed professional engineer for the project to be eligible for funding
7			under this section.
8		<u>(e)</u>	The board may evaluate and score funding applications for proposed
9			projects in phases as it deems appropriate.
10	(4)	The	board may contract or consult with a third-party independent consultant, state
11		ager	ncies, or special purpose governmental entities to assist with the funding

13	(5)	If a	funding applicant is selected as an eligible funding recipient approved under the

25			1. Accounting and financial planning, including with regard to asset
26			depreciation;
27			2. Rate setting;

3	(6)	(a)	A funding recipient shall forfeit all moneys received pursuant to this section
4			and KRS 224A.322 and all outstanding funding amounts, including accrued

7			1. Fails to comply with any of the requirements of this section;
8			2. Uses the awarded funding for any purpose other than the eligible project
9			for which the funding was awarded; or
10			3. Transfers or assigns the obligation to repay the funding amounts to any

17	(7)	In th	ne implementation of the Kentucky WWATERS Program, the board shall:
18		(a)	Hold at least monthly meetings, which may be in conjunction with regularly
19			scheduled board meetings, to discharge its duties under this section;
20		(b)	Determine whether a funding applicant is an eligible funding recipient and is
21			seeking funding for an eligible project;
22		(c)	Based on the criteria listed in paragraph (d) of this subsection, develop an
23			objective score card or rubric, which may be amended from time to time, to
24			aid in the analysis and scoring of funding applications;
25		(d)	Evaluate and score each funding applicant's project according to the extent to
26			which it meets the following criteria:
27			1. The median household income within the service area of the funding

1		applicant is less than the Commonwealth's median household income;
2	2.	User rates for the public drinking water or wastewater services provided
3		by the funding applicant are at or above one percent (1%) of annual
4		household income for its service area;
5	3.	The funding applicant has failed to produce a financial statement audit
6		in at least one (1) of the prior three (3) years;
7	4.	The funding applicant has negative income in any two (2) of the
8		previous five (5) years;
9	5.	The funding applicant's debt service coverage ratio, calculated by
10		dividing its annual net operating income by its annual debt payments,
1		was less than one and one-tenth (1.1) in any three (3) of the previous
12		five (5) years;
13	6.[The funding applicant's current accounts payable turnover ratio,
14		calculated by dividing its monthly net credit purchases from suppliers by
15		its average accounts payable balance for the month, is less than one (1);

5		seriously impairs its effectiveness;
6		9. The funding applicant has previously received funding through the
7		Kentucky WWATERS Program for a prior phase of the proposed
8		project that has been completed in accordance with the requirements
9		of the program and the funding applicant is seeking additional

19	(e)	Within sixty (60) days of a funding application being deemed complete under
20		subsection (3)(b) of this section, make determinations on the eligibility of the
21		proposed project and the applicant and issue a project score for the
22		application;
23	(f)	Provide detailed feedback to all funding applicants within fourteen (14) days
24		of the project score being completed; and
25	(g)	No later than December 1, 2024, and each December 1 thereafter, submit to
26		the Legislative Research Commission for referral to the Interim Joint
27		Committee on Appropriations and Revenue an annual report containing:

1	1.	The evaluations and scores of the proposed funding recipients for the
2		year to allow for the General Assembly to make the determinations for
3		funding the proposed funding recipients. For each proposed funding
4		recipient that meets the eligibility requirements for funding, the board
5		shall provide a proposal for the structure and the terms of the funding,

→ Section 2. Whereas it is critical to the proper administration of the Kentucky Water and Wastewater Assistance for Troubled or Economically Restrained Systems Program that changes to its eligibility criteria, application process, and funding requirements take effect for new funding applicants as soon as possible, an emergency is declared to exist, and this Act takes effect upon its passage and approval by the Governor or upon its otherwise becoming a law.
