- (h) "Public agency" has the same meaning as KRS 61.870, including a policymaking board, or any officer, employee, or entity of a public institution operating under KRS Chapter 164.
- 4 (2) No law enforcement agency, law enforcement officer, employee of a law
  5 enforcement agency, public agency, public official, employee of a public agency, or
  6 employee of a local government shall enforce, assist in the enforcement of, or
  7 otherwise cooperate in the enforcement of a federal ban on firearms, ammunition,
  8 or firearm accessories, and shall not participate in any federal enforcement action
  9 implementing a federal ban on firearms, ammunition, or firearm accessories.
