3 ➔Section 1. KRS 15.010 is amended to read as follows:

4 (1) The Attorney General is the head of the Department of Law.

5 (2) The Department of Law shall include the following major organizational units:

6 (a) Department of Criminal Investigations;

7 1. Office of Counter-Exploitation;

8 a. Special Victims Division;

9 b. Cyber Crimes Division; and

10 c. Trafficking and Abuse Prevention and Prosecution Division;

11 2. Office of Investigative Operations;

18 ➔Section 2. KRS 15.111 is amended to read as follows:

- 19 (1) The Office of Administrative Hearings is created **within the Department of Law** ~~[in~~
- 20 ~~the Office of Attorney General]~~.
- 21 (2) This office shall have the following responsibilities:
- 22 (a) Employing and maintaining a pool of hearing officers for assignment to the
- 23 individual agencies at their request, for the conduct of administrative hearings.
- 24 The Attorney General's office may also employ other staff as necessary to
- 25 carry out functions and responsibilities assigned by KRS Chapter 13B;
- 26 (b) Reviewing and approving or disapproving requests from agencies for waivers
- 27 from provisions of KRS Chapter 13B;

- 1 (c) Providing training in administrative hearing procedures for hearing officers as
 2 required in KRS 13B.030, either by developing and offering the training, or
 3 by contracting with appropriate organizations for the provision of training, or
 4 by approving training developed and submitted by the agencies;
- 5 (d) Consulting with the Personnel Cabinet and employing agencies in the
 6 establishment of relevant and appropriate qualifications for classes of hearing
 7 officers;
- 8 (e) ~~Establishing, in cooperation with the Office of Consumer Protection, a~~
 9 ~~clearinghouse for complaints concerning the administrative hearing process in~~
 10 ~~Kentucky. Each complaint received shall be referred to the agency that is the~~
 11 ~~subject of the complaint, and the action of the agency to resolve the complaint~~
 12 ~~shall be noted and reported to the office;~~
- 13 ~~(f)~~ Reporting to the Legislative Research Commission by July 1 of each odd-
 14 numbered year, the status of the administrative hearing process in Kentucky.
 15 The report shall include a compilation of statistical data and other information
 16 necessary to assess the effectiveness and efficiency of hearing procedures and
 17 recommendations for making improvements to the system. Agencies shall
 18 provide the information requested by the Office of Administrative Hearings
 19 necessary to complete the report;

 21 Inspector General, for review and investigation:
- 22 1. Any charge or case against any employee of the Cabinet for Health and
 23 Family Services where it has cause to believe the employee has engaged
 24 in dishonest, unethical, or illegal conduct or practices related to his or
 25 her job duties; or
 - 26 2. Any violation of state law or administrative regulation by any
 27 organization or individual regulated by, or contracted with, the Cabinet

3 relates to the Cabinet for Health and Family Services.

4 ➔Section 3. KRS 15.802 (Effective July 1, 2025) is amended to read as follows:

- 5 (1) The duties of the ~~{Office of the Attorney General, }~~**Department of** Child Support
6 **Services within the Department of Law**~~{Enforcement}~~, or its designee, shall
7 include:
- 8 (a) Serve as state agency authorized to administer Part D of Title IV of the Social
9 Security Act, 42 U.S.C. secs. 651 to 669;
 - 10 (b) Serve as the information agency as provided in the Uniform Interstate Family
11 Support Act, KRS Chapter 407;
 - 12 (c) Serve as collector of all court-ordered or administratively ordered child
13 support payments pursuant to Part D of Title IV of the Social Security Act;
 - 14 (d) Serve as the agent for enforcement of international child support obligations,
15 and respond to requests from foreign reciprocating countries;
 - 16 (e) Establish and enforce an obligation upon receipt of a completed, notarized
17 voluntary acknowledgment-of-paternity form;
 - 18 (f) Enforce Kentucky child support laws, including collection of court-ordered or
19 administratively ordered child support arrearages and prosecution of persons
20 who fail to pay child support;
 - 21 (g) Publicize the availability of services and encourage the use of these services
22 for establishing paternity and child support;
 - 23 (h) Pay the cost of genetic testing to establish paternity, subject to recoupment
24 from the alleged father, when paternity is administratively or judicially
25 determined; and obtain additional testing when an original test is contested,
26 upon request and advance payment by the contestant;
 - 27 (i) Establish child support obligations and seek modification of judicially or

- 1 administratively established child support obligations in accordance with the
2 child support guidelines of the Commonwealth of Kentucky as provided under
3 KRS 403.212;
- 4 (j) Administratively establish child support orders which shall have the same
5 force and effect of law;
- 6 (k) Issue an administrative subpoena to secure public and private records of
7 utility and cable companies and asset and liability information from financial
8 institutions for the establishment, modification, or enforcement of a child
9 support obligation;
- 10 (l) Impose a penalty for failure to comply with an administrative subpoena;
- 11 (m) Provide notices, copies of proceedings, and determinations of support
12 amounts to any parties or individuals who are applying for or receiving Title
13 IV-D services, or who are parties to cases in which Title IV-D services are
14 being provided; and
- 15 (n) Issue interstate administrative subpoenas to any individual or entity for
16 financial or other information or documents which are needed to establish,
17 modify, or enforce a child support obligation pursuant to Part D of Title IV of
18 the Social Security Act, 42 U.S.C. sec. 651 et seq. An administrative
19 subpoena lawfully issued in another state to an individual or entity residing in
20 this state shall be honored and enforced in the Circuit Court where the
21 individual or entity resides.
- 22 (2) The ~~{Office of the Attorney General, }~~Department of Child Support Services within
23 the Department of Law~~{Enforcement}~~, or its designee, may promulgate
24 administrative regulations to implement this section and adopt forms or implement
25 other requirements of federal law relating to interstate administrative subpoenas,
26 and may amend forms by technical amendment that are mandated by the federal
27 Office of Child Support Enforcement and incorporated by reference in

1 administrative regulation.

2 (3) The Office of the Attorney General shall maintain a system to receive and process
3 all child support payments. The system shall include existing computer systems to
4 record the payments. The automated system shall include a state case registry that
5 contains records with respect to each case in which services are being provided by
6 the office and each child support order established or modified in the state~~[on or~~
7 ~~after October 1, 1998]~~.

8 (4) The Office of the Attorney General shall establish and operate a state disbursement
9 unit for the collection, disbursement, and recording of payments under support
10 orders for all Title IV-D cases and for all cases initially issued in the state~~[on or~~
11 ~~after January 1, 1994,]~~ in which a wage withholding has been court-ordered or
12 administratively ordered, pursuant to Part D of Title IV of the Social Security Act.
13 Establishment of the state unit may include the designation and continuation of
14 existing local collection units to aid efficient and effective collection, disbursement,
15 and recording of child support payments.

16 (5) After the establishment of the disbursement unit child support collection system, the
17 Office of the Attorney General or its designee shall serve as collector of all court-
18 ordered or administratively ordered child support payments pursuant to Part D of
19 Title IV of the Social Security Act.

20 (6) Where establishment of paternity and enforcement and collection of child support is
21 by law the responsibility of local officials, the Office of the Attorney General shall
22 refer cases to the appropriate official for such action. The
23 office may enter into cooperative arrangements with appropriate courts and law
24 enforcement officials to assist the office in administering the program of child
25 support recovery, including the entering into of financial arrangements with such
26 courts and officials as provided for under the provisions of federal law and
27 regulations. The local county attorney shall be considered the designee of the office

1 for purposes of administering the program of child support recovery within a
2 county, subject to the option of the county attorney to decline such designation.
3 Nothing in this section shall prevent the Attorney General from taking such action,
4 with prior written notice, as appropriate if the terms and conditions of the
5 cooperative agreement are not met. When a cooperative agreement with a
6 contracting official is canceled for good cause, the office may not offer that
7 cooperative agreement to that official during the official's tenure.

8 (7) Where the local county attorney, friend of the court, domestic relations agent, or
9 other designee of the Office of the Attorney General has been contracted for the
10 purpose of administering child support enforcement pursuant to Title IV-D of the
11 Social Security Act, the contracting official shall be deemed to be representing the
12 office and as such does not have an attorney-client relationship with the applicant
13 who has requested services pursuant to Title IV-D of the Social Security Act nor
14 with any dependent on behalf of the individuals for whom services are sought.

15 (8) The Office of the Attorney General shall determine the name of each obligor who
16 owes an arrearage of at least two thousand five hundred dollars (\$2,500). After
17 notification to the obligor owing an arrearage amount of two thousand five hundred
18 dollars (\$2,500), the office shall transmit to the United States secretary of health
19 and human services the certified names of the individuals and supporting
20 documentation for the denial, revocation, or limitation of the obligor's passport. The
21 office shall notify the identified obligor of the determination and the consequences
22 and provide an opportunity to contest the determination.

23 (9) The Office of the Attorney General shall determine the name of an obligor owing
24 an arrearage and shall indefinitely deny, suspend, or revoke a license or certification
25 that has been issued if the person has a child support arrearage that equals or
26 exceeds the amount that would be owed after six (6) months of nonpayment or fails,
27 after receiving appropriate notice, to comply with subpoenas or warrants relating to

- 1 paternity or child support proceedings as provided by 42 U.S.C. sec. 666(a)(16).
- 2 (10) The Office of the Attorney General shall forward the name of the individual to a
3 board of licensure or board of certification for the notification of the denial,
4 revocation, or suspension of a driver's license, professional license or certification,
5 occupational license or certification, recreational license, or sporting license.
- 6 (11) The denial or suspension shall remain in effect until the child support arrearage has
7 been eliminated or payments on the child support arrearage are being made in
8 accordance with a court or administrative order, the person complies with the
9 subpoena or warrant relating to paternity or child support proceedings, or the appeal
10 of the denial or suspension is upheld and the license is reinstated.
- 11 (12) Except for cases administered by the Office of the Attorney General under 42
12 U.S.C. sec. 651 et seq. which shall be afforded the appeal process set forth by KRS
13 405.450(3), an individual who has a license or certification denied, revoked, or
14 suspended shall have the right to appeal to the licensing or certifying board.
- 15 (13) A dispute hearing shall be conducted by the Office of the Attorney General in
16 accordance with KRS 405.450. The only basis for a dispute hearing shall be a
17 mistake in fact.
- 18 (14) The Office of the Attorney General shall in its discretion enter into agreements with
19 financial institutions doing business in the Commonwealth to develop and operate,
20 in coordination with the financial institutions, a data match system as required by
21 KRS 15.844, 15.846, 15.848, and 15.850.
- 22 (15) The Office of the Attorney General may issue both intrastate and interstate
23 administrative subpoenas to any individual or entity for financial or other
24 information or documents that are needed to establish, modify, or enforce a child
25 support obligation pursuant to Title IV-D of the Social Security Act, 42 U.S.C. sec.
26 651 et seq. An administrative subpoena lawfully issued in another state to an
27 individual or entity in this state shall be honored and enforced in the Circuit Court

1 of the county in which the individual or entity resides.

2 (16) The Office of the Attorney General shall promulgate administrative regulations in
3 accordance with KRS Chapter 13A to implement KRS 15.055.

4 (17) The Office of the Attorney General shall compare a quarterly report provided by the
5 Finance and Administration Cabinet of all tort claims made against the state by
6 individuals with the child support database to match individuals who have a child
7 support arrearage and may receive a settlement from the state.

8 (18) The Office of the Attorney General shall prepare and distribute to the office's
9 designee for the administration of the child support program information on child
10 support collections and enforcement. The information shall include a description of
11 how child support obligations are:

12 (a) Established;

13 (b) Modified;

14 (c) Enforced;

15 (d) Collected; and

16 (e) Distributed.

17 (19) The Office of the Attorney General's designee for the administration of the child
18 support program shall distribute, when appropriate, the following:

19 (a) Information on child support collections and enforcement; and

20 (b) Job listings posted by employment services.

21 ➔Section 4. KRS 44.030 is amended to read as follows:

22 (1) No money shall be paid to any person on a claim against the state in his or her own
23 right, or as an assignee of another, when the person or the person's assignor is
24 indebted to the state or any local government. The claim, to the extent it is allowed,
25 shall first be credited to the account of the person indebted to the state, and if there
26 is any balance due the person after settling the whole demand of the state, any
27 certified liquidated debts of any local government shall be paid if the local

1 government provides information concerning the liquidated debt to the State
2 Treasurer. If there is any balance due the person after settling the whole demand of
3 the state or local governments, and if there are not liquidated debts certified against
4 the claim pursuant to KRS 44.065, that balance shall be paid to the person.

5 (2) In case of multiple claims by state agencies, the claims shall be paid as follows:

6 (a) First, to any claim made by the Office of the Attorney General~~[Cabinet for~~
7 ~~Health and Family Services]~~ for past due child support obligations;

8 (b) Second, to any claim filed by the Finance and Administration Cabinet,
9 Department of Revenue, for taxes owed the Commonwealth; and

10 (c) Third, to all other state agencies in the order that the claims were filed with
11 the State Treasury.

12 (3) In the case of multiple claims filed by any local government, the claims shall be
13 paid in the order that the claims were filed with the State Treasury.

14 (4) No money shall be paid to any person on a claim against a local government in his
15 or her own right, or as an assignee of another, when the person or the person's
16 assignor is indebted to the local government or the state. The claim, to the extent it
17 is allowed, shall first be credited to any debt of the person indebted to the local
18 government, and if there is any balance due the person after settling the whole
19 demand of the local government, any certified liquidated debts of the state shall be
20 paid if the state provides the local government with information concerning the
21 liquidated debt. If there is any balance due the person after settling the whole
22 demand of the local government or the state, that balance shall be paid to the
23 person.

24 (5) The Finance and Administration Cabinet shall provide the Office of the Attorney
25 General~~[Cabinet for Health and Family Services]~~ with a quarterly report of all tort
26 claims made against the state by individuals that the Office of the Attorney
27 General~~[Cabinet for Health and Family Services]~~ shall compare with the child

1 support database to match individuals who have a child support arrearage and may
2 receive a settlement from the state.

3 (6) Each organizational unit and administrative body in the executive branch of state
4 government, as defined in KRS 12.010, the Court of Justice in the judicial branch of
5 state government, and, where feasible, any local government shall provide
6 information to the State Treasurer concerning any debt it has referred to the
7 Department of Revenue for collection under KRS 45.241.

8 (7) Each agency, the Court of Justice, and, where feasible, any local government shall
9 provide information to the State Treasurer concerning any debt referred to the
10 Department of Revenue for collection under KRS 45.237.

11 ➔Section 5. KRS 154A.060 is amended to read as follows:

12 (1) The corporation shall conduct and administer lottery games which will result in
13 maximization of revenues to the Commonwealth of Kentucky while at the same
14 time provide entertainment to its citizens. It shall be the duty of the corporation, its
15 employees, and the members of the board to provide for the effective operation of
16 lottery games which insure the integrity of the lottery and maintain the dignity of
17 the Commonwealth and the general welfare of its citizens. The corporation, in
18 pursuit of the attainment of the objectives and the purposes of this chapter, may:

19 (a) Sue and be sued in its corporate name;

20 (b) Adopt a corporate seal and a symbol;

21 (c) Hold copyrights, trademarks, and service marks, and enforce its rights with
22 respect thereto;

23 (d) Appoint agents upon which process may be served;

24 (e) Enter into written agreements with one (1) or more other states for the
25 operation, marketing, and promotion of a joint lottery or joint lottery games;

26 (f) Acquire real property and make improvements thereon. These acquisitions
27 shall be reported to the Capital Projects and Bond Oversight Committee for its

- 1 review and determination in accordance with KRS 45.750 to 45.810; and
- 2 (g) Make, execute, and effectuate any and all agreements or contracts including:
- 3 1. Contracts for the purchase of such goods and services as are necessary
- 4 for the operation and promotion of the state lottery. Proposed purchases
- 5 of major items of equipment estimated to cost one hundred thousand
- 6 dollars (\$100,000) or more and proposed purchases of items of
- 7 equipment where the estimated contract price for all the items of
- 8 equipment taken together is four hundred thousand dollars (\$400,000) or
- 9 more shall be reported to the Capital Projects and Bond Oversight
- 10 Committee for its review and determination in accordance with the
- 11 provisions of KRS 45.750 to 45.810. A contract shall not be artificially
- 12 divided to cause an estimated contract price to fall below the four
- 13 hundred thousand dollar (\$400,000) threshold. Contracts for personal
- 14 service shall be reviewed in accordance with KRS 45A.690 to 45A.725.
- 15 2. Contracts to incur debt in its own name and enter into financing
- 16 agreements with the Commonwealth, its own agencies, or with a
- 17 commercial bank, excluding the authority to issue bonds.
- 18 (2) The corporation shall:
- 19 (a) Supervise and administer the lottery in accordance with the provisions of this
- 20 chapter and the administrative regulations adopted by the board;
- 21 (b) Submit monthly and annual reports to the Governor, the President of the
- 22 Senate, and the Speaker of the House of Representatives containing financial
- 23 statements which include but are not limited to disclosure of gross revenues,
- 24 expenses, and net proceeds for the period;
- 25 (c) Adopt by administrative regulation a system of continuous internal audits;
- 26 (d) Maintain weekly or more frequent records of lottery transactions, including
- 27 distribution of tickets to lottery retailers, revenues received, claims for prizes,

- 1 prizes paid, and all other financial transactions of the corporation;
- 2 (e) Adopt by administrative regulation a code of ethics for officers and
3 employees of the corporation to carry out the standards of conduct established
4 by the provisions of this chapter;
- 5 (f) Include capital projects, as defined in KRS 45.750(1)(f), which exceed the
6 thresholds set forth in KRS 154A.060(1)(g)1. in the budget unit request
7 submitted by the corporation to the Finance and Administration Cabinet
8 pursuant to KRS 48.050. In the budget unit request submitted by the
9 corporation, a contingency item for acquisition of the on-line central system,
10 all related equipment, and any other equipment owned by vendors of the
11 corporation relating to computer-generated lottery games from the
12 corporation's vendors shall be stated separately from all other equipment.
13 Further, if the identification of specific projects requiring the acquisition of
14 equipment in the nature of computer systems, communications equipment and
15 related peripheral devices, and operating system software cannot be
16 ascertained with absolute certainty at the time the corporation is required to
17 submit its budget unit request, the corporation shall be entitled to submit a
18 general request for the equipment without individually identifying specific
19 projects, together with a maximum amount to be allocated for the equipment,
20 in the budget unit request;
- 21 (g) The Kentucky Lottery Corporation and the Office of the Attorney
22 General~~[Cabinet for Health and Family Services]~~ shall develop a system to
23 allow the Kentucky Lottery Corporation to receive a list of delinquent child
24 support obligors from the Office of the Attorney General~~[Cabinet for Health~~
25 ~~and Family Services]~~ on a monthly basis. The Kentucky Lottery Corporation
26 shall withhold delinquent amounts from prizes of winners that appear on the
27 list. This system shall be timely and shall not create an unavoidable delay in

1 the payment of a lottery prize; and

2 (h) The Kentucky Lottery Corporation and the authority shall develop a system to
3 allow the Kentucky Lottery Corporation to receive on a periodic basis a list of
4 persons declared in default of repayment obligations under financial
5 assistance programs in KRS Chapters 164 and 164A. The Kentucky Lottery
6 Corporation shall withhold from a person's prize winnings the amount of the
7 defaulted loan and shall transfer the amount to the authority to credit the
8 account of the person in default. Any amount remaining after the deduction of
9 the loan amount shall be paid to the person.

10 ➔Section 6. KRS 186.570 is amended to read as follows:

11 (1) The cabinet or its agent designated in writing for that purpose may deny any person
12 an operator's license or may suspend the operator's license of any person, or, in the
13 case of a nonresident, withdraw the privilege of operating a motor vehicle in this
14 state, subject to a hearing and with or without receiving a record of conviction of
15 that person of a crime, if the cabinet has reason to believe that:

16 (a) That person has committed any offenses for the conviction of which
17 mandatory revocation of a license is provided by KRS 186.560;[]

18 (b) That person has, by reckless or unlawful operation of a motor vehicle, caused,
19 or contributed to an accident resulting in death or injury or serious property
20 damage;[]

21 (c) That person has a mental or physical disability that makes it unsafe for him to
22 drive upon the highways. The Transportation Cabinet shall, by administrative
23 regulations promulgated pursuant to KRS Chapter 13A, establish a medical
24 review board to provide technical assistance in the review of the driving
25 ability of these persons. The board shall consist of licensed medical and
26 rehabilitation specialists;[]

27 (d) That person is an habitually reckless or negligent driver of a motor vehicle or

- 1 has committed a serious violation of the motor vehicle laws;~~[-]~~
- 2 (e) That person has been issued a license without making proper application for
3 it, as provided in KRS 186.412 or 186.4121 and administrative regulations
4 promulgated pursuant to KRS Chapter 13A;~~[-]~~
- 5 (f) That person has presented false or misleading information as to the person's
6 residency, citizenship, religious convictions, or immigration status;~~[-]~~
- 7 (g) A person required by KRS 186.480 to take an examination has been issued a
8 license without first having passed the examination;~~[-]~~
- 9 (h) That person has been convicted of assault and battery resulting from the
10 operation of a motor vehicle;~~[-]~~
- 11 (i) That person has failed to appear pursuant to a citation or summons issued by a
12 law enforcement officer of this Commonwealth or any other jurisdiction;~~[-]~~
- 13 (j) That person has failed to appear pursuant to an order by the court to produce
14 proof of security required by KRS 304.39-010 and a receipt showing that a
15 premium for a minimum policy period of six (6) months has been paid;~~or~~~~[-]~~
- 16 (k) That person is a habitual violator of KRS 304.39-080. For purposes of this
17 section, a "habitual violator" shall mean any person who has operated a motor
18 vehicle without security on the motor vehicle as required by Subtitle 39 of this
19 chapter three (3) or more times within a five (5) year period, in violation of
20 KRS 304.99-060(2).
- 21 (2) The cabinet shall deny any person a license or shall suspend the license of an
22 operator of a motor vehicle upon receiving written notification from the ***Office of***
23 ***the Attorney General***~~Cabinet for Health and Family Services~~ that the person has a
24 child support arrearage which equals or exceeds the cumulative amount which
25 would be owed after six (6) months of nonpayment or failure, after receiving
26 appropriate notice, to comply with a subpoena or warrant relating to paternity or
27 child support proceedings, as provided by 42 U.S.C. ~~sec.~~~~secs.~~ 651 et seq.~~[-]~~~~except~~

1 ~~that any child support arrearage which exists prior to January 1, 1994, shall not be~~
2 ~~included in the calculation to determine whether the license of an operator of a~~
3 ~~motor vehicle shall be denied or suspended.]~~ The denial or suspension shall
4 continue until the arrearage has been eliminated, payments on the child support
5 arrearage are being made in accordance with a court or administrative order, or the
6 person complies with the subpoena or warrant relating to paternity or child support.
7 Before the license may be reinstated, proof of elimination of the child support
8 arrearage or proof of compliance with the subpoena or warrant relating to paternity
9 or child support proceedings as provided by 42 U.S.C. sec. 666(a)(16) from the
10 court where the action is pending or the Office of the Attorney General~~[Cabinet for~~
11 ~~Health and Family Services]~~ shall be received by the Transportation Cabinet as
12 prescribed by administrative regulations promulgated by the Office of the Attorney
13 General~~[Cabinet for Health and Family Services]~~ and the Transportation Cabinet.

14 (3) The cabinet or its agent designated in writing for that purpose shall deny any person
15 an operator's license or shall suspend the operator's license of any person, or, in the
16 case of a nonresident, withdraw the privilege of operating a motor vehicle in this
17 state:

18 (a) Where the person has been declared ineligible to operate a motor vehicle
19 under KRS 532.356 for the duration of the ineligibility, upon notification of
20 the court's judgment; or

21 (b) Upon receiving written notification from the Finance and Administration
22 Cabinet, Department of Revenue, that the person is a delinquent taxpayer as
23 provided in KRS 131.1817. The denial or suspension shall continue until a
24 written tax clearance has been received by the cabinet from the Finance and
25 Administration Cabinet, Department of Revenue. Notwithstanding the
26 provisions of subsection (4) of this section, a person whose license is denied
27 or suspended under this paragraph shall have thirty (30) days from the date

1 the cabinet mails the notice to request a hearing.

2 (4) The cabinet or its agent designated in writing for that purpose shall provide any
3 person subject to the suspension, revocation, or withdrawal of their driving
4 privileges, under provisions of this section, an informal hearing. Upon determining
5 that the action is warranted, the cabinet shall notify the person in writing by mailing
6 the notice to the person by first-class mail to the last known address of the person.
7 The hearing shall be automatically waived if not requested within twenty (20) days
8 after the cabinet mails the notice. The hearing shall be scheduled as early as
9 practical within twenty (20) days after receipt of the request at a time and place
10 designated by the cabinet. An aggrieved party may appeal a decision rendered as a
11 result of an informal hearing, and upon appeal an administrative hearing shall be
12 conducted in accordance with KRS Chapter 13B.

13 (5) (a) The cabinet may suspend the operator's license of any resident upon receiving
14 notice of the conviction of that person in another state of an offense there
15 which, if committed in this state, would be grounds for the suspension or
16 revocation of an operator's license. The cabinet shall not suspend an operator's
17 license under this paragraph if:

- 18 1. The conviction causing the suspension or revocation is more than five
19 (5) years old;
- 20 2. The conviction is for a traffic offense other than a felony traffic offense
21 or a habitual violator offense; and
- 22 3. The license holder complies with the provisions of KRS 186.442.

23 (b) If, at the time of application for an initial Kentucky operator's license, a
24 person's license is suspended or revoked in another state for a conviction that

1 (c) The cabinet may, upon receiving a record of the conviction in this state of a
2 nonresident driver of a motor vehicle of any offense under the motor vehicle
3 laws, forward a notice of that person's conviction to the proper officer in the
4 state of which the convicted person is a resident.

5 (d) This subsection shall not apply to a commercial driver's license.

6 (6) The Transportation Cabinet is forbidden from suspending or revoking an operator's
7 license or assessing points or any other form of penalty against the license holder
8 for speeding violations or speeding convictions from other states. This subsection
9 shall apply only to speeding violations. This section shall not apply to a person who
10 holds or is required to hold a commercial driver's license.

11 (7) Each operator's license which has been canceled, suspended, or revoked shall be
12 surrendered to and destroyed by the cabinet. At the end of the period of
13 cancellation, suspension, or revocation, the license holder may reapply under KRS
14 186.412 or 186.4121, after the licensee has complied with all requirements for the
15 issuance or reinstatement of his or her driving privilege.

16 (8) Insurance companies issuing motor vehicle policies in the Commonwealth shall be
17 prohibited from raising a policyholder's rates solely because the policyholder's
18 driving privilege has been suspended or denied pursuant to subsection (2) of this
19 section.

20 ➔Section 7. KRS 237.110 is amended to read as follows:

21 (1) The Department of Kentucky State Police is authorized to issue and renew licenses
22 to carry concealed firearms or other deadly weapons, or a combination thereof, to
23 persons qualified as provided in this section.

24 (2) An original or renewal license issued pursuant to this section shall:

25 (a) Be valid throughout the Commonwealth and, except as provided in this
26 section or other specific section of the Kentucky Revised Statutes or federal
27 law, permit the holder of the license to carry firearms, ammunition, or other

- 1 deadly weapons, or a combination thereof, at any location in the
2 Commonwealth;
- 3 (b) Unless revoked or suspended as provided by law, be valid for a period of five
4 (5) years from the date of issuance;
- 5 (c) Authorize the holder of the license to carry a concealed firearm or other
6 deadly weapon, or a combination thereof, on or about his or her person; and
- 7 (d) Authorize the holder of the license to carry ammunition for a firearm on or
8 about his or her person.
- 9 (3) Prior to the issuance of an original or renewal license to carry a concealed deadly
10 weapon, the Department of Kentucky State Police, upon receipt of a completed
11 application, applicable fees, and any documentation required by this section or
12 administrative regulation promulgated by the Department of Kentucky State Police,
13 shall conduct a background check to ascertain whether the applicant is eligible
14 under 18 U.S.C. sec. 922(g) and (n), any other applicable federal law, and state law
15 to purchase, receive, or possess a firearm or ammunition, or both. The background
16 check shall include:
- 17 (a) A state records check covering the items specified in this subsection, together
18 with any other requirements of this section;
- 19 (b) A federal records check, which shall include a National Instant Criminal
20 Background Check System (NICS) check;
- 21 (c) A federal Immigration Alien Query if the person is an alien who has been
22 lawfully admitted to the United States by the United States government or an
23 agency thereof; and
- 24 (d) In addition to the Immigration Alien Query, if the applicant has not been

26 Department of Kentucky State Police shall, if a doubt exists relating to an
27 alien's eligibility to purchase a firearm, consult with the United States

16 3. Is lawfully admitted to the United States by the United States
17 government or an agency thereof, is permitted by federal law to
18 purchase a firearm, and is a resident of this Commonwealth; or

21 purchase a firearm, is, at the time of the application, assigned to a
22 military posting in Kentucky, and has been assigned to a posting in the
23 Commonwealth;

24 (c) Is twenty-one (21) years of age or older;

25 (d) Has not been committed to a state or federal facility for the abuse of a
26 controlled substance or been convicted of a misdemeanor violation of KRS
27 Chapter 218A or similar laws of any other state relating to controlled

- 1 substances, within a three (3) year period immediately preceding the date on
2 which the application is submitted;
- 3 (e) Does not chronically and habitually use alcoholic beverages as evidenced by
4 the applicant having two (2) or more convictions for violating KRS 189A.010
5 within the three (3) years immediately preceding the date on which the
6 application is submitted, or having been committed as an alcoholic pursuant to
7 KRS Chapter 222 or similar laws of another state within the three (3) year
8 period immediately preceding the date on which the application is submitted;
- 9 (f) Does not owe a child support arrearage which equals or exceeds the
10 cumulative amount which would be owed after one (1) year of nonpayment, if
11 the Department of Kentucky State Police has been notified of the arrearage by
12 the Office of the Attorney General~~[Cabinet for Health and Family Services]~~;
- 13 (g) Has complied with any subpoena or warrant relating to child support or
14 paternity proceedings. If the Department of Kentucky State Police has not
15 been notified by the Office of the Attorney General~~[Cabinet for Health and
16 Family Services]~~ that the applicant has failed to meet this requirement, the
17 Department of Kentucky State Police shall assume that paternity and child
18 support proceedings are not an issue;
- 19 (h) Has not been convicted of a violation of KRS 508.030 or 508.080 within the
20 three (3) years immediately preceding the date on which the application is
21 submitted. The commissioner of the Department of Kentucky State Police
22 may waive this requirement upon good cause shown and a determination that
23 the applicant is not a danger and that a waiver would not violate federal law;
- 24 (i) Demonstrates competence with a firearm by successful completion of a
25 firearms safety or training course that is conducted by a firearms instructor

27 (5) (a) A legible photocopy or electronic copy of a certificate of completion issued

1 by a firearms instructor certified by a national organization or the Department
2 of Criminal Justice Training shall constitute evidence of qualification under
3 subsection (4)(i) of this section.

4 (b) Persons qualifying under subsection (6)(d) of this section may submit with
5 their application:

6 1. At least one (1) of the following paper or electronic forms or their
7 successor forms showing evidence of handgun training or handgun
8 qualifications:

- 9 a. Department of Defense Form DD 2586;
 - 10 b. Department of Defense Form DD 214;
 - 11 c. Coast Guard Form CG 3029;
 - 12 d. Department of the Army Form DA 88-R;
 - 13 e. Department of the Army Form DA 5704-R;
 - 14 f. Department of the Navy Form OPNAV 3591-1; or
 - 15 g. Department of the Air Force Form AF 522; or
- 16 2. a. Documentary evidence of an honorable discharge; and
17 b. A notarized affidavit on a form provided by the Department of
18 Kentucky State Police, signed under penalty of perjury, stating the
19 person has met the training requirements of subsection (6)(d) of
20 this section.

21 (6) (a) Peace officers who are currently certified as peace officers by the Kentucky
22 Law Enforcement Council pursuant to KRS 15.380 to 15.404 and peace
23 officers who are retired and are members of the Kentucky Employees
24 Retirement System, State Police Retirement System, or County Employees
25 Retirement System or other retirement system operated by or for a city,
26 county, or urban-county in Kentucky shall be deemed to have met the training
27 requirement.

- 1 (b) Current and retired peace officers of the following federal agencies shall be
2 deemed to have met the training requirement:
- 3 1. Any peace officer employed by a federal agency specified in KRS
4 61.365;
 - 5 2. Any peace officer employed by a federal civilian law enforcement
6 agency not specified above who has successfully completed the basic
7 law enforcement training course required by that agency;
 - 8 3. Any military peace officer of the United States Army, Navy, Marine
9 Corps, or Air Force, or a reserve component thereof, or of the Army
10 National Guard or Air National Guard who has successfully completed
11 the military law enforcement training course required by that branch of
12 the military;
 - 13 4. Any member of the United States Coast Guard serving in a peace officer
14 role who has successfully completed the law enforcement training
15 course specified by the United States Coast Guard.
- 16 (c) Corrections officers who are currently employed by a consolidated local

18 who have successfully completed a basic firearms training course required for

3 1. Successfully completed handgun training which was conducted by the
4 United States Army, Navy, Marine Corps, Air Force, or Coast Guard, or
5 a reserve component thereof, or of the Army National Guard or Air

7 2. Successfully completed handgun qualification within the United States
8 Army, Navy, Marine Corps, Air Force, or Coast Guard, or a reserve
9 component thereof, or of the Army Guard or Air Force National Guard.

10 (7) (a) 1. A paper application for a license, or renewal of a license, to carry a
11 concealed deadly weapon shall be obtained from and submitted to the
12 office of the sheriff in the county in which the person resides.

13 2. An applicant, in lieu of a paper application, may submit an electronic
14 application for a license, or renewal of a license, to carry a concealed
15 deadly weapon to the Department of Kentucky State Police.

16 3. Persons qualifying under subsection (6)(d) of this section shall be
17 supplied the information in subsection (4)(i)4. of this section upon
18 obtaining an application.

19 (b) 1. The completed paper application and any documentation required by
20 this section plus an application fee or renewal fee, as appropriate, of
21 sixty dollars (\$60) shall be presented to the office of the sheriff of the

24 material to the Department of Kentucky State Police within five (5)

12 thirty dollars (\$30) of the electronic application fee shall be retained by

- 1 from paying the paper or electronic application or renewal fees.
- 2 (e) The application, whether paper or electronic, shall be completed, under oath,

- 1 6. A conspicuous warning that the application is executed under oath and
2 that a materially false answer to any question, or the submission of any
3 materially false document by the applicant, subjects the applicant to

- 5 (8) The applicant shall submit to the sheriff of the applicant's county of residence or
6 county of military posting if submitting a paper application, or to the Department of
7 Kentucky State Police if submitting an electronic application:
- 8 (a) A completed application as described in subsection (7) of this section;
9 (b) A recent color photograph of the applicant, as prescribed by administrative
10 regulation;
11 (c) A paper or electronic certificate or an affidavit or document as described in
12 subsection (5) of this section;
13 (d) A paper or electronic document establishing the training exemption as
14 described in subsection (6) of this section; and
15 (e) For an applicant who is not a citizen of the United States and has been
16 lawfully admitted to the United States by the United States government or an
17 agency thereof, an affidavit as prescribed by administrative regulation
18 concerning his or her immigration status and his or her United States
19 government issued:
- 20 1. Permanent Resident Card I-551 or its equivalent successor
21 identification;
22 2. Other United States government issued evidence of lawful admission to
23 the United States which includes the category of admission, if admission
24 has not been granted as a permanent resident; and
25 3. Evidence of compliance with the provisions of 18 U.S.C. sec. 922(g)(5),
26 18 U.S.C. sec. 922(d)(5), or 18 U.S.C. sec. 922(y)(2), and 27 C.F.R. Part
27 178, including, as appropriate, but not limited to evidence of ninety (90)

1 day residence in the Commonwealth, a valid current Kentucky hunting
2 license if claiming exemption as a hunter, or other evidence of eligibility
3 to purchase a firearm by an alien which is required by federal law or
4 regulation.

5 If an applicant presents identification specified in this paragraph, the sheriff
6 shall examine the identification, may record information from the
7 identification presented, and shall return the identification to the applicant.

8 (9) The Department of Kentucky State Police shall, within sixty (60) days after the date
9 of receipt of the items listed in subsection (8) of this section if the applicant
10 submitted a paper application, or within fifteen (15) business days after the date of
11 receipt of the items listed in subsection (8) of this section if the applicant applied
12 electronically, either:

13 (a) Issue the license; or

14 (b) Deny the application based solely on the grounds that the applicant fails to
15 qualify under the criteria listed in subsection (3) or (4) of this section. If the
16 Department of Kentucky State Police denies the application, it shall notify the
17 applicant in writing, stating the grounds for denial and informing the applicant
18 of a right to submit, within thirty (30) days, any additional documentation
19 relating to the grounds of denial. Upon receiving any additional
20 documentation, the Department of Kentucky State Police shall reconsider its
21 decision and inform the applicant within twenty (20) days of the result of the
22 reconsideration. The applicant shall further be informed of the right to seek de
23 novo review of the denial in the District Court of his or her place of residence
24 within ninety (90) days from the date of the letter advising the applicant of the
25 denial.

26 (10) The Department of Kentucky State Police shall maintain an automated listing of
27 license holders and pertinent information, and this information shall be available

1 upon request, at all times to all Kentucky, federal, and other states' law enforcement
2 agencies. A request for the entire list of licensees, or for all licensees in a
3 geographic area, shall be denied. Only requests relating to a named licensee shall be
4 honored or available to law enforcement agencies. Information on applications for
5 licenses, names and addresses, or other identifying information relating to license
6 holders shall be confidential and shall not be made available except to law
7 enforcement agencies. No request for lists of local or statewide permit holders shall
8 be made to any state or local law enforcement agency, peace officer, or other
9 agency of government other than the Department of Kentucky State Police, and no
10 state or local law enforcement agency, peace officer, or agency of government,
11 other than the Department of Kentucky State Police, shall provide any information
12 to any requester not entitled to it by law.

13 (11) Within thirty (30) days after the changing of a permanent address, or within thirty
14 (30) days after the loss, theft, or destruction of a license, the licensee shall notify the
15 Department of Kentucky State Police of the loss, theft, or destruction. Failure to
16 notify the Department of Kentucky State Police shall constitute a noncriminal
17 violation with a penalty of twenty-five dollars (\$25) payable to the clerk of the
18 District Court. No court costs shall be assessed for a violation of this subsection.
19 When a licensee makes application to change his or her residence address or other
20 information on the license, neither the sheriff nor the Department of Kentucky State
21 Police shall require a surrender of the license until a new license is in the office of
22 the applicable sheriff and available for issuance. Upon the issuance of a new
23 license, the old license shall be destroyed by the sheriff.

24 (12) If a license is lost, stolen, or destroyed, the license shall be automatically invalid,
25 and the person to whom the same was issued may, upon payment of fifteen dollars
26 (\$15) for a paper request, or twenty-five dollars (\$25) for an electronic request
27 submitted in lieu of a paper request, to the Department of Kentucky State Police,

1 obtain a duplicate, upon furnishing a notarized statement to the Department of
2 Kentucky State Police that the license has been lost, stolen, or destroyed.

3 (13) (a) The commissioner of the Department of Kentucky State Police, or his or her
4 designee in writing, shall revoke the license of any person who becomes
5 permanently ineligible to be issued a license or have a license renewed under
6 the criteria set forth in this section.

7 (b) The commissioner of the Department of Kentucky State Police, or his or her
8 designee in writing, shall suspend the license of any person who becomes
9 temporarily ineligible to be issued a license or have a license renewed under
10 the criteria set forth in this section. The license shall remain suspended until
11 the person is again eligible for the issuance or renewal of a license.

12 (c) Upon the suspension or revocation of a license, the commissioner of the
13 Department of Kentucky State Police, or his or her designee in writing, shall:

14 1. Order any peace officer to seize the license from the person whose
15 license was suspended or revoked; or

16 2. Direct the person whose license was suspended or revoked to surrender
17 the license to the sheriff of the person's county of residence within two
18 (2) business days of the receipt of the notice.

19 (d) If the person whose license was suspended or revoked desires a hearing on the
20 matter, the person shall surrender the license as provided in paragraph (c)2. of
21 this subsection and petition the commissioner of the Department of Kentucky
22 State Police to hold a hearing on the issue of suspension or revocation of the
23 license.

24 (e) Upon receipt of the petition, the commissioner of the Department of Kentucky
25 State Police shall cause a hearing to be held in accordance with KRS Chapter
26 13B on the suspension or revocation of the license. If the license has not been
27 surrendered, no hearing shall be scheduled or held.

- 1 (f) If the hearing officer determines that the licensee's license was wrongly
2 suspended or revoked, the hearing officer shall order the commissioner of the
3 Department of Kentucky State Police to return the license and abrogate the
4 suspension or revocation of the license.
- 5 (g) Any party may appeal a decision pursuant to this subsection to the District
6 Court in the licensee's county of residence in the same manner as for the
7 denial of a license.
- 8 (h) If the license is not surrendered as ordered, the commissioner of the
9 Department of Kentucky State Police shall order a peace officer to seize the
10 license and deliver it to the commissioner.
- 11 (i) Failure to surrender a suspended or revoked license as ordered is a Class A
12 misdemeanor.
- 13 (j) The provisions of this subsection relating to surrender of a license shall not
14 apply if a court of competent jurisdiction has enjoined its surrender.
- 15 (k) When a domestic violence order or emergency protective order is issued
16 pursuant to the provisions of KRS Chapter 403 against a person holding a
17 license issued under this section, the holder of the permit shall surrender the
18 license to the court or to the officer serving the order. The officer to whom the
19 license is surrendered shall forthwith transmit the license to the court issuing
20 the order. The license shall be suspended until the order is terminated, or until
21 the judge who issued the order terminates the suspension prior to the
22 termination of the underlying domestic violence order or emergency
23 protective order, in writing and by return of the license, upon proper motion
24 by the license holder. Subject to the same conditions as above, a peace officer
25 against whom an emergency protective order or domestic violence order has
26 been issued shall not be permitted to carry a concealed deadly weapon when
27 not on duty, the provisions of KRS 527.020 to the contrary notwithstanding.

- 1 (14) (a) Not less than one hundred twenty (120) days prior to the expiration date of the
2 license, the Department of Kentucky State Police shall mail to each licensee a
3 written notice of the expiration and a renewal form prescribed by the
4 Department of Kentucky State Police. The outside of the envelope containing
5 the license renewal notice shall bear only the name and address of the
6 applicant. No other information relating to the applicant shall appear on the
7 outside of the envelope sent to the applicant. The licensee may renew his or
8 her license on or before the expiration date by filing with the sheriff of his or
9 her county of residence the paper renewal form, or by filing with the
10 Department of Kentucky State Police an electronic renewal form in lieu of a
11 paper renewal form, stating that the licensee remains qualified pursuant to the
12 criteria specified in subsections (3) and (4) of this section, and the required
13 renewal fee set forth in subsection (7) of this section. The sheriff shall issue to
14 the applicant a receipt for the paper application for renewal of the license and
15 shall date the receipt. The Department of Kentucky State Police shall issue to
16 the applicant a receipt for an electronic application for renewal of the license
17 submitted in lieu of a paper application for renewal and shall date the receipt.
- 18 (b) A license which has expired shall be void and shall not be valid for any
19 purpose other than surrender to the sheriff in exchange for a renewal license.
- 20 (c) The license shall be renewed to a qualified applicant upon receipt of the
21 completed renewal application, records check as specified in subsection (3) of
22 this section, determination that the renewal applicant is not ineligible for a
23 license as specified in subsection (4), and appropriate payment of fees. Upon
24 the issuance of a new license, the old license shall be destroyed by the sheriff.
25 A licensee who fails to file a renewal application on or before its expiration
26 date may renew his or her license by paying, in addition to the license fees, a
27 late fee of fifteen dollars (\$15). No license shall be renewed six (6) months or

1 more after its expiration date, and the license shall be deemed to be
2 permanently expired six (6) months after its expiration date. A person whose
3 license has permanently expired may reapply for licensure pursuant to
4 subsections (7), (8), and (9) of this section.

5 (15) The licensee shall carry the license at all times the licensee is carrying a concealed
6 firearm or other deadly weapon and shall display the license upon request of a law
7 enforcement officer. Violation of the provisions of this subsection shall constitute a
8 noncriminal violation with a penalty of twenty-five dollars (\$25), payable to the
9 clerk of the District Court, but no court costs shall be assessed.

10 (16) Except as provided in KRS 527.020, no license issued pursuant to this section shall
11 authorize any person to carry a concealed firearm into:

12 (a) Any police station or sheriff's office;

13 (b) Any detention facility, prison, or jail;

14 (c) Any courthouse, solely occupied by the Court of Justice courtroom, or court
15 proceeding;

16 (d) Any meeting of the governing body of a county, municipality, or special
17 district; or any meeting of the General Assembly or a committee of the
18 General Assembly, except that nothing in this section shall preclude a member
19 of the body, holding a concealed deadly weapon license, from carrying a
20 concealed deadly weapon at a meeting of the body of which he or she is a
21 member;

22 (e) Any portion of an establishment licensed to dispense beer or alcoholic
23 beverages for consumption on the premises, which portion of the
24 establishment is primarily devoted to that purpose;

25 (f) Any elementary or secondary school facility without the consent of school
26 authorities as provided in KRS 527.070, any child-caring facility as defined in
27 KRS 199.011, any day-care center as defined in KRS 199.894, or any certified

- 1 family child-care home as defined in KRS 199.8982, except however, any
2 owner of a certified child-care home may carry a concealed firearm into the
3 owner's residence used as a certified child-care home;
- 4 (g) An area of an airport to which access is controlled by the inspection of
5 persons and property; or
- 6 (h) Any place where the carrying of firearms is prohibited by federal law.
- 7 (17) The owner, business or commercial lessee, or manager of a private business
8 enterprise, day-care center as defined in KRS 199.894 or certified or licensed
9 family child-care home as defined in KRS 199.8982, or a health-care facility
10 licensed under KRS Chapter 216B, except facilities renting or leasing housing, may
11 prohibit persons holding concealed deadly weapon licenses from carrying
12 concealed deadly weapons on the premises and may prohibit employees, not
13 authorized by the employer, holding concealed deadly weapons licenses from
14 carrying concealed deadly weapons on the property of the employer. If the building
15 or the premises are open to the public, the employer or business enterprise shall
16 post signs on or about the premises if carrying concealed weapons is prohibited.
17 Possession of weapons, or ammunition, or both in a vehicle on the premises shall
18 not be a criminal offense so long as the weapons, or ammunition, or both are not
19 removed from the vehicle or brandished while the vehicle is on the premises. A
20 private but not a public employer may prohibit employees or other persons holding
21 a concealed deadly weapons license from carrying concealed deadly weapons, or
22 ammunition, or both in vehicles owned by the employer, but may not prohibit
23 employees or other persons holding a concealed deadly weapons license from
24 carrying concealed deadly weapons, or ammunition, or both in vehicles owned by
25 the employee, except that the Justice and Public Safety Cabinet may prohibit an
26 employee from carrying any weapons, or ammunition, or both other than the
27 weapons, or ammunition, or both issued or authorized to be used by the employee

1 of the cabinet, in a vehicle while transporting persons under the employee's
2 supervision or jurisdiction. Carrying of a concealed weapon, or ammunition, or both
3 in a location specified in this subsection by a license holder shall not be a criminal
4 act but may subject the person to denial from the premises or removal from the
5 premises, and, if an employee of an employer, disciplinary measures by the
6 employer.

7 (18) All moneys collected by the Department of Kentucky State Police pursuant to this
8 section shall be used to administer the provisions of this section and KRS 237.138
9 to 237.142. By March 1 of each year, the Department of Kentucky State Police and
10 the Administrative Office of the Courts shall submit reports to the Governor, the
11 President of the Senate, and the Speaker of the House of Representatives, indicating
12 the amounts of money collected and the expenditures related to this section, KRS
13 237.138 to 237.142, and KRS 237.115, 244.125, 527.020, and 527.070, and the
14 administration of the provisions of this section, KRS 237.138 to 237.142, and KRS
15 237.115, 244.125, 527.020, and 527.070.

16 (19) The General Assembly finds as a matter of public policy that it is necessary to
17 provide statewide uniform standards for issuing licenses to carry concealed firearms
18 and to occupy the field of regulation of the bearing of concealed firearms to ensure
19 that no person who qualifies under the provisions of this section is denied his rights.
20 The General Assembly does not delegate to the Department of Kentucky State
21 Police the authority to regulate or restrict the issuing of licenses provided for in this
22 section beyond those provisions contained in this section. This section shall be
23 liberally construed to carry out the constitutional right to bear arms for self-defense.

24 (20) (a) A person who is not a resident of Kentucky and who has a valid license issued
25 by another state of the United States to carry a concealed deadly weapon in
26 that state may, subject to provisions of Kentucky law, carry a concealed
27 deadly weapon in Kentucky, and his or her license shall be considered as valid

1 in Kentucky.

2 (b) If a person with a valid license to carry a concealed deadly weapon issued
3 from another state that has entered into a reciprocity agreement with the
4 Department of Kentucky State Police becomes a resident of Kentucky, the
5 license issued by the other state shall be considered as valid for the first one
6 hundred twenty (120) days of the person's residence in Kentucky, if within
7 sixty (60) days of moving to Kentucky, the person completes a form
8 promulgated by the Department of Kentucky State Police which shall include:

9 1. A signed and notarized statement averring that to the best of his or her
10 knowledge the person's license to carry a concealed deadly weapon is
11 valid and in compliance with applicable out-of-state law, and has not
12 been revoked or suspended for any reason except for valid forfeiture due
13 to departure from the issuing state;

14 2. The person's name, date of birth, citizenship, gender, Social Security
15 number if applicable, proof that he or she is a citizen of the United
16 States, a permanent resident of the United States, or otherwise lawfully
17 present in the United States, former out-of-state address, current address
18 within the state of Kentucky, date on which Kentucky residence began,
19 state which issued the concealed carry license, the issuing state's
20 concealed carry license number, and the state of issuance of license; and

21 3. A photocopy of the person's out-of-state license to carry a concealed
22 deadly weapon.

23 (c) Within sixty (60) days of moving to Kentucky, the person shall deliver the
24 form and accompanying documents by registered or certified mail, return
25 receipt requested, to the address indicated on the form provided by the
26 Department of Kentucky State Police pursuant to this subsection.

27 (d) The out-of-state concealed carry license shall become invalid in Kentucky

1 upon the earlier of:

- 2 1. The out-of-state person having resided in Kentucky for more than one
- 3 hundred twenty (120) days; or
- 4 2. The person being issued a Kentucky concealed deadly weapon license
- 5 pursuant to this section.

6 (e) The Department of Kentucky State Police shall, ~~[not later than thirty (30) days~~
7 ~~after July 15, 1998, and]~~ not less than once every twelve (12) months~~[~~
8 ~~thereafter]~~, make written inquiry of the concealed deadly weapon carrying
9 licensing authorities in each other state as to whether a Kentucky resident may
10 carry a concealed deadly weapon in their state based upon having a valid
11 Kentucky concealed deadly weapon license, or whether a Kentucky resident
12 may apply for a concealed deadly weapon carrying license in that state based
13 upon having a valid Kentucky concealed deadly weapon license. The
14 Department of Kentucky State Police shall attempt to secure from each other
15 state permission for Kentucky residents who hold a valid Kentucky concealed
16 deadly weapon license to carry concealed deadly weapons in that state, either
17 on the basis of the Kentucky license or on the basis that the Kentucky license
18 is sufficient to permit the issuance of a similar license by the other state. The
19 Department of Kentucky State Police shall enter into a written reciprocity
20 agreement with the appropriate agency in each state that agrees to permit
21 Kentucky residents to carry concealed deadly weapons in the other state on
22 the basis of a Kentucky-issued concealed deadly weapon license or that will
23 issue a license to carry concealed deadly weapons in the other state based
24 upon a Kentucky concealed deadly weapon license. If a reciprocity agreement
25 is reached, the requirement to recontact the other state each twelve (12)
26 months shall be eliminated as long as the reciprocity agreement is in force.
27 The information shall be a public record and shall be available to individual

1 requesters free of charge for the first copy and at the normal rate for open
2 records requests for additional copies.

3 (21) By March 1 of each year, the Department of Kentucky State Police shall submit a
4 statistical report to the Governor, the President of the Senate, and the Speaker of the
5 House of Representatives, indicating the number of licenses issued, revoked,
6 suspended, and denied since the previous report and in total and also the number of
7 licenses currently valid. The report shall also include the number of arrests,
8 convictions, and types of crimes committed since the previous report by individuals
9 licensed to carry concealed weapons.

10 (22) The following provisions shall apply to concealed deadly weapon training classes
11 conducted by the Department of Criminal Justice Training or any other agency
12 pursuant to this section:

13 (a) No concealed deadly weapon instructor trainer shall have his or her
14 certification as a concealed deadly weapon instructor trainer reduced to that of
15 instructor or revoked except after a hearing conducted pursuant to KRS
16 Chapter 13B in which the instructor is found to have committed an act in
17 violation of the applicable statutes or administrative regulations;

18 (b) No concealed deadly weapon instructor shall have his or her certification as a
19 concealed deadly weapon instructor license suspended or revoked except after
20 a hearing conducted pursuant to KRS Chapter 13B in which the instructor is
21 found to have committed an act in violation of the applicable statutes or
22 administrative regulations;

23 (c) The department shall not require prior notification that an applicant class or
24 instructor class will be conducted by a certified instructor or instructor trainer;

25 (d) Each concealed deadly weapon instructor or instructor trainer who teaches a
26 concealed deadly weapon applicant or concealed deadly weapon instructor
27 class shall supply the Department of Criminal Justice Training with a class

1 roster indicating which students enrolled and successfully completed the class,
2 and which contains the name and address of each student, within five (5)
3 working days of the completion of the class. The information may be sent by
4 mail, facsimile, email~~[e-mail]~~, or other method which will result in the receipt
5 of or production of a hard copy of the information. The postmark, facsimile
6 date, or e-mail date shall be considered as the date on which the notice was
7 sent. Concealed deadly weapon class applicant, instructor, and instructor
8 trainer information and records shall be confidential. The department may
9 release to any person or organization the name, address, and telephone
10 number of a concealed deadly weapon instructor or instructor trainer if that
11 instructor or instructor trainer authorizes the release of the information in
12 writing. The department shall include on any application for an instructor or
13 instructor trainer certification a statement that the applicant either does or
14 does not desire the applicant's name, address, and telephone number to be
15 made public;

16 (e) An instructor trainer who assists in the conduct of a concealed deadly weapon
17 instructor class or concealed deadly weapon applicant class for more than two
18 (2) hours shall be considered as to have taught a class for the purpose of
19 maintaining his or her certification. All class record forms shall include spaces
20 for assistant instructors to sign and certify that they have assisted in the
21 conduct of a concealed deadly weapon instructor or concealed deadly weapon
22 class;

23 (f) An instructor who assists in the conduct of a concealed deadly weapon
24 applicant class for more than two (2) hours shall be considered as to have
25 taught a class for the purpose of maintaining his or her license. All class
26 record forms shall include spaces for assistant instructors to sign and certify
27 that they have assisted in the conduct of a concealed deadly weapon class;

1 (g) If the Department of Criminal Justice Training believes that a firearms
2 instructor trainer or certified firearms instructor has not in fact complied with
3 the requirements for teaching a certified firearms instructor or applicant class
4 by not teaching the class as specified in KRS 237.126, or who has taught an
5 insufficient class as specified in KRS 237.128, the department shall send to
6 each person who has been listed as successfully completing the concealed
7 deadly weapon applicant class or concealed deadly weapon instructor class a
8 verification form on which the time, date, date of range firing if different from
9 the date on which the class was conducted, location, and instructor of the class
10 is listed by the department and which requires the person to answer "yes" or
11 "no" to specific questions regarding the conduct of the training class. The
12 form shall be completed under oath and shall be returned to the Department of
13 Criminal Justice Training not later than forty-five (45) days after its receipt. A
14 person who fails to complete the form, to sign the form, or to return the form
15 to the Department of Criminal Justice Training within the time frame
16 specified in this section or who, as a result of information on the returned
17 form, is determined by the Department of Criminal Justice Training,
18 following a hearing pursuant to KRS Chapter 13B, to not have received the
19 training required by law shall have his or her concealed deadly weapon
20 license revoked by the Department of Kentucky State Police, following a
21 hearing conducted by the Department of Criminal Justice Training pursuant to
22 KRS Chapter 13B, at which hearing the person is found to have violated the
23 provisions of this section or who has been found not to have received the
24 training required by law;

25 (h) The department shall annually, not later than December 31 of each year,
26 report to the Legislative Research Commission:

27 1. The number of firearms instructor trainers and certified firearms

- 1 instructors whose certifications were suspended, revoked, denied, or
2 who were otherwise disciplined;
- 3 2. The reasons for the imposition of suspensions, revocations, denials, or
4 other discipline; and
- 5 3. Suggestions for improvement of the concealed deadly weapon applicant
6 training program and instructor process;
- 7 (i) If a concealed deadly weapon license holder is convicted of, pleads guilty to,
8 or enters an Alford plea to a felony offense, then his or her concealed deadly
9 weapon license shall be forthwith revoked by the Department of Kentucky
10 State Police as a matter of law;
- 11 (j) If a concealed deadly weapon instructor or instructor trainer is convicted of,
12 pleads guilty to, or enters an Alford plea to a felony offense, then his or her
13 concealed deadly weapon instructor certification or concealed deadly weapon
14 instructor trainer certification shall be revoked by the Department of Criminal
15 Justice Training as a matter of law; and
- 16 (k) The following shall be in effect:
- 17 1. Action to eliminate the firearms instructor trainer program is prohibited.
18 The program shall remain in effect, and no firearms instructor trainer
19 shall have his or her certification reduced to that of certified firearms
20 instructor;
- 21 2. The Department of Kentucky State Police shall revoke the concealed
22 deadly weapon license of any person who received no firearms training
23 as required by KRS 237.126 and administrative regulations, or who
24 received insufficient training as required by KRS 237.128 and
25 administrative regulations, if the person voluntarily admits nonreceipt of
26 training or admits receipt of insufficient training, or if either nonreceipt
27 of training or receipt of insufficient training is proven following a

1 hearing conducted by the Department of Criminal Justice Training

4 Before distribution of the funds, a list of individuals or entities that are awarded tobacco

17 made, or upon either parent's petition if the amount of the child support awarded
