1	A CONCURRENT RESOLUTION expressing Kentucky's support for the Crisis
2	Recovery Support Network coordinated by the Southern Regional Education Board,
3	expressing support for Kentucky's participation in the network, and recognizing the
4	network as a trusted support for Kentucky schools, districts, and postsecondary
5	institutions to know they may call upon if the need arises.
6	WHEREAS, after natural disasters such as hurricanes, tornadoes, and floods, after
7	school shootings, and in public emergencies, recovery must be prioritized as a long-term
8	process, rather than an immediate response only; and
9	WHEREAS, states, school districts, and postsecondary institutions have focused on
10	crisis prevention and management, but may not have the capacity to provide sustained
11	counseling support for their students, teachers, communities, and even their own
12	counselors during the recovery stage; and
13	WHEREAS, rural school districts and institutions in particular tend to have fewer
14	counselors and limited access to additional counseling resources; and
15	WHEREAS, school counselors are often expected to respond to student needs after
16	tragedy, even as they themselves grapple with the emotional toll, underscoring the need
17	for external support for the entire school community; and
18	WHEREAS, schools and institutions affected by crisis may require at least a year of
19	dedicated support to fully recover; and
20	WHEREAS, recovery efforts can strain resources that are already stretched thin,
21	given that a National Center for Education Statistics study showed that less than half of
22	public schools surveyed believe that their school is equipped to provide mental health
23	services to all students in need; and
24	WHEREAS, recovery is an extended healing process for students and adults alike,
25	and having additional counselors come to the aid of a school or institution in extreme
26	need supports the healing process of all people in the community, including teachers and
27	counselors; and

1 WHEREAS, specialized training for counselors is essential to ensure they have 2 received psychological first aid training and provide counseling that aligns with the 3 unique needs of an educational environment; and 4 WHEREAS, research shows that students who receive adequate support after a 5 crisis are more likely to succeed academically, remain in school, and contribute positively 6 to society; and 7 WHEREAS, the Southern Regional Education Board (SREB), with its 75-year history of partnering with states to improve education, is uniquely equipped to lead this 8 9 effort because of its ability to mobilize key education and policymaking stakeholders at 10 all levels; and 11 WHEREAS, SREB will cover the cost of a coordinator to operate the network, as 12 well as travel costs for network counselors during training and deployment; and 13 WHEREAS, SREB has secured funding for the first two years of training for a pool 14 of counselors from each SREB state; and 15 WHEREAS, the Kentucky General Assembly is aware that SREB will ask states for 16 \$10,000 in additional funding in two years to sustain training of counselors; 17 NOW, THEREFORE, 18 Be it resolved by the Senate of the General Assembly of the Commonwealth of 19 Kentucky, the House of Representatives concurring therein: 20 → Section 1. To meet the urgent need for a coordinated, region-wide effort to 21 provide consistent long-term counseling capacity that is ready to deploy immediately 22 after a crisis is managed, the Kentucky General Assembly supports the mission of the 23 Southern Regional Education Board (SREB) Crisis Recovery Support Network. The 24 SREB, in close collaboration with governors' offices, state education agencies, local 25 school districts, and postsecondary institutions, will complement existing school and 26 district crisis management efforts by focusing on long-term healing and psychological 27 resilience by deploying counselors with specialized training to schools in extreme need.
