"(13) "Profile-based feed":

(a) Means a stream of content which has been selected or prioritized by the covered social media platform for display to an account holder based in whole or in part on the personal information of that account holder; and

(b) Does not include a stream of content where the selection or prioritization by the covered social media platform is based on:

1. An account holder's affirmative choice to include, exclude, prioritize, or deprioritize a third party's content in the account holder's displayed feed, including but not limited to following, friending, unfollowing, blocking, or engaging in a similar action with respect to the third party;

2. The age or any estimate of the age of the account holder used solely to implement the covered social media platform's policies regarding media appropriate for minors;

(8) A covered social media platform shall not collect, sell, share, or retain any personal information of a child that is not necessary to provide a child access to a covered social media platform with which the child is actively and knowingly engaged.

(9) A covered social media platform shall not use previously collected personal information of a child for any purpose other than the purpose for which the personal information was originally collected, unless necessary to comply with any obligation under Sections 1 to 7 of this Act."; and

On page 9, line 5, after "determination.", insert the following: "**Information collected for the purpose of verifying an account holder's age shall not be used for any purpose other than age verification and shall be deleted immediately after the covered social media platform has completed its determination, except to the extent necessary to comply with any other applicable state or federal law or regulation.**"; and

On page 9, lines 6 to 11, delete Section 5 in its entirety; and

Re-number subsequent sections accordingly; and
