

1 AN ACT relating to the Kentucky Communications Network Authority and  
2 declaring an emergency.

3 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

4 ➔Section 1. KRS 154.15-010 is amended to read as follows:

5 As used in this subchapter:

6 (1) "Authority" means the Kentucky Communications Network Authority;

7 (2) "Board" means the Board of the Kentucky Communications Network Authority;

8 (3) ~~"Executive director" means the executive director of the Kentucky Communications~~  
9 ~~Network Authority;~~

10 (4) "Network" or "KentuckyWired" means the Commonwealth's open-access  
11 broadband network; and

12 (4) ~~(5)~~ "Partnership" means the public-private partnership entered into between the  
13 Commonwealth and a private entity or entities for the purpose of creating, running,  
14 and maintaining the network.

15 ➔Section 2. KRS 154.15-020 is amended to read as follows:

16 (1) The Kentucky Communications Network Authority is established and shall be  
17 attached to the *Finance and Administration Cabinet for administrative*  
18 *purposes* ~~[Office of the Governor. The authority shall be headed by an executive~~  
19 ~~director who shall be hired by the board and approved by the Governor].~~

20 (2) ~~[Notwithstanding KRS 42.726,]~~ The duties of the authority shall be to:

21 (a) Oversee and maintain KentuckyWired, the Commonwealth's open-access  
22 broadband network;

23 (b) Manage the master agreement establishing the public-private partnership  
24 between the Commonwealth and its private industry partner or partners. The  
25 purpose of the agreement is to design, engineer, build, operate, maintain, and  
26 upgrade the network;

27 (c) Provide network connectivity to public agencies;

- 1 (d) Offer access to entities eligible to utilize excess capacity on the network;
- 2 (e) Manage other aspects of the network and its utilization~~[through the executive~~  
3 ~~director and]~~ with oversight and input from the board established in KRS  
4 154.15-030~~[and the advisory group established in this section];~~
- 5 (f) Promulgate administrative regulations *in accordance with*~~[pursuant to]~~ KRS  
6 Chapter 13A necessary to implement the purposes of this subchapter;
- 7 (g) Enter into contracts with public and private entities to carry out its duties and  
8 responsibilities. A contract or other agreement involving the acquisition or  
9 disposition of a property interest by the Commonwealth shall be signed by the  
10 secretary of the Finance and Administration Cabinet. KRS Chapters 45A and  
11 56 may require the secretary's signature on other contracts or agreements;
- 12 (h) Provide program management services ensuring the financial viability of the  
13 master agreement and related contracts and agreements, including grant  
14 administration, contract compliance and oversight, community planning  
15 support, and constituent services; *and*
- 16 (i) Seek out, secure, and manage funding sources for the network~~;~~ *and*
- 17 ~~(j) Create an advisory group, including major stakeholders, to provide input and~~  
18 ~~feedback on issues important to the user community and to the long-term~~  
19 ~~sustainability of the project and the network. The advisory group shall be~~  
20 ~~administratively attached to and managed by the authority. The advisory~~  
21 ~~group shall include but not be limited to representatives of:~~
- 22 1. ~~The Department of Education;~~
- 23 2. ~~The Council on Postsecondary Education;~~
- 24 3. ~~The Cabinet for Economic Development;~~

10       (3) *The executive director of the Commonwealth Office of Technology established in*  
11       *KRS 42.724 shall assign personnel employed with the Commonwealth Office of*  
12       *Technology to carry out the functions and responsibilities of the authority*~~[With~~  
13       ~~the approval of the board, the executive director may hire additional officers and~~  
14       ~~other personnel necessary for the proper functioning of the authority, fix their~~  
15       ~~salaries, and prescribe their duties. The executive director and persons employed by~~  
16       ~~the authority shall not be subject to the provisions of KRS Chapter 18A].~~

17       (4) (a) With the approval of the board, the executive director *of the Commonwealth*  
18       *Office of Technology* may make, execute, and effectuate contracts, leveraging  
19       future revenues from provision of government-to-government services and  
20       sale or lease of excess capacity, to incur debt in the name of the authority and  
21       enter into financing agreements with the Commonwealth, agencies of the  
22       Commonwealth, lending institutions, investors, or investing entities.

23       (b) The total amount of debt or financing under this subsection shall not exceed  
24       one hundred ten million dollars (\$110,000,000), and shall not leverage any  
25       future revenues committed to the repayment of any other debt, or expected to  
26       be used for the repayment of any other debt, as of the time the debt or  
27       financing is entered into.

- 1 (c) Any proposed debt or financing under this subsection shall be submitted to the  
2 Capital Projects and Bond Oversight Committee for review at least fourteen  
3 (14) days prior to the committee meeting.
- 4 (d) If any debt or financing is incurred under this subsection, the authority shall  
5 provide to the Legislative Research Commission:
- 6 1. Within thirty (30) days of entering into a debt or financing agreement, a  
7 copy of the agreement; and
- 8 2. On January 1, April 1, July 1, and October 1 of each year that the debt  
9 or financing is outstanding:
- 10 a. The amount of principal and interest remaining on the debt or  
11 financing;
- 12 b. The use to which the capital gained from the debt or financing has  
13 been put; and
- 14 c. Any amendments, if any, to the original debt or financing  
15 instruments or agreements.

16 **(5) The following officials shall serve as ex officio members on the board of directors**  
17 **of any nonprofit organization incorporated under the laws of the Commonwealth**  
18 **to carry out activities associated with the roles or responsibilities of the authority**  
19 **or the board:**

20 **(a) The secretary of the Finance and Administration Cabinet;**

21 **(b) The Treasurer; and**

22 **(c) The executive director of the Commonwealth Office of Technology.**

23 ➔Section 3. KRS 154.15-030 is amended to read as follows:

24 (1) The Board of the Kentucky Communications Network Authority is established. The  
25 board shall be attached administratively to the **Finance and Administration**  
26 **Cabinet**~~[Office of the Governor]~~.

27 (2) The board shall consist of:

- 1 (a) The chief information officer of the Department of Education~~[secretary of~~  
 2 ~~the Governor's Executive Cabinet]~~ or designee, who shall serve as chair of the  
 3 board;
- 4 (b) Two (2) members designated by the Governor as follows:
- 5 1. One (1) member selected from a list of three (3) nominees submitted  
 6 by the Kentucky League of Cities; and
- 7 2. One (1) member selected from a list of three (3) nominees submitted  
 8 by the Kentucky Association of Counties~~[The state budget director or~~  
 9 ~~designee;~~

- 18 (3) The duties of the board shall be to:
- 19 (a) Develop and implement a strategic plan for and provide policy direction to the  
 20 authority;
- 21 (b) Review performance reports from the partners named in the master agreement  
 22 regarding deployment, operations, and administration of the network and its  
 23 compliance with service level agreements with the Commonwealth;
- 24 (c) Monitor the results achieved through the partnership's strategy to develop new  
 25 revenue streams and expand network usage through marketing and awareness  
 26 programs;
- 27 (d) Approve fiscal planning for the authority including budget development, state

1 appropriations management, cost-recovery schedules, grant administration,  
2 and billing services;

3 (e) Establish rates for services offered through the network and establish methods  
4 for customer account management; and

5 (f) Direct upgrades to technology as necessary.

6 (4) The board shall meet at least semiannually and at other times upon the call of the  
7 chair.

8 (5) The board may form committees or other subgroups as necessary to accomplish its  
9 duties and functions.

10 ➔Section 4. KRS 42.014 is amended to read as follows:

11 (1) There is established within the cabinet the:

12 (a) Office of the Secretary;

13 (b) Commonwealth Office of Technology~~[-]~~ and the Office of the Controller, each  
14 of which shall be headed by an executive director appointed by the secretary  
15 with the approval of the Governor;

16 (c) *Kentucky Communications Network Authority established in Section 2 of*  
17 *this Act and headed by the executive director of the Commonwealth Office*  
18 *of Technology;*

19 (d) *Board of the Kentucky Communications Network Authority established in*  
20 *Section 3 of this Act;* and

21 (e)~~[-(e)]~~ Department of Revenue and the Department for Facilities and Support  
22 Services, each of which shall be headed by a commissioner appointed by the  
23 secretary, upon the approval of the Governor, and responsible to the secretary.  
24 Each of these departments may have at least one (1) major assistant not in the  
25 classified service.

26 (2) The secretary shall establish the internal organization and assignment of functions  
27 which are not established by statute, and shall divide the cabinet into the offices,

1       bureaus, divisions, or other units the secretary deems necessary to perform the  
2       functions, powers, and duties of the cabinet, subject to the provisions of KRS  
3       Chapter 12.

4       (3) All appointments under this chapter to positions not in the classified service shall be  
5       made pursuant to KRS 12.050, and such appointees shall be major assistants to the  
6       secretary and shall assist in the development of policy.

7       ➔Section 5. KRS 42.726 is amended to read as follows:

8       (1) The Commonwealth Office of Technology shall be the lead organizational entity  
9       within the executive branch regarding delivery of information technology services,  
10       including application development and delivery, and shall serve as the single  
11       information technology authority for the Commonwealth.

12       (2) The roles and duties of the Commonwealth Office of Technology shall include but  
13       not be limited to:

14       (a) Providing technical support and services to all executive agencies of state  
15       government in the application of information technology;

16       (b) Assuring compatibility and connectivity of Kentucky's information systems;

17       (c) Developing strategies and policies to support and promote the effective  
18       applications of information technology within state government as a means of  
19       saving money, increasing employee productivity, and improving state services  
20       to the public, including electronic public access to information of the  
21       Commonwealth;

22       (d) Developing, implementing, and managing strategic information technology  
23       directions, standards, and enterprise architecture, including implementing  
24       necessary management processes to ensure full compliance with those  
25       directions, standards, and architecture;

26       (e) Promoting effective and efficient design and operation of all major  
27       information resources management processes for executive branch agencies,

- 1 including improvements to work processes;
- 2 (f) Developing, implementing, and maintaining the technology infrastructure of
- 3 the Commonwealth and all related support staff, planning, administration,
- 4 asset management, and procurement for all executive branch cabinets and
- 5 agencies except:
- 6 1. Agencies led by a statewide elected official;
- 7 2. The nine (9) public institutions of postsecondary education;
- 8 3. The Department of Education's services provided to local school
- 9 districts;
- 10 4. The Kentucky Retirement Systems, the County Employees Retirement
- 11 System, the Kentucky Public Pensions Authority, and the Teachers'
- 12 Retirement System;
- 13 5. The Kentucky Housing Corporation;
- 14 6. The Kentucky Lottery Corporation;
- 15 7. The Kentucky Higher Education Student Loan Corporation; and
- 16 8. The Kentucky Higher Education Assistance Authority;
- 17 (g) Facilitating and fostering applied research in emerging technologies that offer
- 18 the Commonwealth innovative business solutions;
- 19 (h) Reviewing and overseeing large or complex information technology projects
- 20 and systems for compliance with statewide strategies, policies, and standards,
- 21 including alignment with the Commonwealth's business goals, investment,
- 22 and other risk management policies. The executive director is authorized to
- 23 grant or withhold approval to initiate these projects;
- 24 (i) Integrating information technology resources to provide effective and
- 25 supportable information technology applications in the Commonwealth;
- 26 (j) Establishing the central statewide geographic information clearinghouse to
- 27 maintain map inventories, information on current and planned geographic



- 1 information systems applications, information on grants available for the  
2 acquisition or enhancement of geographic information resources, and a  
3 directory of geographic information resources available within the state or  
4 from the federal government;
- 5 (k) Coordinating multiagency information technology projects, including  
6 overseeing the development and maintenance of statewide base maps and  
7 geographic information systems;
- 8 (l) Providing access to both consulting and technical assistance, and education  
9 and training, on the application and use of information technologies to state  
10 and local agencies;
- 11 (m) In cooperation with other agencies, evaluating, participating in pilot studies,  
12 and making recommendations on information technology hardware and  
13 software;
- 14 (n) Providing staff support and technical assistance to the Geographic  
15 Information Advisory Council and the Kentucky Information Technology  
16 Advisory Council;
- 17 (o) Overseeing the development of a statewide geographic information plan with  
18 input from the Geographic Information Advisory Council;
- 19 (p) Developing for state executive branch agencies a coordinated security  
20 framework and model governance structure relating to the privacy and  
21 confidentiality of personal information collected and stored by state executive  
22 branch agencies, including but not limited to:
- 23 1. Identification of key infrastructure components and how to secure them;  
24 2. Establishment of a common benchmark that measures the effectiveness  
25 of security, including continuous monitoring and automation of  
26 defenses;
- 27 3. Implementation of vulnerability scanning and other security

- 1 assessments;
- 2 4. Provision of training, orientation programs, and other communications
- 3 that increase awareness of the importance of security among agency
- 4 employees responsible for personal information; and
- 5 5. Development of and making available a cyber security incident response
- 6 plan and procedure;
- 7 (q) Establishing, publishing, maintaining, and implementing comprehensive
- 8 policy standards and procedures for the responsible, ethical, and transparent
- 9 use of generative artificial intelligence systems and high-risk artificial
- 10 intelligence systems by departments, agencies, and administrative bodies,
- 11 including but not limited to policy standards and procedures that:
- 12 1. Govern their procurement, implementation, and ongoing assessment;
- 13 2. Address and provide resources for security of data and privacy; and
- 14 3. Create guidelines for acceptable use policies for integrating high-risk
- 15 artificial intelligence systems;~~and~~
- 16 (r) Preparing proposed legislation and funding proposals for the General
- 17 Assembly that will further solidify coordination and expedite implementation
- 18 of information technology systems;and
- 19 (s) Carrying out the functions and responsibilities of the Kentucky
- 20 Communications Network Authority established in Section 2 of this Act.
- 21 (3) The Commonwealth Office of Technology may:
- 22 (a) Provide general consulting services, technical training, and support for
- 23 generic software applications, upon request from a local government, if the
- 24 executive director finds that the requested services can be rendered within the
- 25 established terms of the federally approved cost allocation plan;
- 26 (b) Promulgate administrative regulations in accordance with KRS Chapter 13A
- 27 necessary for the implementation of KRS 42.720 to 42.742, 45.253, 171.420,

- 1 186A.040, and 186A.285;
- 2 (c) Solicit, receive, and consider proposals from any state agency, federal agency,
- 3 local government, university, nonprofit organization, private person, or
- 4 corporation;
- 5 (d) Solicit and accept money by grant, gift, donation, bequest, legislative
- 6 appropriation, or other conveyance to be held, used, and applied in accordance
- 7 with KRS 42.720 to 42.742, 45.253, 171.420, 186A.040, and 186A.285;
- 8 (e) Make and enter into memoranda of agreement and contracts necessary or
- 9 incidental to the performance of duties and execution of its powers, including
- 10 but not limited to agreements or contracts with the United States, other state
- 11 agencies, and any governmental subdivision of the Commonwealth;
- 12 (f) Accept grants from the United States government and its agencies and
- 13 instrumentalities, and from any source, other than any person, firm, or
- 14 corporation, or any director, officer, or agent thereof that manufactures or
- 15 sells information resources technology equipment, goods, or services. To
- 16 these ends, the Commonwealth Office of Technology shall have the power to
- 17 comply with those conditions and execute those agreements that are
- 18 necessary, convenient, or desirable; and
- 19 (g) Purchase interest in contractual services, rentals of all types, supplies,
- 20 materials, equipment, and other services to be used in the research and
- 21 development of beneficial applications of information resources technologies.
- 22 Competitive bids may not be required for:
- 23 1. New and emerging technologies as approved by the executive director
- 24 or her or his designee; or
- 25 2. Related professional, technical, or scientific services, but contracts shall
- 26 be submitted in accordance with KRS 45A.690 to 45A.725.
- 27 (4) Nothing in this section shall be construed to alter or diminish the provisions of KRS

1 171.410 to 171.740 or the authority conveyed by these statutes to the Archives and  
2 Records Commission and the Department for Libraries and Archives.

3 (5) The Commonwealth Office of Technology shall, on or before October 1 of each  
4 year, submit to the Legislative Research Commission a report in accordance with  
5 KRS 57.390 detailing:

6 (a) Any security breaches that occurred within organizational units of the  
7 executive branch of state government during the prior fiscal year that required  
8 notification to the Commonwealth Office of Technology under KRS 61.932;

9 (b) Actions taken to resolve the security breach, and to prevent additional security  
10 breaches in the future;

11 (c) A general description of what actions are taken as a matter of course to protect  
12 personal data from security breaches; and

13 (d) Any quantifiable financial impact to the agency reporting a security breach.

14 ➔Section 6. KRS 42.732 is amended to read as follows:

15 (1) There is hereby created the Kentucky Information Technology Advisory Council to:

16 (a) Advise the executive director of the Commonwealth Office of Technology on  
17 approaches to coordinating information technology solutions among libraries,  
18 public schools, local governments, universities, and other public entities;

19 (b) Advise the executive director of the Commonwealth Office of Technology on  
20 coordination among and across the organizational units of the executive  
21 branch of state government to prepare for, respond to, and prevent attacks;  
22 and

23 (c) Provide a forum for the discussion of emerging technologies that enhance  
24 electronic accessibility to various publicly funded sources of information and  
25 services.

26 (2) The Kentucky Information Technology Advisory Council shall consist of:

27 (a) The state budget director or a designee;

- 1 (b) The state librarian or a designee;
- 2 (c) One (1) representative from the public universities to be appointed by the
- 3 Governor from a list of three (3) persons submitted by the Council on
- 4 Postsecondary Education;
- 5 (d) Three (3) citizen members from the private sector with information
- 6 technology knowledge and experience appointed by the Governor;
- 7 (e) Two (2) representatives of local government appointed by the Governor;
- 8 (f) One (1) representative from the area development districts appointed by the
- 9 Governor from a list of names submitted by the executive directors of the area
- 10 development districts;
- 11 (g) One (1) member of the media appointed by the Governor;
- 12 (h) The executive director of the Kentucky Authority for Educational Television;
- 13 (i) The chair of the Public Service Commission or a designee;
- 14 (j) Two (2) members of the Kentucky General Assembly, one (1) from each
- 15 chamber, selected by the Legislative Research Commission;
- 16 (k) One (1) representative of the Administrative Office of the Courts;
- 17 (l) One (1) representative from the public schools system appointed by the
- 18 Governor;
- 19 (m) One (1) representative of the Kentucky Chamber of Commerce; and
- 20 (n) The executive director of the Commonwealth Office of Technology; and
- 21 ~~(o) The executive director of the Kentucky Communications Network Authority~~
- 22 ~~or designee].~~
- 23 (3) Appointed members of the council shall serve for a term of two (2) years. Members
- 24 who serve by virtue of an office shall serve on the council while they hold the
- 25 office.
- 26 (4) Vacancies on the council shall be filled in the same manner as the original
- 27 appointments. If a nominating organization changes its name, its successor

1 organization having the same responsibilities and purposes shall be the nominating  
2 organization.

3 (5) Members shall receive no compensation but shall receive reimbursement for actual  
4 and necessary expenses in accordance with travel and subsistence requirements  
5 established by the Finance and Administration Cabinet.

6 ➔Section 7. KRS 12.020 is amended to read as follows:

7 Departments, program cabinets and their departments, and the respective major  
8 administrative bodies that they include are enumerated in this section. It is not intended  
9 that this enumeration of administrative bodies be all-inclusive. Every authority, board,
