

1 AN ACT relating to public postsecondary education.

2 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

3 ➔Section 1. KRS 164.321 is amended to read as follows:

4 (1) (a) Eastern Kentucky University, Morehead State University, Murray State  
5 University, Western Kentucky University, Kentucky State University, and  
6 Northern Kentucky University~~, and the Kentucky Community and Technical~~  
7 ~~College System~~ shall each be governed by a board of regents appointed for a  
8 term set by law pursuant to Section 23 of the Constitution of Kentucky.

9 ~~(b)~~(a) Each board of the comprehensive universities ***listed in subsection (1)(a)***  
10 ***of this section*** shall consist of eight (8) members appointed by the Governor,  
11 one (1) member of the teaching faculty, one (1) member of the university  
12 nonteaching personnel, and one (1) member of the student body of the  
13 respective university ~~or college~~. The members appointed by the Governor  
14 shall be subject to confirmation by the Senate. The members of the board shall  
15 select a chairperson annually~~.~~

16 ~~(b) The board of the Kentucky Community and Technical College System shall~~  
17 ~~consist of eight (8) members appointed by the Governor, two (2) members of~~  
18 ~~the teaching faculty, two (2) members of the nonteaching personnel, and two~~  
19 ~~(2) members of the student body. The members appointed by the Governor~~  
20 ~~shall be subject to confirmation by the Senate.~~

21 ~~1. No more than three (3) appointed members of the board shall reside in any~~  
22 ~~one (1) judicial district of the Kentucky Supreme Court as of the date of the~~  
23 ~~appointment.~~

24 ~~2. A change in residency of a gubernatorial appointee after the date of~~  
25 ~~appointment shall not affect the appointee's ability to serve or eligibility for~~  
26 ~~reappointment, except an appointee who assumes residency outside the fifty~~  
27 ~~(50) United States shall become immediately ineligible to serve. The Council~~

1           ~~on Postsecondary Education shall notify the appointee of his or her~~  
2           ~~ineligibility to serve.~~

3           ~~3. In making initial appointments, the Governor shall act so as to provide equal~~  
4           ~~representation of the two (2) sexes. In filling vacancies, the Governor shall act~~  
5           ~~so as to provide, inasmuch as possible, equal representation of the two (2)~~  
6           ~~sexes by appointing a member of the sex that is the lesser represented at the~~  
7           ~~time of the appointment. If the remaining membership already has an equal~~  
8           ~~number of males and females, the Governor may appoint a member of either~~  
9           ~~sex].~~

10           ~~(c)(2)~~    The terms of appointed members shall be for six (6) years and until their  
11           successors are appointed and qualified, unless a member is removed by the  
12           Governor pursuant to KRS 63.080(2), (3), or (4)~~], except the initial~~  
13           ~~appointments to the board of regents for the Kentucky Community and~~  
14           ~~Technical College System shall be as follows:~~

15           ~~(a) One (1) member shall serve a one (1) year term;~~

16           ~~(b) One (1) member shall serve a two (2) year term;~~

17           ~~(c) Two (2) members shall serve three (3) year terms;~~

18           ~~(d) One (1) member shall serve a four (4) year term;~~

19           ~~(e) One (1) member shall serve a five (5) year term; and~~

21           ~~(d)~~    New appointees of a board~~[of regents]~~ shall not serve for more than two (2)  
22           consecutive terms.

23           ~~(e) 1.(3)~~    The gubernatorial appointments may include one (1) graduate of  
24           the respective institution who resides outside the Commonwealth.

25           ~~2. No[Not]~~    more than two (2) appointed members of any board shall be  
26           residents of one (1) county.

27           ~~3.~~    The appointments shall reflect the proportional representation of the two

1 (2) leading political parties of the Commonwealth based on the state's  
2 voter registration and the political affiliation of each appointee as of  
3 December 31 of the year preceding the date of his or her appointment. A  
4 particular political affiliation shall not be a prerequisite to appointment  
5 to any board generally; however, if any person is appointed to a board  
6 that does not represent either of the two (2) leading political parties of  
7 the Commonwealth, the proportional representation by political  
8 affiliation requirement shall be determined and satisfied based on the  
9 total number of members on the board less any members not affiliated  
10 with either of the two (2) leading political parties~~. Membership on the~~  
11 ~~board shall reflect no less than proportional representation of the~~  
12 ~~minority racial composition of the Commonwealth based on the total~~  
13 ~~minority racial population using the most recent census or estimate data~~  
14 ~~from the United States Census Bureau. If the determination of~~  
15 ~~proportional minority representation does not result in a whole number~~  
16 ~~of minority members, it shall be rounded up to the next whole number].~~

17 4. Membership on the board shall not be incompatible with any state  
18 office.

19 5. A change in residency after the date of appointment shall not affect a  
20 member's ability to serve nor shall it prevent a member's eligibility for  
21 reappointment, except a member who assumes residency outside the  
22 fifty (50) United States shall become immediately ineligible to serve.

23 6. The Council on Postsecondary Education shall notify the appointee of  
24 his or her ineligibility to serve.

25 ~~(f)(4)~~ Appointments to fill vacancies shall be made in the same manner and  
26 within the same time after the occurrence of the vacancy as regular  
27 appointments. The person appointed shall hold the position for the unexpired

1 term only.

2 ~~(g)~~~~(5)~~ Each member of the board shall serve for the term for which the  
3 member is appointed and until a successor is appointed and qualified, unless a  
4 member is removed by the Governor pursuant to KRS 63.080(2), (3), or (4).

5 ~~(h)~~~~(6)~~—~~(a)~~ The faculty member of a board~~[comprehensive university]~~ shall be  
6 a teaching or research member of the faculty of his or her respective  
7 university of the rank of assistant professor or above. The faculty member  
8 shall be elected by secret ballot by all faculty members of his or her university  
9 of the rank of instructor, assistant professor, or above. The faculty member  
10 shall serve for a term of three (3) years and until his successor is elected and  
11 qualified. The faculty member shall be eligible for reelection, but he or she  
12 shall not be eligible to continue to serve as a member of the board if he or she  
13 ceases being a member of the teaching staff of the university. Elections to fill  
14 vacancies shall be for the unexpired term in the same manner as provided for  
15 the original election[-

16 ~~(b) The faculty members of the Kentucky Community and Technical College~~  
17 ~~System shall be represented by one (1) faculty member elected from the~~  
18 ~~community colleges and one (1) faculty member elected from the technical~~  
19 ~~institutions to serve three (3) year terms and until their successors are named.~~  
20 ~~The faculty representative of each branch shall be elected by means of a~~  
21 ~~process established by the board. The faculty members may be reelected but~~  
22 ~~shall not serve more than two (2) consecutive terms. A faculty member shall~~  
23 ~~be ineligible to continue to serve as a member of the board if he or she ceases~~  
24 ~~to be a member of the faculty at one (1) of the institutions within the system.~~  
25 ~~Elections to fill vacancies shall be for the unexpired term in the same manner~~  
26 ~~as provided for the original election. These two (2) members shall collectively~~  
27 ~~have one (1) vote which may be cast one half (1/2) vote by each member].~~

1        ~~(i)~~<sup>(7)</sup> ~~— (a)~~ The nonteaching personnel member of a board ~~in a comprehensive~~  
2        ~~university~~ shall be any full-time staff member, excluding the president, vice  
3        presidents, academic deans, and academic department chairpersons. He or she shall  
4        represent all nonteaching university employees including ~~but not limited to~~  
5        building facilities and clerical personnel. The member shall be elected by secret  
6        ballot by the nonteaching employees. The nonteaching personnel member shall serve  
7        a term of three (3) years and until a successor is elected and qualified. The  
8        nonteaching personnel member shall be eligible for reelection, but he or she shall not  
9        be eligible to continue to serve as a member of the board if he or she ceases being an  
10       employee of the university. Elections to fill vacancies shall be for the unexpired  
11       term in the same manner as provided for the original election.

 5 student member does not maintain the position as student body president or the status  
 6 as a full-time student at any time during that academic year, a special election shall  
 7 be held to select a full-time student member. The elected student member shall serve  
 8 for the remainder of the unexpired term].

9 ~~(b) Two (2) full-time student members shall be elected to the board of regents for~~  
 10 ~~the Kentucky Community and Technical College System. One (1) shall~~  
 11 ~~represent students of the community colleges and one (1) shall represent the~~  
 12 ~~technical institutions. The student members shall be elected by means of a~~  
 13 ~~process established by the board. The student members shall serve one (1)~~  
 14 ~~year terms beginning on July 1 after being elected and sworn in as a student~~  
 15 ~~member of the board and ending on the following June 30. If the student~~  
 16 ~~member does not maintain the status as a full-time student, a special election~~

 21 complete an orientation and education program prescribed by the council  
 22 under KRS 164.020(24)] as a condition of their service and eligibility for  
 23 appointment or election to a second term.

24 ~~(l)(10)~~ Board members may be removed by the Governor under the following  
 25 circumstances:

26 ~~1.(a)~~ For cause, pursuant to KRS 63.080(2); or

27 ~~2.(b)~~ Pursuant to KRS 63.080(3) or (4).

1        ~~(m)(11)~~ The inability of ~~a~~the board ~~or boards of the comprehensive~~  
 2        ~~universities or Kentucky Community and Technical College System~~ to hold  
 3        quarterly meetings, to elect a chairperson annually, to establish a quorum, to  
 4        adopt an annual budget, to set tuition rates, to conduct an annual evaluation of  
 5        the president of the university ~~or system~~, to carry out its primary function to  
 6        periodically evaluate the university's ~~or system's~~ progress in implementing  
 7        its mission, goals, and objectives to conform to the strategic agenda, or to  
 8        otherwise perform its duties under KRS 164.350 shall be cause for the  
 9        Governor to remove all appointed members of the board ~~or boards~~ and

11       **(2) (a) The Kentucky Community and Technical College System shall be governed**  
 12       **by a board of regents appointed for a term set by law pursuant to Section 93**  
 13       **of the Constitution of Kentucky.**

14       **(b) 1. Beginning on October 1, 2026, the board of the Kentucky Community**  
 15       **and Technical College System shall consist of the following seventeen**  
 16       **(17) members:**

17       **a. Fourteen (14) members appointed by the Governor, as follows:**

18       **i. One (1) member selected from a list of three (3) names**  
 19       **submitted by the Kentucky Association of School**  
 20       **Administrators;**

21       **ii. One (1) member selected from a list of three (3) names**  
 22       **submitted by the Kentucky Association of Manufacturers;**

23       **iii. One (1) member selected from a list of three (3) names**  
 24       **submitted by the Associated General Contractors of**  
 25       **Kentucky;**

26       **iv. One (1) member selected from a list of three (3) names**  
 27       **submitted by the Kentucky Hospital Association;**

- 1                    v. One (1) member selected from a list of three (3) names  
2                    submitted by the Kentucky Association for Economic  
3                    Development;
- 4                    vi. One (1) member selected from a list of three (3) names  
5                    submitted by the Energy Planning and Inventory  
6                    Commission established in KRS 164.2807; and
- 7                    vii. Eight (8) members appointed from the state at large; and
- 8                    b. Three (3) members elected in accordance with subsection (2)(h)  
9                    of this section, as follows:
- 10                   i. One (1) member of the KCTCS teaching faculty;  
11                   ii. One (1) member of the KCTCS nonteaching personnel;  
12                   and
- 13                   iii. One (1) member of the KCTCS student body.
- 14                   2. The members appointed by the Governor shall be subject to  
15                   confirmation by the Senate.
- 16                   3. The members of the board shall select a chairperson annually.
- 17                   (c) The terms of appointed board members shall be for four (4) years and until  
18                   their successors are appointed and qualified, unless a member is removed  
19                   by the Governor pursuant to KRS 63.080(2), (3), or (4).
- 20                   (d) New appointees of the board shall not serve for more than two (2)  
21                   consecutive terms.
- 22                   (e) 1. No more than one (1) appointed member of the board shall be a  
23                   resident of one (1) county.
- 24                   2. No more than two (2) appointed members of the board shall reside in  
25                   any one (1) judicial district of the Kentucky Supreme Court as of the  
26                   date of the appointment.
- 27                   3. The appointments to the board shall reflect the proportional

1 representation of the two (2) leading political parties of the  
2 Commonwealth based on the state's voter registration and the political  
3 affiliation of each appointee as of December 31 of the year preceding  
4 the date of his or her appointment. A particular political affiliation  
5 shall not be a prerequisite to appointment to the board generally;  
6 however, if any person is appointed to the board that does not  
7 represent either of the two (2) leading political parties of the  
8 Commonwealth, the proportional representation by political affiliation  
9 requirement shall be determined and satisfied based on the total  
10 number of members on the board less any members not affiliated with  
11 either of the two (2) leading political parties.

12 4. Membership on the board shall not be incompatible with any state  
13 office.

14 5. a. A change in residency after the date of appointment shall not  
15 affect a member's ability to serve, except that a member who  
16 assumes residency:

17 i. Outside the fifty (50) United States shall become  
18 immediately ineligible to serve; and

19 ii. That places the board in violation of the requirements of  
20 subparagraphs 1. and 2. of this paragraph shall become  
21 immediately ineligible to serve.

22 b. The Council on Postsecondary Education shall notify the  
23 appointee of his or her ineligibility to serve.

24 6. No appointed member of the board shall have a conflict of interest in  
25 accordance with KRS 45A.340 or be a relative of any employee of the  
26 system.

27 (f) Appointments to fill vacancies shall be made in the same manner and

1 within the same time after the occurrence of the vacancy as regular  
2 appointments. The person appointed shall hold the position for the  
3 unexpired term only.

4 (g) Each member of the board shall serve for the term for which the member is  
5 appointed and until a successor is appointed and qualified, unless a member  
6 is removed by the Governor pursuant to KRS 63.080(2), (3), or (4).

7 (h) Members elected to the board shall be as follows:

8 1. The teaching faculty member of the board shall be a teaching member  
9 of the faculty of the KCTCS. The faculty member shall be elected by  
10 secret ballot by all regular full-time faculty members of the KCTCS.  
11 The faculty member shall serve for a term of three (3) years and until  
12 a successor is elected and qualified. The faculty member shall be  
13 eligible for reelection, but he or she shall not be eligible to continue to  
14 serve as a member of the board if he or she ceases being a member of  
15 the teaching faculty of the KCTCS. Elections to fill vacancies shall be  
16 for the unexpired term in the same manner as provided for the  
17 original election;

18 2. The nonteaching personnel member of the board shall be any full-  
19 time staff member, excluding the president, chancellor, provost, vice  
20 presidents, academic deans, academic department chairpersons, and  
21 any other administrator who supervises two (2) or more employees and  
22 reports directly to the president or chancellor. He or she shall  
23 represent all nonteaching employees of the KCTCS, including but not  
24 limited to building facilities and clerical personnel. The member shall  
25 be elected by secret ballot by the nonteaching employees. The  
26 nonteaching personnel member shall serve a term of three (3) years  
27 and until a successor is elected and qualified. The nonteaching

1 personnel member shall be eligible for reelection, but he or she shall  
2 not be eligible to continue to serve as a member of the board if he or  
3 she ceases being an employee of the KCTCS. Elections to fill  
4 vacancies shall be for the unexpired term in the same manner as  
5 provided for the original election; and

6 3. The student body member of the board shall be elected by means of a  
7 process established by the board. The student member shall serve a  
8 one (1) year term beginning on July 1 after being elected and sworn in  
9 as the student body member of the board and ending on the following  
10 June 30. If the student member does not maintain status as a full-time  
11 student, a special election shall be held to fill the vacancy for the  
12 remainder of the unexpired term.

13 (i) All appointed and elected board members shall be required to attend and  
14 complete an orientation and education program prescribed by the council  
15 under KRS 164.020(24) as a condition of their service and eligibility for  
16 appointment or election to a second term.

17 (j) Board members may be removed by the Governor under the following  
18 circumstances:

19 1. For cause, pursuant to KRS 63.080(2);

20 2. Pursuant to KRS 63.080(3) or (4); or

21 3. Upon the request of the president or chairman of the board after the  
22 member has failed to attend three (3) consecutive regularly scheduled  
23 meetings, which shall be considered gross neglect of duty pursuant to  
24 KRS 63.080(2)(d).

25 (k) The inability of the board to hold quarterly meetings, to elect a chairperson  
26 annually, to establish a quorum, to adopt an annual budget, to set tuition  
27 rates, to conduct an annual evaluation of the president of the system, to

1           carry out its primary function, to periodically evaluate the system's progress  
 2           in implementing its mission, goals, and objectives to conform to the strategic  
 3           agenda, or to otherwise perform its duties under Section 2 of this Act shall  
 4           be cause for the Governor to remove all appointed members of the board  
 5           and replace the entire appointed membership pursuant to KRS 63.080(4).

6           ➔Section 2. KRS 164.350 is amended to read as follows:

- 7           (1) The government of each of the state universities and the Kentucky Community and  
 8           Technical College System is vested in its respective board of regents. Each board ~~of~~  
 9           ~~of regents~~, when its members have been appointed and qualified, shall constitute a  
 10           body corporate, with the usual corporate powers, and with all immunities, rights,  
 11           privileges, and franchises usually attaching to the governing bodies of educational  
 12           institutions. Each board may:
- 13           (a) Receive grants of money and expend the same for the use and benefit of the  
 14           university or college;
- 15           (b) Require such reports from the president, officers, faculty, and employees as it  
 16           deems necessary and proper from time to time;
- 17           (c) Determine the number of divisions, departments, bureaus, offices, and  
 18           agencies needed for the successful conduct of the affairs of the university or  
 19           college; and
- 20           (d) Grant diplomas and confer degrees upon the recommendation of the president  
 21           and faculty.
- 22           (2) Each board shall adopt bylaws, rules, and regulations for the governance of its  
 23           members, officers, agents, and employees, which shall reference the member  
 24           removal and replacement provisions of KRS 63.080, and the board shall enforce  
 25           obedience to such bylaws, rules, and regulations.
- 26           (3) Each board ~~of regents~~ shall periodically evaluate the institution's progress in  
 27           implementing its missions, goals, and objectives to conform to the adopted strategic

1 agenda. Officers and officials shall be held accountable for the status of the  
2 institution's progress.

3 (4) (a) In addition to the duties required in subsections (1), (2), and (3) of this  
4 section, the board~~[of regents]~~ for the Kentucky Community and Technical  
5 College System, upon recommendation of the president of the system, shall:

6 1. ~~[(a) Develop and implement guidelines for the preparation of biennial  
7 budget requests by the administrators of the colleges within the system.  
8 The guidelines shall define the processes for review and approval by the  
9 boards of directors for the colleges;~~

10 ~~(b) Adopt a]~~ Review the president's biennial budget request for the  
11 Kentucky Community and Technical College System~~[ upon the  
12 recommendation of the president of the system;~~

13 ~~(c) Adopt an allocation process for distributing funds to the colleges within  
14 the system;~~

15 ~~(d) Consider recommendations from the boards of directors of the colleges  
16 to improve the overall budget planning and allocation processes];~~

17 2.~~[(e)]~~ Designate each college with a name;

18 3.~~[(f)]~~ Encourage and accept donations of land and funds to be used in  
19 the acquisition, construction, or operations of colleges in the system.  
20 The board may commemorate donations from private persons or  
21 corporations with suitable memorials;~~[ and]~~

22 4.~~[(g)]~~ Accept federal grants when deemed appropriate to be used in the  
23 acquisition, construction, or operations of colleges in the system;~~[-]~~

24 5. Review~~[The board of regents shall ensure that]~~ the budget planning and  
25 implementation processes to ensure consistency~~[are consistent]~~ with the  
26 adopted strategic agenda and biennial budget and with the missions of  
27 the colleges~~[institutions]~~ within the system; and

1        *(b) Notwithstanding the recommendation of the president of the system, the*  
2        *board of regents shall adopt policy specifying the minimum qualifications of*  
3        *the president of the system and the chancellors of the colleges, which shall*  
4        *be the same.*

5        ➔Section 3. KRS 164.365 is amended to read as follows:

6        ~~{(1) }~~Anything in any statute of the Commonwealth to the contrary notwithstanding, the  
7        power over and control of appointments, qualifications, salaries, and compensation  
8        payable out of the State Treasury or otherwise, promotions, and official relations of all  
9        employees of Eastern Kentucky University, Western Kentucky University, Murray State  
10        University, Northern Kentucky University, and Morehead State University, as provided  
11        in KRS 164.350 and 164.360, and of Kentucky State University and the Kentucky  
12        Community and Technical College System, shall be under the exclusive jurisdiction of  
13        the respective governing boards of each of the institutions named~~[-~~

14        ~~(2) The board of regents for the Kentucky Community and Technical College System~~  
15        ~~shall develop personnel rules for the governing of its members, officers, agents, and~~  
16        ~~employees by June 30, 1998. The board shall adopt interim policies to govern~~  
17        ~~employees hired from July 1, 1997, until the permanent rules are adopted.~~

18        ~~(3) Upon receipt of a written authorization from an employee of the Kentucky~~  
19        ~~Community and Technical College System, the board shall deduct dues from the~~  
20        ~~employee's paycheck for employee membership organizations, except that no~~  
21        ~~deduction shall be made for labor organization membership dues, fees, assessments,~~

2       ➔Section 4. KRS 164.580 is amended to read as follows:

- 3       (1) The Kentucky Community and Technical College System is established and~~[-The~~  
4       ~~Kentucky Community and Technical College System]~~ shall provide:
- 5       (a) A general two (2) year academic curriculum with credits transferable to two  
6       (2) year and four (4) year colleges and universities;
- 7       (b) Technical and semiprofessional programs of two (2) years or less;
- 8       (c) Within a two (2) year college curriculum, courses in general education,  
9       including adult education, not necessarily intended for transfer nor technically  
10       oriented; and
- 11       (d) Services to Kentucky's employers and the general public to provide  
12       continuing education and customized training for purposes of improving the  
13       knowledge and skills of Kentucky workers and citizens in all regions of the  
14       state.
- 15       (2) The KCTCS~~[Kentucky Community and Technical College System]~~ shall be  
16       responsive to the needs of students and employers in all regions of the

- 4 (1) "Advisory committee" means the Kentucky Aerospace, Aviation, and Defense  
5 Investment Fund Advisory Committee established in KRS 164.7013;
- 6 (2) "Aviation" means the operation, maintenance, or manufacturing of aircraft or other  
7 aerospace equipment, aerospace initiatives and efforts, and defense-related products  
8 related to aerospace and aviation;
- 9 (3) "Aviation industry partner" means a grantor to the fund that the council determines  
10 customarily employs individuals with an eligible aviation or aerospace credential in  
11 a relevant aviation role in the usual course of the grantor's business;
- 12 (4) "Aviation program":
- 13 (a) Means an education or training program located in Kentucky that issues  
14 eligible aviation or aerospace credentials or is a specific requirement to  
15 earning an eligible aviation or aerospace credential, including but not limited  
16 to a public high school vocational program; and
- 17 (b) Notwithstanding paragraph (a) of this subsection, does not include a flight  
18 training program unless that program is a certified pilot school regulated by  
19 the Federal Aviation Administration in accordance with 14 C.F.R. pt. 141, *a*  
20 *certified public postsecondary pilot school regulated by the Federal Aviation*  
21 *Administration in accordance with 14 C.F.R. pt. 61,* or is a public high  
22 school vocational program;
- 23 (5) "Council" means the Council on Postsecondary Education;
- 24 (6) "Dedicated moneys" means a gift, grant, or donation to the fund that is subject to  
25 restrictions imposed by a private grantor under KRS 164.7015;
- 26 (7) "Eligible aviation credential" means:
- 27 (a) Any license or certification issued by the Federal Aviation Administration;

- 1 (b) A Bachelor of Science in aviation issued by a postsecondary education  
2 institution overseen or licensed by the council and located in Kentucky;
- 3 (c) Any engineering degree issued by a postsecondary education institution  
4 overseen or licensed by the council and located in Kentucky; or
- 5 (d) A career and technical education license or certification determined by the  
6 council, in collaboration with the advisory committee, to be in high demand  
7 and relevant to the aerospace industry;
- 8 (8) "Fund" means the Kentucky aerospace, aviation, and defense investment fund  
9 established in KRS 164.7013;
- 10 (9) "Grantor" means an individual or an entity that gifts, grants, or donates moneys to  
11 the fund;
- 12 (10) "Immediate family" means an individual's parents, siblings, spouse, and children;
- 13 (11) "Kentucky resident" means a Kentucky resident as defined by the council pursuant  
14 to KRS 164.020(8); and
- 15 (12) "Public aviation program" is an aviation program that is a public high school  
16 vocational program or institution that is a member of Kentucky's public  
17 postsecondary education system.

24 ➔Section 14. (1) Notwithstanding subsection (2)(c) of Section 1 of this Act,  
25 initial appointments to the board of regents of the Kentucky Community and Technical  
26 College System under subsection (2)(b)1.a.i. to vi. of Section 1 of this Act shall be as  
27 follows:

1 (a) One member shall serve a one-year term;

2 (b) One member shall serve a two-year term;

3 (c) Two members shall serve a three-year term; and

4 (d) Two members shall serve a four-year term.

5 (2) Upon the expiration of the initial appointments under subsection (1) of this  
6 section, members shall be appointed under subsection (2)(b)1.a.i. to vi. of Section 1 of
