

1 AN ACT relating to scholarships.

2 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

3 ➔Section 1. KRS 164.7879 is amended to read as follows:

4 (1) (a) Kentucky educational excellence scholarship awards shall be based upon an
5 established base scholarship amount and an eligible high school student's grade
6 point average. ***Beginning with the 2026-2027 academic year,*** the base scholarship
7 amount for students attaining a grade point average of at least 2.5 for ~~an~~~~the 1998-~~
8 ~~1999~~ academic year shall be as follows:

23 ***(b) The base amount of the Kentucky educational excellence scholarship:***

24 ***1. Shall be annually adjusted by the authority based on the most recent***
25 ***percent increase in the nonseasonally adjusted annual average***
26 ***Consumer Price Index for All Urban Consumers (CPI-U), U.S. City***
27 ***Average, All Items, between the two (2) most recent calendar years***

available, as published by the United States Bureau of Labor Statistics
by administrative regulation, subject to the availability of funds,
beginning with grade point averages attained in the 2018-2019
academic year and each academic year thereafter;

2. May increase, but shall not be decreased;

3. Shall be paid at the most recent amount calculated for the academic
term in which a student utilizes his or her award;

4. Shall be provided at the adjusted amount identified in subparagraph 1.
of this paragraph for eligible high school students who graduated
prior to the 2021-2022 academic year and have received an eligibility
extension by the authority pursuant to subsection (5) of Section 3 of
this Act; and

5. Shall not be made available for retroactive payments due to an award
amount adjustment, pursuant to subparagraph 1. of this paragraph,
for prior academic terms.

(2) (a) The authority shall commit to provide to each eligible high school student the base amount of the Kentucky educational excellence scholarship for each academic year of high school study in the Kentucky educational excellence scholarship curriculum that the high school student has attained at least a 2.5 grade point average. The award shall be based upon the eligible high school student's grade point average at the close of each academic year, including any. ~~An award attributable to a past academic year shall not be increased after the award has been earned by an eligible high school student, regardless of any subsequent increases made to the base amount of the Kentucky educational excellence scholarship through the promulgation of an administrative regulation by the authority~~ in accordance with subsection (1)(b) of this section.

1 (b) Notwithstanding the definitions of "eligible high school student" and "high
2 school" in KRS 164.7874, any high school student who maintains Kentucky
3 residency and completes the academic courses that are required for a
4 Kentucky educational excellence scholarship while participating in an
5 approved educational high school foreign exchange program or participating
6 in the United States Congressional Page School may apply his or her grade
7 point average for that academic year toward the base as described in
8 paragraph (a) of this subsection. The grade point average shall be reported by
9 the student's Kentucky home high school, based on an official transcript from
10 the school that the student attended during the out-of-state educational
11 experience. The authority shall promulgate administrative regulations that
12 describe the approval process for the educational exchange programs that
13 qualify under this paragraph. The provisions in this paragraph shall likewise
14 apply to any Kentucky high school student who participated in an approved
15 educational exchange program or in a Congressional Page School~~[-since the~~
16 ~~1998-99 school year]~~ and maintained his or her Kentucky residency
17 throughout.

18 (c) 1. Notwithstanding the definitions of "eligible high school student" and
19 "high school" in KRS 164.7874 and the requirement that a student
20 graduate from a Kentucky high school, a high school student who
21 completes the KEES curriculum while attending an accredited out-of-
22 state high school or Department of Defense school may apply the grade
23 point average for any applicable academic year toward the base as
24 described in paragraph (a) of this subsection and shall also qualify for a
25 supplemental award under subsection (3) of this section when:

- 26 a. His or her custodial parent or guardian is in active service of the
27 Armed Forces of the United States;

- 1 b. The student attended an accredited out-of-state high school or a
2 Department of Defense school as a result of the custodial parent's
3 or guardian's military transfer outside of Kentucky; and
- 4 c. The student earned a KEES base amount at a Kentucky high
5 school prior to the custodial parent's or guardian's military transfer
6 outside of Kentucky.
- 7 2. The student or parent shall arrange for the out-of-state school to report
8 the student's grade point average each academic year and the student's
9 highest ACT score to the authority as required under KRS 164.7885.
10 The authority shall promulgate administrative regulations implementing
11 the requirements in this paragraph, including:
- 12 a. The documentation that the parent shall submit to the authority
13 establishing the student's eligibility for the scholarship; and
- 14 b. The assurances that an out-of-state institution shall submit to the
15 authority for submission of the student grade point average.

- 18 (d) ~~[Beginning with the 2013-2014 academic year,]~~ A student who meets the
19 Kentucky core academic standards for high school graduation established in

21 high school shall receive a Kentucky educational excellence scholarship
22 award equivalent to completing high school in four (4) years. The award shall
23 be determined by dividing the total actual KEES scholarship earned under
24 subsection (1) of this section by three (3) and multiplying that number by four
25 (4). The resulting number shall be the annual award the student is eligible for
26 under subsection (1) of this section.

11 commit to provide a supplemental award for achievement on examinations for
12 Advanced Placement or International Baccalaureate as defined in KRS
13 164.002 to an eligible high school student whose family was eligible for free
14 or reduced-price lunch for any year during high school enrollment.

- 15 1. The supplemental award for AP examination scores are as follows:
 - 16 a. Two hundred dollars (\$200) for each score of three (3);
 - 17 b. Two hundred fifty dollars (\$250) for each score of four (4); and
 - 18 c. Three hundred dollars (\$300) for each score of five (5).
- 19 2. The supplemental award for IB examination scores are as follows:
 - 20 a. Two hundred dollars (\$200) for each score of five (5);
 - 21 b. Two hundred fifty dollars (\$250) for each score of six (6); and
 - 22 c. Three hundred dollars (\$300) for each score of seven (7).

23 ~~(c)(d)~~ ~~[Beginning with the 2013-2014 academic year,]~~The authority shall
24 commit to provide a supplemental award for achievement on examinations for
25 Cambridge Advanced International as defined in KRS 164.002 to an eligible
26 high school student whose family was eligible for free or reduced-priced
27 lunch for any year during high school enrollment. The supplemental award for

Cambridge Advanced International examination scores are as follows:

1. Two hundred dollars (\$200) for each score of "e";
2. Two hundred fifty dollars (\$250) for each score of "c" or "d"; and
3. Three hundred dollars (\$300) for each score of "a*", "a", or "b".

~~(d)~~~~(e)~~ The authority shall promulgate administrative regulations establishing the eligibility criteria and procedures for making a supplemental award to Kentucky residents who are citizens, nationals, or permanent residents of the United States and who graduate from a nonpublic secondary school not certified by the Kentucky Board of Education and Kentucky residents who are citizens, nationals, or permanent residents of the United States and who obtain a High School Equivalency Diploma within five (5) years of their high school graduating class, and students under subsection (2)(c) of this section who do not attend an accredited high school.

(e) *Beginning with the 2026-2027 academic year, the base amount of the supplemental awards in paragraphs (a) to (c) of this subsection:*

1. *May be annually adjusted by the authority based on the most recent percent increase in the nonseasonally adjusted annual average Consumer Price Index for All Urban Consumers (CPI-U), U.S. City Average, All Items, between the two (2) most recent calendar years available, as published by the United States Bureau of Labor Statistics by administrative regulation, subject to the availability of funds, beginning with examination scores attained in the 2018-2019 academic year and each academic year thereafter;*
2. *May be increased, but shall not be decreased;*
3. *Shall be paid at the most recent amount calculated for the academic term in which a student utilizes his or her award;*
4. *Shall be provided at the adjusted amount identified in subparagraph 1.*

1 of this paragraph for eligible high school students who graduated

8 ➔Section 2. KRS 164.7874 is amended to read as follows:

9 As used in KRS 164.7871 to 164.7885:

- 10 (1) "Academic term" means a semester or other time period specified in an
11 administrative regulation promulgated by the authority;
- 12 (2) "Academic year" means a period consisting of at least the minimum school term, as
13 defined in KRS 158.070;
- 14 (3) "ACT score" means the composite score achieved on the American College Test at
15 a national test site on a national test date or the college admissions examination
16 administered statewide under KRS 158.6453(5)(b)5. if the exam is the ACT, or an
17 equivalent score, as determined by the authority, on the SAT administered by the
18 College Board, Inc.;
- 19 (4) "Authority" means the Kentucky Higher Education Assistance Authority;
- 20 (5) "Award period" means the fall and spring consecutive academic terms within one
21 (1) academic year;
- 22 (6) "Council" means the Council on Postsecondary Education created under KRS
23 164.011;
- 24 (7) "Eligible high school student" means any person who:
- 25 (a) Is a citizen, national, or permanent resident of the United States and Kentucky
26 resident;
- 27 (b) Was enrolled after July 1, 1998:

- 1 1. In a Kentucky high school for at least one hundred forty (140) days of
2 the minimum school term unless exempted by the authority's executive
3 director upon documentation of extreme hardship, while meeting the
4 KEES curriculum requirements, and was enrolled in a Kentucky high
5 school at the end of the academic year;
- 6 2. In a Kentucky high school for the fall academic term of the senior year
7 and who:
 - 8 a. Was enrolled during the entire academic term;
 - 9 b. Completed the high school's graduation requirements during the
10 fall academic term; and
 - 11 c. Was not enrolled in a secondary school during any other academic
12 term of that academic year; or
- 13 3. In the Gatton Academy of Mathematics and Science in Kentucky, the
14 Craft Academy for Excellence in Science and Mathematics, or in high
15 school at a model and practice school under KRS 164.380 while meeting
16 the Kentucky educational excellence scholarship curriculum
17 requirements;
- 18 (c) Has a grade point average of 2.5 or above at the end of any academic year
19 beginning after July 1, 1998, or at the end of the fall academic term for a
20 student eligible under paragraph (b)2.~~[(b) 2.]~~ of this subsection; and
- 21 (d) Is not a convicted felon;
- 22 (8) "Eligible postsecondary student" means a citizen, national, or permanent resident of
23 the United States and Kentucky resident, as determined by the participating
24 institution in accordance with criteria established by the council for the purposes of
25 admission and tuition assessment, who:
 - 26 (a) Earned a KEES award;
 - 27 (b) Has the required postsecondary GPA and credit hours required under KRS

1 164.7881;

2 (c) Has remaining semesters of eligibility under KRS 164.7881;

3 (d) Is enrolled in a participating institution as a part-time or full-time student; and

4 (e) Is not a convicted felon;

5 (9) "Full-time student" means a student enrolled in a postsecondary program of study
6 that meets the full-time student requirements of the participating institution in
7 which the student is enrolled;

8 (10) "Grade point average" or "GPA" means the grade point average earned by an
9 eligible student and reported by the high school or participating institution in which
10 the student was enrolled based on a scale of 4.0 or its equivalent if the high school
11 or participating institution that the student attends does not use the 4.0 grade scale;

12 (11) "High school" means any Kentucky public high school, the Gatton Academy of
13 Mathematics and Science in Kentucky, the Craft Academy for Excellence in
14 Science and Mathematics, a high school of a model and practice school under KRS
15 164.380, and any private, parochial, or church school located in Kentucky that has
16 been certified by the Kentucky Board of Education as voluntarily complying with
17 curriculum, certification, and textbook standards established by the Kentucky Board
18 of Education under KRS 156.160;

19 (12) "KEES" or "Kentucky educational excellence scholarship" means a scholarship
20 provided under KRS 164.7871 to 164.7885;

21 (13) "KEES award" means:

22 (a) For an eligible high school student, the sum of the KEES base amount for
23 each academic year of high school plus any KEES supplemental amount, as
24 adjusted pursuant to KRS 164.7881; and

25 (b) For a student eligible under KRS 164.7879(3)(~~d~~)(~~e~~), the KEES supplemental
26 amount as adjusted pursuant to KRS 164.7881;

27 (14) "KEES award maximum" means the sum of the KEES base amount earned in each

- 1 academic year of high school plus any KEES supplemental amount earned;
- 2 (15) "KEES base amount" or "base amount" means the amount earned by an eligible
3 high school student based on the student's GPA pursuant to KRS 164.7879;
- 4 (16) "KEES curriculum" means five (5) courses of study, except for students who meet
5 the criteria of subsection (7)(b)2. of this section, in an academic year as determined
6 in accordance with an administrative regulation promulgated by the authority;
- 7 (17) "KEES supplemental amount" means the amount earned by an eligible student
8 based on the student's ACT score pursuant to KRS 164.7879;
- 9 (18) "KEES trust fund" means the Wallace G. Wilkinson Kentucky educational
10 excellence scholarship trust fund;
- 11 (19) "On track to graduate" means the number of cumulative credit hours earned as
12 compared to the number of hours determined by the postsecondary education
13 institution as necessary to complete a bachelor's degree by the end of eight (8)
14 academic terms or ten (10) academic terms if a student is enrolled in an
15 undergraduate program that requires five (5) years of study;
- 16 (20) "Participating institution" means an "institution" as defined in KRS 164.001 that is
17 eligible to participate in the federal Pell Grant program, executes a contract with the
18 authority on terms the authority deems necessary or appropriate for the
19 administration of its programs, and:
- 20 (a) 1. Is publicly operated;
- 21 2. Is licensed by the Commonwealth of Kentucky and has operated for at
22 least ten (10) years, offers an associate or baccalaureate degree program
23 of study not comprised solely of sectarian instruction, and admits as
24 regular students only high school graduates, recipients of a High School
25 Equivalency Diploma, or students transferring from another accredited
26 degree granting institution; or
- 27 3. Is designated by the authority as an approved out-of-state institution that

1 offers a degree program in a field of study that is not offered at any
2 institution in the Commonwealth; and

3 (b) Continues to commit financial resources to student financial assistance
4 programs; and

5 (21) "Part-time student" means a student enrolled in a postsecondary program of study
6 who does not meet the full-time student requirements of the participating institution
7 in which the student is enrolled and who is enrolled for at least six (6) credit hours,
8 or the equivalent for an institution that does not use credit hours.

9 ➔Section 3. KRS 164.7881 is amended to read as follows:

10 (1) Eligible high school students who have graduated from high school and eligible
11 postsecondary students who have earned a Kentucky educational excellence
12 scholarship, a Kentucky educational excellence scholarship and a supplemental
13 award, or a supplemental award only pursuant to KRS 164.7879(3)(d)(~~e~~), shall be
14 eligible to receive the Kentucky educational excellence scholarship, the Kentucky
15 educational excellence scholarship and the supplemental award, or a supplemental
16 award only for a maximum of eight (8) academic terms in an undergraduate or other
17 postsecondary program of study at a participating institution, except as provided in
18 subsections (5) and (6) of this section.

19 (2) To receive the Kentucky educational excellence scholarship, a Kentucky
20 educational excellence scholarship and supplemental award, or a supplemental
21 award only, an eligible high school or postsecondary student shall:

22 (a) Enroll in and attend a participating institution as a full-time student or a part-
23 time student; and

24 (b) Maintain eligibility as provided in subsection (3) of this section.

25 (3) Eligibility for a Kentucky educational excellence scholarship or a Kentucky
26 educational excellence scholarship and supplemental award shall terminate upon
27 the earlier of:

- 1 (a) The expiration of five (5) years following the student's graduation from high
2 school, except as provided in subsection (5) or (6) of this section; or
- 3 (b) The successful completion of an undergraduate or other postsecondary course
4 of study. However, any student who successfully completes the requirements
5 for a degree or certification involving a postsecondary course of study that
6 normally requires less than eight (8) academic terms to complete may
7 continue to receive the benefits of a Kentucky educational excellence
8 scholarship, a Kentucky educational excellence scholarship and supplemental
9 award, or a supplemental award only, for a cumulative total of eight (8)
10 academic terms if the student enrolls as at least a part-time student in a four
11 (4) year program.
- 12 (4) (a) The maximum award amount shall be determined by the authority and shall
13 be adjusted as provided in this subsection. The award amount ultimately
14 determined to be available to an eligible postsecondary student for an award
15 period shall be delivered by the authority to the participating institution for
16 disbursement to the eligible postsecondary student.
- 17 (b) The authority shall, by promulgation of administrative regulations, provide for
18 the proportionate reduction of the maximum award amount for an eligible
19 postsecondary student for any academic term in which the student is enrolled
20 on a part-time basis. Each academic term for which any scholarship or
21 supplemental award funds are accepted by an eligible postsecondary student
22 shall count as a full academic term, even if the award amount was reduced to
23 reflect the part-time status of the eligible postsecondary student, except if the
24 eligible postsecondary student interrupts enrollment during the award period
25 for any reason specified in subsection (5) of this section, and the participating
26 institution does not certify a cumulative grade point average for that student at
27 the end of that award period.

- 1 (c) 1. An eligible postsecondary student who is enrolled full-time in an
2 undergraduate program of study, in the pharmacy program at the
3 University of Kentucky, or in a program of study designated as an
4 equivalent undergraduate program of study by the authority in an
5 administrative regulation, shall receive the maximum award amount for
6 the first award period that the student is enrolled in and attending the
7 program of study.
- 8 2. To retain the maximum award for the second award period, an eligible
9 postsecondary student shall have at least a 2.5 grade point average at the
10 end of the first award period. If the eligible postsecondary student
11 interrupts enrollment during the award period for any reason specified in
12 subsection (5) of this section, and the participating institution does not
13 certify a cumulative grade point average for that student at the end of
14 that award period, the eligible postsecondary student shall, subject to
15 paragraph (b) of this subsection, retain the maximum award for the
16 award period in which he or she resumes enrollment.
- 17 3. To retain the maximum award amount for subsequent award periods, an
18 eligible postsecondary student shall have:
- 19 a. A cumulative grade point average of 3.0 or greater at the end of
20 the prior award period. If the eligible postsecondary student
21 interrupts enrollment during the award period for any reason
22 specified in subsection (5) of this section, and the participating
23 institution does not certify a cumulative grade point average for
24 that student at the end of that award period, the eligible
25 postsecondary student shall, subject to paragraph (b) of this
26 subsection, retain the same award for the award period in which he
27 or she resumes enrollment as he or she received in the award

- 1 period in which enrollment was interrupted; or
- 2 b. A cumulative grade point average of 2.5 or greater but less than
- 3 3.0 at the end of the prior award period and be on track to
- 4 graduate. If the eligible postsecondary student interrupts
- 5 enrollment during the award period for any reason specified in
- 6 subsection (5) of this section, and the participating institution does
- 7 not certify a cumulative grade point average for that student at the
- 8 end of that award period, the eligible postsecondary student shall,
- 9 subject to paragraph (b) of this subsection, retain the same award
- 10 for the award period in which he or she resumes enrollment as he
- 11 or she received in the award period in which enrollment was
- 12 interrupted.
- 13 4. Any eligible full-time postsecondary student who maintains a
- 14 cumulative grade point average of less than 3.0 but at least 2.5 but is not
- 15 on track to graduate at the completion of any award period shall receive
- 16 a reduction in the maximum award amount equal to fifty percent (50%)
- 17 of the maximum award amount for the next award period.
- 18 5. Any eligible postsecondary student who maintains a cumulative grade
- 19 point average of less than 2.5 at the completion of any award period
- 20 shall lose his or her award for the next award period.
- 21 6. a. Each participating institution shall certify to the authority at the
- 22 close of each award period the cumulative grade point average of
- 23 each Kentucky educational excellence scholarship recipient
- 24 enrolled as a full-time or part-time student at the participating
- 25 institution.
- 26 b. In addition to reporting the grade point average, beginning with
- 27 the 2010-2011 academic year, each participating institution shall

1 certify to the authority at the close of each award period whether a
2 Kentucky educational excellence scholarship recipient who
3 initially enrolled in college in 2009-2010 or thereafter is on track
4 to graduate.

- 5 7. Any student who loses eligibility through failure to maintain the
6 required cumulative grade point average may regain eligibility in a
7 subsequent award period upon reestablishing at least a 2.5 cumulative
8 grade point average or its equivalent during a subsequent award period,
9 as certified by the participating institution.

- 10 (5) The expiration of a student's eight (8) academic terms and five (5) year eligibility
11 shall be extended by the authority upon a determination that the student was unable
12 to enroll for or complete an academic term due to any of the following
13 circumstances:

- 14 (a) A serious and extended illness or injury of the student, certified by an
15 attending physician;
- 16 (b) The death or serious and extended illness or injury of an immediate family
17 member of the student, certified by an attending physician, which would
18 render the student unable to attend classes;
- 19 (c) Natural disasters that would render a student unable to attend classes; or
- 20 (d) 1. Active duty status for the student in the United States Armed Forces or
21 as an officer in the Commissioned Corps of the United States Public
22 Health Service, or active service by the student in the Peace Corps Act
23 or the Americorps, for the total number of years during which the
24 student was on active duty status. The number of months served on
25 active duty status shall be rounded up to the next higher year to
26 determine the maximum length of eligibility extension allowed.

- 27 2. A student whose eligibility expired prior to July 15, 2008, due to the

1 three (3) year time limit on eligibility extensions imposed by this
2 paragraph prior to July 15, 2008, shall have his or her eligibility
3 reinstated for the number of years beyond the three (3) years during
4 which he or she was on active duty status. The number of months served
5 on active duty status shall be rounded up to the next higher year to
6 determine the maximum length of eligibility extension allowed.

7 (6) An eligible postsecondary student who is enrolled at a participating institution in a
8 five (5) year undergraduate degree program designated in an administrative
9 regulation promulgated by the authority shall be eligible to receive the Kentucky
10 educational excellence scholarship, the Kentucky educational excellence
11 scholarship and the supplemental award, or the supplemental award only for a
12 maximum of ten (10) academic terms. The expiration of an eligible postsecondary
13 student's five (5) year eligibility shall be extended to six (6) years for eligible
14 postsecondary students meeting the requirements of this subsection.

15 (7) Each participating institution shall notify its students of their terms of eligibility.

16 (8) Each eligible high school student who attains a 28 or above on the ACT and a 4.0
17 grade point average for all four (4) years of high school shall be designated as a
18 "Senator Jeff Green Scholar" in honor of the late Senator Jeff Green of Mayfield,
19 Kentucky, First District, and shall be recognized by the high school in a manner
20 consistent with recognition given by the high school to other high levels of
21 academic achievement.

22 ➔Section 4. KRS 164.7884 is amended to read as follows:

23 (1) As used in this section:

24 (a) "Academic year" means July 1 through June 30 of each year;

25 (b) "Apprentice" has the same meaning as in KRS 343.010;

26 (c) "Approved workforce solutions training program" means a local high-demand
27 work sector training program that is approved by the authority and is offered

1 by the Kentucky Community and Technical College System through
2 consultation with representatives of the local workforce development area and

15 164.7874;

16 (e) "Eligible student" means an eligible high school student who has graduated
17 from high school or a student eligible under KRS 164.7879(3)(d)(~~e~~);

18 (f) "Proprietary school" means a school that:

- 19 1. Is licensed by the Kentucky Commission on Proprietary Education;
- 20 2. Has operated for at least five (5) years;
- 21 3. Has its headquarters or main campus physically located in Kentucky;
22 and
- 23 4. Does not qualify as a participating institution under KRS 164.7874(20);

24 (g) "Qualified proprietary school program" means a program offered by a
25 proprietary school that is in the field of agriculture as defined in KRS 246.010
26 or is in one (1) of Kentucky's top five (5) high-demand work sectors as
27 determined by the Kentucky Workforce Innovation Board;

- 1 (h) "Qualified workforce training program" means a program that is in one (1) of
2 Kentucky's top five (5) high-demand work sectors as determined by the
3 Kentucky Workforce Innovation Board;
- 4 (i) "Registered apprenticeship program" means an apprenticeship program that:
5 1. Is established in accordance with the requirements of KRS Chapter 343;
6 2. Requires a minimum of two thousand (2,000) hours of on-the-job work
7 experience;
8 3. Requires a minimum of one hundred forty-four (144) hours of related
9 instruction for each year of the apprenticeship; and
10 4. Is approved by the Education and Labor Cabinet;

- 13 (2) Notwithstanding KRS 164.7881, an eligible student who earned a KEES award
14 shall be eligible for a Kentucky educational excellence scholarship if the student

17 (b) Enrolled in a qualified workforce training program that has a current
18 articulation agreement for postsecondary credit hours with a participating

- 23 (3) (a) Beginning with the 2018-2019 academic year, an eligible student enrolled in a

27 in a qualified proprietary school program, an approved workforce solutions

10 (4) Eligibility for a KEES scholarship under this section shall terminate upon the earlier

15 (b) The eligible student's successful completion of the registered apprenticeship
16 program, qualified workforce training program, qualified proprietary school
17 program, or approved workforce solutions training program.
