

1 AN ACT relating to KEES scholarships for students attending noncertified schools.

2 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

3 ➔Section 1. KRS 164.7874 is amended to read as follows:

4 As used in KRS 164.7871 to 164.7885:

5 (1) "Academic term" means a semester or other time period specified in an  
6 administrative regulation promulgated by the authority;

7 (2) "Academic year" means a period consisting of at least the minimum school term, as  
8 defined in KRS 158.070;

9 (3) "ACT score" means:

10 (a) The composite score achieved on the American College Test at a national test  
11 site on a national test date or the college admissions examination administered  
12 statewide under KRS 158.6453(5)(b)5. if the exam is the ACT;~~the~~ or

13 (b) An equivalent score, as determined by the authority, on the SAT administered  
14 by the College Board, Inc.;

15 (4) "Authority" means the Kentucky Higher Education Assistance Authority;

16 (5) "Award period" means the fall and spring consecutive academic terms within one  
17 (1) academic year;

18 (6) "Council" means the Council on Postsecondary Education created under KRS  
19 164.011;

20 (7) "Eligible high school student" means any person who:

21 (a) Is a citizen, national, or permanent resident of the United States and a  
22 Kentucky resident;

23 (b) Was enrolled~~after July 1, 1998~~:

24 1. In a Kentucky high school for at least one hundred forty (140) days of  
25 the minimum school term unless exempted by the authority's executive  
26 director upon documentation of extreme hardship, while meeting the  
27 KEES curriculum requirements, and was enrolled in a Kentucky high

- 1 school at the end of the academic year;
- 2 2. In a Kentucky high school for the fall academic term of the senior year
- 3 and who:
- 4 a. Was enrolled during the entire academic term;
- 5 b. Completed the high school's graduation requirements during the
- 6 fall academic term; and
- 7 c. Was not enrolled in a secondary school during any other academic
- 8 term of that academic year; or
- 9 3. In the Gatton Academy of Mathematics and Science in Kentucky, the
- 10 Craft Academy for Excellence in Science and Mathematics, or in high
- 11 school at a model and practice school under KRS 164.380 while meeting
- 12 the KEES~~[Kentucky educational excellence scholarship]~~ curriculum
- 13 requirements;
- 14 (c) Has a grade point average of 2.5 or above at the end of any academic year~~[~~
- 15 ~~beginning after July 1, 1998]~~, or at the end of the fall academic term for a
- 16 student eligible under paragraph (b)2.~~[(b) 2.]~~ of this subsection; and
- 17 (d) Is not a convicted felon;
- 18 (8) **"Eligible noncertified school graduate" means any person who:**
- 19 **(a) Is a citizen, national, or permanent resident of the United States and a**
- 20 **Kentucky resident;**
- 21 **(b) Graduates in the 2026-2027 academic year or thereafter from a Kentucky**
- 22 **nonpublic secondary school not certified by the Kentucky Board of**
- 23 **Education;**
- 24 **(c) Is not a convicted felon; and**
- 25 **(d) Completes all KEES noncertified school student application requirements**
- 26 **set by the authority;**
- 27 **(9)** "Eligible postsecondary student" means a **person who is a** citizen, national, or

1 permanent resident of the United States and a Kentucky resident, as determined by  
2 the participating institution in accordance with criteria established by the council  
3 for the purposes of admission and tuition assessment, who:

- 4 (a) Earned a KEES award;  
5 (b) Has the required postsecondary GPA and credit hours required under KRS  
6 164.7881;  
7 (c) Has remaining semesters of eligibility under KRS 164.7881;  
8 (d) Is enrolled in a participating institution as a part-time or full-time student; and  
9 (e) Is not a convicted felon;

10 ~~(10)~~~~(9)~~ "Full-time student" means a student enrolled in a postsecondary program of  
11 study that meets the full-time student requirements of the participating institution in  
12 which the student is enrolled;

13 ~~(11)~~~~(10)~~ "Grade point average" or "GPA" means the grade point average ***that is*** earned  
14 by an eligible student and reported by the high school or participating institution in  
15 which the student was enrolled based on a scale of 4.0 or its equivalent if the high  
16 school or participating institution that the student attends does not use the 4.0 grade  
17 scale;

18 ~~(12)~~~~(11)~~ "High school" means any Kentucky public high school, the Gatton Academy  
19 of Mathematics and Science in Kentucky, the Craft Academy for Excellence in  
20 Science and Mathematics, a high school of a model and practice school under KRS  
21 164.380, and any private, parochial, or church school located in Kentucky that has  
22 been certified by the Kentucky Board of Education as voluntarily complying with  
23 curriculum, certification, and textbook standards established by the Kentucky Board  
24 of Education under KRS 156.160;

25 ~~(13)~~~~(12)~~ "KEES" or "Kentucky educational excellence scholarship" means a  
26 scholarship provided under KRS 164.7871 to 164.7885;

27 ~~(14)~~~~(13)~~ "KEES award" means:

- 1 (a) For an eligible high school student, the sum of the KEES base amount for  
2 each academic year of high school plus any KEES supplemental amount, as  
3 adjusted pursuant to KRS 164.7881;~~{and}~~
- 4 (b) *For an eligible noncertified school graduate, the KEES base amount*  
5 *described in subsection (1) of Section 2 of this Act multiplied by four (4)*  
6 *plus any KEES supplemental amount, as adjusted pursuant to Section 3 of*  
7 *this Act; and*
- 8 (c) For a student eligible under KRS 164.7879(3)~~(d)~~~~(e)~~ *who is not an eligible*  
9 *noncertified school graduate*, the KEES supplemental amount as adjusted  
10 pursuant to KRS 164.7881;
- 11 ~~(15)~~~~(14)~~ "KEES award maximum" means the sum of the KEES base amount earned in  
12 each academic year of high school plus any KEES supplemental amount earned *or*  
13 *for an eligible noncertified school graduate, the amount described in subsection*

- 15 ~~(16)~~~~(15)~~ "KEES base amount" or "base amount" means the amount earned by an  
16 eligible high school student based on the student's GPA, *or for an eligible*  
17 *noncertified school graduate the equivalent GPA based on the student's ACT*  
18 *score,* pursuant to KRS 164.7879;
- 19 ~~(17)~~~~(16)~~ "KEES curriculum" means five (5) courses of study, except for students who  
20 meet the criteria of subsection (7)(b)2. of this section, in an academic year as  
21 determined in accordance with an administrative regulation promulgated by the  
22 authority;
- 23 ~~(18)~~~~(17)~~ "KEES supplemental amount" means the amount earned by an eligible student  
24 based on the student's ACT score pursuant to KRS 164.7879;
- 25 ~~(19)~~~~(18)~~ "KEES trust fund" means the Wallace G. Wilkinson Kentucky educational  
26 excellence scholarship trust fund;
- 27 ~~(20)~~~~(19)~~ "On track to graduate" means the number of cumulative credit hours earned as

1 compared to the number of hours determined by the postsecondary education  
2 institution as necessary to complete a bachelor's degree by the end of eight (8)  
3 academic terms or ten (10) academic terms if a student is enrolled in an  
4 undergraduate program that requires five (5) years of study;

5 ~~(21)~~~~(20)~~ "Participating institution" means an "institution" as defined in KRS 164.001  
6 that is eligible to participate in the federal Pell Grant program, executes a contract  
7 with the authority on terms the authority deems necessary or appropriate for the  
8 administration of its programs, and:

- 9 (a) 1. Is publicly operated;
- 10 2. Is licensed by the Commonwealth of Kentucky and has operated for at  
11 least ten (10) years, offers an associate or baccalaureate degree program  
12 of study not comprised solely of sectarian instruction, and admits as  
13 regular students only high school graduates, recipients of a High School  
14 Equivalency Diploma, or students transferring from another accredited  
15 degree granting institution; or
- 16 3. Is designated by the authority as an approved out-of-state institution that  
17 offers a degree program in a field of study that is not offered at any  
18 institution in the Commonwealth; and

- 19 (b) Continues to commit financial resources to student financial assistance  
20 programs; and

21 ~~(22)~~~~(21)~~ "Part-time student" means a student enrolled in a postsecondary program of  
22 study who does not meet the full-time student requirements of the participating  
23 institution in which the student is enrolled and who is enrolled for at least six (6)  
24 credit hours, or the equivalent for an institution that does not use credit hours.

25 ➔Section 2. KRS 164.7879 is amended to read as follows:

- 26 (1) (a) Kentucky educational excellence scholarship awards shall be based upon an  
27 established base scholarship amount and an eligible high school student's

grade point average or the equivalent grade point average for an eligible noncertified school graduate as described in paragraph (b) of this subsection. The base scholarship amount for students attaining a grade point average of at least 2.5~~[for the 1998-1999 academic year]~~ shall be as follows:

The authority shall review the base amount of the ~~KEES~~~~[Kentucky educational excellence scholarship]~~ each academic year and may promulgate an administrative regulation to make adjustments after considering the availability of funds.

(b) For an eligible noncertified school graduate, the equivalent grade point average shall be based on the graduate's ACT score. The base amount shall equal the GPA's corresponding dollar award in paragraph (a) of this subsection. The ACT to GPA conversion values are as follows:

- (2) (a) The authority shall commit to provide to each eligible high school student the base amount of the KEES~~[Kentucky educational excellence scholarship]~~ for each academic year of high school study in the KEES~~[Kentucky educational excellence scholarship]~~ curriculum that the high school student has attained at least a 2.5 grade point average. The award shall be based upon the eligible high school student's grade point average at the close of each academic year. An award attributable to a past academic year shall not be increased after the award has been earned by an eligible high school student, regardless of any subsequent increases made to the base amount of the KEES~~[Kentucky educational excellence scholarship]~~ through the promulgation of an administrative regulation by the authority.
- (b) Notwithstanding the definitions of "eligible high school student" and "high school" in KRS 164.7874, any high school student who maintains Kentucky residency and completes the academic courses that are required for a KEES~~[Kentucky educational excellence scholarship]~~ while participating in an approved educational high school foreign exchange program or participating in the United States Congressional Page School may apply his or her grade point average for that academic year toward the base as described in paragraph (a) of this subsection. The grade point average shall be reported by the student's Kentucky home high school, based on an official transcript from the school that the student attended during the out-of-state educational experience. The authority shall promulgate administrative regulations that describe the approval process for the educational exchange programs that qualify under this paragraph. The provisions in this paragraph shall likewise

1 apply to any Kentucky high school student who participated in an approved  
2 educational exchange program or in a Congressional Page School~~[-since the~~  
3 ~~1998-99 school year]~~ and maintained his or her Kentucky residency  
4 throughout.

5 (c) 1. Notwithstanding the definitions of "eligible high school student" and  
6 "high school" in KRS 164.7874 and the requirement that a student  
7 graduate from a Kentucky high school, a high school student who  
8 completes the KEES curriculum while attending an accredited out-of-  
9 state high school or Department of Defense school may apply the grade  
10 point average for any applicable academic year toward the base as  
11 described in paragraph (a) of this subsection and shall also qualify for a  
12 supplemental award under subsection (3) of this section when:

- 13 a. His or her custodial parent or guardian is in active service of the  
14 Armed Forces of the United States;
- 15 b. The student attended an accredited out-of-state high school or a  
16 Department of Defense school as a result of the custodial parent's  
17 or guardian's military transfer outside of Kentucky; and
- 18 c. The student earned a KEES base amount at a Kentucky high  
19 school prior to the custodial parent's or guardian's military transfer  
20 outside of Kentucky.

21 2. The student or parent shall arrange for the out-of-state school to report  
22 the student's grade point average each academic year and the student's  
23 highest ACT score to the authority as required under KRS 164.7885.  
24 The authority shall promulgate administrative regulations implementing  
25 the requirements in this paragraph, including:

- 26 a. The documentation that the parent shall submit to the authority  
27 establishing the student's eligibility for the scholarship; and

1                   b.    The assurances that an out-of-state institution shall submit to the  
2                               authority for submission of the student grade point average.

3                   3.    The provisions in this paragraph shall apply to the 2001-2002 school  
4                               year and thereafter.

5           (d) ~~[Beginning with the 2013-2014 academic year, ]~~A student who meets the  
6           Kentucky core academic standards for high school graduation established in  
7           administrative regulation and graduates after completing three (3) years of  
8           high school shall receive a Kentucky educational excellence scholarship  
9           award equivalent to completing high school in four (4) years. The award shall  
10          be determined by dividing the total actual KEES scholarship earned under  
11          subsection (1) of this section by three (3) and multiplying that number by four  
12          (4). The resulting number shall be the annual award the student is eligible for  
13          under subsection (1) of this section.

14   (3)   (a) ~~[The authority shall commit to provide to each eligible high school student~~  
15           ~~graduating from high school before June 30, 1999, and achieving a score of at~~  
16           ~~least 15 on the American College Test, a supplemental award for the award~~  
17           ~~period beginning in the fall of 1999, based on the eligible high school~~  
18           ~~student's highest ACT score attained by the date of graduation from high~~

 25       commit to provide a supplemental award for achievement on  
 26       examinations for Advanced Placement or International Baccalaureate as

14 high school student whose family was eligible for free or reduced-priced  
15 lunch for any year during high school enrollment. The supplemental award for  
16 Cambridge Advanced International examination scores are as follows:

- 17 1. Two hundred dollars (\$200) for each score of "e";
- 18 2. Two hundred fifty dollars (\$250) for each score of "c" or "d"; and
- 19 3. Three hundred dollars (\$300) for each score of "a\*", "a", or "b".

20 ~~(d)~~ ~~{(e)}~~ The authority shall promulgate administrative regulations establishing ***in***  
21 ***accordance with KRS Chapter 13A*** the eligibility criteria and procedures for  
22 making a supplemental award to Kentucky residents who are citizens,  
23 nationals, or permanent residents of the United States and who graduate from  
24 a ***Kentucky*** nonpublic secondary school not certified by the Kentucky Board  
25 of Education and Kentucky residents who are citizens, nationals, or permanent  
26 residents of the United States and who obtain a High School Equivalency  
27 Diploma within five (5) years of their high school graduating class, and

1 students under subsection (2)(c) of this section who do not attend an  
2 accredited high school.

3 ➔Section 3. KRS 164.7881 is amended to read as follows:

4 (1) Eligible high school students who have graduated from high school and eligible  
5 postsecondary students who have earned a Kentucky educational excellence  
6 scholarship, a Kentucky educational excellence scholarship and a supplemental  
7 award, or a supplemental award only pursuant to KRS 164.7879(3)(d)(~~e~~), shall be  
8 eligible to receive the Kentucky educational excellence scholarship, the Kentucky  
9 educational excellence scholarship and the supplemental award, or a supplemental  
10 award only for a maximum of eight (8) academic terms in an undergraduate or other  
11 postsecondary program of study at a participating institution, except as provided in  
12 subsections (5) and (6) of this section.

13 (2) To receive the Kentucky educational excellence scholarship, a Kentucky  
14 educational excellence scholarship and supplemental award, or a supplemental  
15 award only, an eligible high school or postsecondary student shall:

16 (a) Enroll in and attend a participating institution as a full-time student or a part-  
17 time student; and

18 (b) Maintain eligibility as provided in subsection (3) of this section.

19 (3) Eligibility for a Kentucky educational excellence scholarship or a Kentucky  
20 educational excellence scholarship and supplemental award shall terminate upon  
21 the earlier of:

22 (a) The expiration of five (5) years following the student's graduation from high  
23 school, except as provided in subsection (5) or (6) of this section; or

24 (b) The successful completion of an undergraduate or other postsecondary course  
25 of study. However, any student who successfully completes the requirements  
26 for a degree or certification involving a postsecondary course of study that  
27 normally requires less than eight (8) academic terms to complete may

1 continue to receive the benefits of a Kentucky educational excellence  
2 scholarship, a Kentucky educational excellence scholarship and supplemental  
3 award, or a supplemental award only, for a cumulative total of eight (8)  
4 academic terms if the student enrolls as at least a part-time student in a four  
5 (4) year program.

6 (4) (a) The maximum award amount shall be determined by the authority and shall  
7 be adjusted as provided in this subsection. The award amount ultimately  
8 determined to be available to an eligible postsecondary student for an award  
9 period shall be delivered by the authority to the participating institution for  
10 disbursement to the eligible postsecondary student.

11 (b) The authority shall, by promulgation of administrative regulations, provide for  
12 the proportionate reduction of the maximum award amount for an eligible  
13 postsecondary student for any academic term in which the student is enrolled  
14 on a part-time basis. Each academic term for which any scholarship or  
15 supplemental award funds are accepted by an eligible postsecondary student  
16 shall count as a full academic term, even if the award amount was reduced to  
17 reflect the part-time status of the eligible postsecondary student, except if the  
18 eligible postsecondary student interrupts enrollment during the award period  
19 for any reason specified in subsection (5) of this section, and the participating  
20 institution does not certify a cumulative grade point average for that student at  
21 the end of that award period.

22 (c) 1. An eligible postsecondary student who is enrolled full-time in an  
23 undergraduate program of study, in the pharmacy program at the  
24 University of Kentucky, or in a program of study designated as an  
25 equivalent undergraduate program of study by the authority in an  
26 administrative regulation, shall receive the maximum award amount for  
27 the first award period that the student is enrolled in and attending the

1 program of study.

2 2. To retain the maximum award for the second award period, an eligible  
3 postsecondary student shall have at least a 2.5 grade point average at the  
4 end of the first award period. If the eligible postsecondary student  
5 interrupts enrollment during the award period for any reason specified in  
6 subsection (5) of this section, and the participating institution does not  
7 certify a cumulative grade point average for that student at the end of  
8 that award period, the eligible postsecondary student shall, subject to  
9 paragraph (b) of this subsection, retain the maximum award for the  
10 award period in which he or she resumes enrollment.

11 3. To retain the maximum award amount for subsequent award periods, an  
12 eligible postsecondary student shall have:

13 a. A cumulative grade point average of 3.0 or greater at the end of  
14 the prior award period. If the eligible postsecondary student  
15 interrupts enrollment during the award period for any reason  
16 specified in subsection (5) of this section, and the participating  
17 institution does not certify a cumulative grade point average for  
18 that student at the end of that award period, the eligible  
19 postsecondary student shall, subject to paragraph (b) of this  
20 subsection, retain the same award for the award period in which he  
21 or she resumes enrollment as he or she received in the award  
22 period in which enrollment was interrupted; or

23 b. A cumulative grade point average of 2.5 or greater but less than  
24 3.0 at the end of the prior award period and be on track to  
25 graduate. If the eligible postsecondary student interrupts  
26 enrollment during the award period for any reason specified in  
27 subsection (5) of this section, and the participating institution does

1 not certify a cumulative grade point average for that student at the  
2 end of that award period, the eligible postsecondary student shall,  
3 subject to paragraph (b) of this subsection, retain the same award  
4 for the award period in which he or she resumes enrollment as he  
5 or she received in the award period in which enrollment was  
6 interrupted.

7 4. Any eligible full-time postsecondary student who maintains a  
8 cumulative grade point average of less than 3.0 but at least 2.5 but is not  
9 on track to graduate at the completion of any award period shall receive  
10 a reduction in the maximum award amount equal to fifty percent (50%)  
11 of the maximum award amount for the next award period.

12 5. Any eligible postsecondary student who maintains a cumulative grade  
13 point average of less than 2.5 at the completion of any award period  
14 shall lose his or her award for the next award period.

15 6. a. Each participating institution shall certify to the authority at the  
16 close of each award period the cumulative grade point average of  
17 each Kentucky educational excellence scholarship recipient  
18 enrolled as a full-time or part-time student at the participating  
19 institution.

20 b. In addition to reporting the grade point average, beginning with  
21 the 2010-2011 academic year, each participating institution shall  
22 certify to the authority at the close of each award period whether a  
23 Kentucky educational excellence scholarship recipient who  
24 initially enrolled in college in 2009-2010 or thereafter is on track  
25 to graduate.

26 7. Any student who loses eligibility through failure to maintain the  
27 required cumulative grade point average may regain eligibility in a

1 subsequent award period upon reestablishing at least a 2.5 cumulative  
2 grade point average or its equivalent during a subsequent award period,  
3 as certified by the participating institution.

4 (5) The expiration of a student's eight (8) academic terms and five (5) year eligibility  
5 shall be extended by the authority upon a determination that the student was unable  
6 to enroll for or complete an academic term due to any of the following  
7 circumstances:

8 (a) A serious and extended illness or injury of the student, certified by an  
9 attending physician;

10 (b) The death or serious and extended illness or injury of an immediate family  
11 member of the student, certified by an attending physician, which would  
12 render the student unable to attend classes;
