

1 AN ACT relating to domestic relations.

2 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

3 ➔Section 1. KRS 209A.122 is amended to read as follows:

4 (1) As used in this section:

5 (a) "Center" means the Criminal Justice Statistical Analysis Center created in
6 KRS 15.280;

7 (b) "Corollary victim" means an individual other than the victim who is directly
8 impacted by domestic violence and abuse or dating violence and abuse, either
9 through relationship or proximity;

10 (c) "Domestic violence fatalities" means deaths that occur as a result of domestic
11 violence and abuse or dating violence and abuse, and includes but is not
12 limited to homicides, related suicides, and corollary victims; and

13 (d) "Near fatality" means a crime where serious physical injury as defined in KRS
14 500.080 occurs.

15 (2) The center shall:

16 (a) Collect information on domestic violence fatalities, domestic violence and
17 abuse, and dating violence and abuse within the Commonwealth from
18 subsections (3) to (5) of this section; and

19 (b) Produce an annual report by July 1 of each year and submit the report to~~the~~:

20 1. ~~ZeroV~~~~[Kentucky Coalition Against Domestic Violence];~~

21 2. The Governor;

22 3. The Cabinet for Health and Family Services;

23 4. The Interim Joint Committee on Judiciary;

24 5. The Interim Joint Committee on Families and Children;~~and~~

25 6. The Legislative Research Commission;

26 7. The Administrative Office of the Court; and

27 8. The Office of the Attorney General.

1 ~~Zero~~^V~~[The Kentucky Coalition Against Domestic Violence]~~ may provide the
2 agencies listed in paragraph (b)~~2.1.1~~ to ~~8.16~~ of this subsection with best practices
3 and any other recommendations for public policy by November ~~15.1.1~~ of each year.

4 (3) (a) The Department of Kentucky State Police shall provide the center with:

- 5 1. ***The statistical information from all JC-3 forms and all fields on a JC-***
6 ***3 form that relate to domestic violence and abuse and dating violence***
7 ***and abuse***~~[The number of domestic violence and abuse and dating~~
8 ~~violence and abuse calls for service to which the Kentucky State Police~~
9 ~~and associated law enforcement agencies responded];~~
10 2. The number of arrests by Kentucky State Police and associated agencies
11 in response to ~~calls of~~ domestic violence and abuse or dating violence
12 and abuse; and
13 3. If an arrest was made, the arresting offense charged by Kentucky State
14 Police or associated law enforcement agencies.

15 (b) The Department of Kentucky State Police shall separately provide the center
16 with information reported to the Law Information Network of Kentucky
17 (LINK). The Department of Kentucky State Police shall provide the center
18 with the:

- 19 1. Number of orders of protection ***entered***~~received~~ to be served by law
20 enforcement agencies;
21 2. Number of orders of protection served by law enforcement agencies;
22 ***and***
23 3. ~~[Number of orders of protection in LINK; and~~
24 4. ~~—~~ Average time for ~~[actual]~~ service~~[to be returned]~~.

25 (4) The Administrative Office of the Courts shall provide the center with:

26 (a) The number and type of petitions for orders of protection filed and denied
27 under KRS 403.725;

- 1 (b) The number and type of petitions for interpersonal violence orders filed and
2 denied under KRS 456.030;
- 3 (c) The number of emergency protective orders granted under KRS 403.730 and
4 temporary interpersonal protective orders granted under KRS 456.040;
- 5 (d) The number of domestic violence orders granted under KRS 403.740 and
6 interpersonal protective orders granted under 456.060, excluding amended or
7 corrected orders;
- 8 (e) Information on whether the parties were represented by legal counsel or
9 guardian ad litem;
- 10 (f) The relationship between the petitioner and the respondent, if known;
- 11 (g)(f) Demographics of the parties, including age, race, and gender;
- 12 (h)(g) Information on whether the victim was or is pregnant, if indicated on the
13 petition; and
- 14 (i)(h) The number of criminal charges for a violation of an order of protection.
- 15 (5) The Cabinet for Health and Family Services shall provide the center with:
- 16 (a) The number of reports of substantiated~~[alleged]~~ child dependency, neglect,
17 or abuse where there was also substantiated domestic violence and abuse
18 between the child's parents, guardians, or persons charged with custody or
19 control of the child~~[made to the cabinet through an adult or child abuse~~
20 ~~hotline in which there were also allegations of domestic violence]~~; and
- 21 (b) Domestic violence and abuse and dating violence and abuse shelter statistics
22 reported to the cabinet, including but not limited to the:
- 23 1. Number of minors served in shelter;
- 24 2. Number of minors served in nonshelter~~[non-shelter]~~ services;
- 25 3. Number of adults served in shelter;
- 26 4. Number of adults served in nonshelter~~[non-shelter]~~ services;
- 27 5. Demographics, including age and race;

- 1 6. Number of crisis or hotline calls;
- 2 7. Number of minors receiving:
- 3 a. Crisis intervention;
- 4 b. Victim advocacy services; and
- 5 c. Individual or group counseling or support group; and
- 6 8. Number of adult victims receiving:
- 7 a. Crisis intervention;
- 8 b. Victim advocacy services;
- 9 c. Individual or group counseling or support group;
- 10 d. Criminal or civil legal advocacy;
- 11 e. Medical accompaniment; and
- 12 f. Transportation services.

13 ➔Section 2. KRS 15A.190 is amended to read as follows:

14 The Justice and Public Safety Cabinet, in consultation with the Cabinet for Health and
15 Family Services, the Kentucky Commission on Women, and any other agency concerned
16 with particular acts of criminal activity, shall:

- 17 (1) Design~~[- print,]~~ and **make available**~~[- distribute]~~ to all law enforcement agencies in
18 the Commonwealth, an electronic ~~[- or paper]~~ uniform reporting form, to be known
19 as the JC-3, which provides statistical information relating to the crimes involving:
- 20 (a) Domestic violence;
 - 21 (b) Child abuse;
 - 22 (c) Childhood sexual assault or abuse as defined in KRS 413.249;
 - 23 (d) Victimization of the elderly, including but not limited to elder abuse, neglect,
24 and exploitation and other crimes against the elderly; or
 - 25 (e) Any other particular area of criminal activity deemed by the secretary of
26 justice and public safety to require research as to its frequency; and
- 27 (2) Promulgate administrative regulations, in accordance with KRS Chapter 13A, to

- 1 provide that the information required in KRS 209A.122 be provided to the Criminal
- 2 Justice Statistical Analysis Center.
