

1 A RESOLUTION urging United States Attorney General Pam Bondi to investigate
2 and prosecute individuals implicated in criminal activities related to the Jeffrey Epstein
3 files and recognizing the efforts of Kentucky's own Representative Thomas Massie in
4 securing their public release.

5 WHEREAS, Jeffrey Epstein was a convicted sex offender whose criminal activities
6 involved the sexual exploitation and trafficking of minors and whose network included
7 numerous high-profile individuals; and

8 WHEREAS, in 2025, Representative Thomas Massie introduced and led the
9 passage of H.R. 4405, the Epstein Files Transparency Act, which requires the Department
10 of Justice to release all unclassified records, documents, communications, and
11 investigative materials related to the investigation and prosecution of Jeffrey Epstein,
12 with limited exceptions for victim privacy; and

13 WHEREAS, in November 2025, the bill was enacted after passing the United States
14 House of Representatives with overwhelming approval, 427-1, and the Senate by
15 unanimous consent; and

16 WHEREAS, the enactment of the Epstein Files Transparency Act led to the release
17 of millions of pages of documents, images, and videos in late 2025 and early 2026; and

18 WHEREAS, these disclosures have revealed new details about Jeffrey Epstein's
19 network and potential associations with participants, as well as evidence that may
20 indicate additional criminal conduct, while also raising ongoing concerns about
21 incomplete releases, excessive redactions, and the need for full accountability; and

22 WHEREAS, the people of Kentucky, including the constituents of Representative
23 Thomas Massie, have a vested interest in ensuring federal law enforcement upholds the
24 rule of law, protects vulnerable individuals, pursues justice without fear or favor, and
25 builds on the transparency achieved through the Epstein Files Transparency Act; and

26 WHEREAS, the Kentucky House of Representatives commends Representative
27 Thomas Massie's persistent efforts to expose the Jeffrey Epstein files and believes that

1 any credible evidence of criminal wrongdoing uncovered therein warrants thorough
2 investigation and appropriate prosecution;

3 NOW, THEREFORE,

4 *Be it resolved by the House of Representatives of the General Assembly of the*
5 *Commonwealth of Kentucky:*

6 ➔Section 1. The House of Representatives urges United States Attorney General
7 Pam Bondi to direct the Department of Justice to conduct a comprehensive review of all
8 materials released pursuant to the Epstein Files Transparency Act, legislation
9 spearheaded by Kentucky's Representative Thomas Massie, and to pursue criminal
10 charges against any individual for whom there is sufficient evidence of violations of
11 federal law, including but not limited to sex trafficking, exploitation of minors,
12 conspiracy, or related offenses.

13 ➔Section 2. The House of Representatives expresses appreciation for
14 Representative Thomas Massie's leadership in making the Jeffrey Epstein files public,
15 thereby advancing justice for victims and transparency for the American people.

16 ➔Section 3. The Clerk of the House of Representatives is directed to transmit a
17 copy of this Resolution to the United States Attorney General, the President of the United
18 States, the Speaker of the United States House of Representatives, the Majority Leader of
19 the United States Senate, Representative Thomas Massie, and each member of the
20 Kentucky congressional delegation.
