

1 AN ACT relating to the Department of Workers' Claims and declaring an  
2 emergency.

3 *Be it enacted by the General Assembly of the Commonwealth of Kentucky:*

4 ➔SECTION 1. A NEW SECTION OF KRS CHAPTER 342 IS CREATED TO  
5 READ AS FOLLOWS:

6 *(1) There is hereby created the Department of Workers' Claims administratively*  
7 *attached to the Office of the Governor, which shall be headed by a commissioner*  
8 *appointed by the Governor and confirmed by the Senate in accordance with*  
9 *Section 6 of this Act.*

10 *(2) The department shall be divided for administrative purposes into the:*

11 *(a) Office of Administrative Law Judges;*

12 *(b) Division of Claims Processing;*

13 *(c) Division of Security and Compliance;*

14 *(d) Division of Workers' Compensation Funds; and*

15 *(e) Division of Specialist and Medical Services.*

16 *(3) The Office of Administrative Law Judges shall be headed by a chief*  
17 *administrative law judge appointed in accordance with Section 7 of this Act.*

18 *(4) Each division in the department shall be headed by a director appointed by the*  
19 *commissioner with the approval of the Governor in accordance with KRS 12.050.*

20 *(5) The Workers' Compensation Board shall be attached to the Department of*  
21 *Workers' Claims for administrative purposes only.*

22 ➔Section 2. KRS 342.0011 is amended to read as follows:

23 As used in this chapter, unless the context otherwise requires:

24 (1) "Injury" means any work-related traumatic event or series of traumatic events,  
25 including cumulative trauma, arising out of and in the course of employment which  
26 is the proximate cause producing a harmful change in the human organism  
27 evidenced by objective medical findings. "Injury" does not include the effects of the

- 1 natural aging process, and does not include any communicable disease unless the  
2 risk of contracting the disease is increased by the nature of the employment.  
3 "Injury" when used generally, unless the context indicates otherwise, shall include  
4 an occupational disease and damage to a prosthetic appliance, but shall not include  
5 a psychological, psychiatric, or stress-related change in the human organism, unless  
6 it is a direct result of a physical injury;
- 7 (2) "Occupational disease" means a disease arising out of and in the course of the  
8 employment;
- 9 (3) An occupational disease as defined in this chapter shall be deemed to arise out of  
10 the employment if there is apparent to the rational mind, upon consideration of all  
11 the circumstances, a causal connection between the conditions under which the  
12 work is performed and the occupational disease, and which can be seen to have  
13 followed as a natural incident to the work as a result of the exposure occasioned by  
14 the nature of the employment and which can be fairly traced to the employment as  
15 the proximate cause. The occupational disease shall be incidental to the character of  
16 the business and not independent of the relationship of employer and employee. An  
17 occupational disease need not have been foreseen or expected but, after its  
18 contraction, it must appear to be related to a risk connected with the employment  
19 and to have flowed from that source as a rational consequence;
- 20 (4) "Injurious exposure" shall mean that exposure to occupational hazard which would,  
21 independently of any other cause whatsoever, produce or cause the disease for  
22 which the claim is made;
- 23 (5) "Death" means death resulting from an injury or occupational disease;
- 24 (6) "Carrier" means any insurer, or legal representative thereof, authorized to insure the  
25 liability of employers under this chapter and includes a self-insurer;
- 26 (7) "Self-insurer" is an employer who has been authorized under the provisions of this  
27 chapter to carry his own liability on his employees covered by this chapter;

- 1 (8) "Department" means the Department of Workers' Claims administratively attached  
2 to the office of the Governor~~[in the Education and Labor Cabinet];~~
- 3 (9) "Commissioner" means the commissioner of the Department of Workers' Claims~~[~~  
4 ~~under the direction and supervision of the secretary of the Education and Labor~~  
5 ~~Cabinet];~~
- 6 (10) "Board" means the Workers' Compensation Board;
- 7 (11) (a) "Temporary total disability" means the condition of an employee who has not  
8 reached maximum medical improvement from an injury and has not reached a  
9 level of improvement that would permit a return to employment;
- 10 (b) "Permanent partial disability" means the condition of an employee who, due  
11 to an injury, has a permanent disability rating but retains the ability to work;  
12 and
- 13 (c) "Permanent total disability" means the condition of an employee who, due to  
14 an injury, has a permanent disability rating and has a complete and permanent  
15 inability to perform any type of work as a result of an injury, except that total  
16 disability shall be irrebuttably presumed to exist for an injury that results in:
- 17 1. Total and permanent loss of sight in both eyes;
  - 18 2. Loss of both feet at or above the ankle;
  - 19 3. Loss of both hands at or above the wrist;
  - 20 4. Loss of one (1) foot at or above the ankle and the loss of one (1) hand at  
21 or above the wrist;
  - 22 5. Permanent and complete paralysis of both arms, both legs, or one (1)  
23 arm and one (1) leg;
  - 24 6. Incurable insanity or imbecility; or
  - 25 7. Total loss of hearing;
- 26 (12) "Income benefits" means payments made under the provisions of this chapter to the  
27 disabled worker or his dependents in case of death, excluding medical and related

- 1           benefits;
- 2   (13) "Medical and related benefits" means payments made for medical, hospital, burial,  
3           and other services as provided in this chapter, other than income benefits;
- 4   (14) "Compensation" means all payments made under the provisions of this chapter  
5           representing the sum of income benefits and medical and related benefits;
- 6   (15) "Medical services" means medical, surgical, dental, hospital, nursing, and medical  
7           rehabilitation services, medicines, and fittings for artificial or prosthetic devices;
- 8   (16) "Person" means any individual, partnership, limited partnership, limited liability  
9           company, firm, association, trust, joint venture, corporation, or legal representative  
10          thereof;
- 11   (17) "Wages" means, in addition to money payments for services rendered, the  
12          reasonable value of board, rent, housing, lodging, fuel, or similar advantages  
13          received from the employer, and gratuities received in the course of employment  
14          from persons other than the employer as evidenced by the employee's federal and  
15          state tax returns;
- 16   (18) "Agriculture" means the operation of farm premises, including the planting,  
17          cultivation, producing, growing, harvesting, and preparation for market of  
18          agricultural or horticultural commodities thereon, the raising of livestock for food  
19          products and for racing purposes, and poultry thereon, and any work performed as  
20          an incident to or in conjunction with the farm operations, including the sale of  
21          produce at on-site markets and the processing of produce for sale at on-site markets.  
22          It shall not include the commercial processing, packing, drying, storing, or canning  
23          of such commodities for market, or making cheese or butter or other dairy products  
24          for market;
- 25   (19) "Beneficiary" means any person who is entitled to income benefits or medical and  
26          related benefits under this chapter;
- 27   (20) "United States," when used in a geographic sense, means the several states, the

1 District of Columbia, the Commonwealth of Puerto Rico, the Canal Zone, and the  
2 territories of the United States;

3 (21) "Alien" means a person who is not a citizen, a national, or a resident of the United  
4 States or Canada. Any person not a citizen or national of the United States who  
5 relinquishes or is about to relinquish his residence in the United States shall be  
6 regarded as an alien;

7 (22) "Insurance carrier" means every insurance carrier or insurance company authorized  
8 to do business in the Commonwealth writing workers' compensation insurance  
9 coverage and includes the Kentucky Employers Mutual Insurance Authority and  
10 every self-insured group operating under the provisions of this chapter;

11 (23) (a) "Severance or processing of coal" means all activities performed in the  
12 Commonwealth at underground, auger, and surface mining sites; all activities  
13 performed at tipple or processing plants that clean, break, size, or treat coal;  
14 and all activities performed at coal loading facilities for trucks, railroads, and  
15 barges. Severance or processing of coal shall not include acts performed by a  
16 final consumer if the acts are performed at the site of final consumption.

17 (b) "Engaged in severance or processing of coal" shall include all individuals,  
18 partnerships, limited partnerships, limited liability companies, corporations,  
19 joint ventures, associations, or any other business entity in the Commonwealth  
20 which has employees on its payroll who perform any of the acts stated in  
21 paragraph (a) of this subsection, regardless of whether the acts are performed  
22 as owner of the coal or on a contract or fee basis for the actual owner of the  
23 coal. A business entity engaged in the severance or processing of coal,  
24 including but not limited to administrative or selling functions, shall be  
25 considered wholly engaged in the severance or processing of coal for the  
26 purpose of this chapter. However, a business entity which is engaged in a  
27 separate business activity not related to coal, for which a separate premium

1 charge is not made, shall be deemed to be engaged in the severance or  
2 processing of coal only to the extent that the number of employees engaged in  
3 the severance or processing of coal bears to the total number of employees.  
4 Any employee who is involved in the business of severing or processing of  
5 coal and business activities not related to coal shall be prorated based on the  
6 time involved in severance or processing of coal bears to his total time;

7 (24) "Premium" for every self-insured group means any and all assessments levied on its  
8 members by such group or contributed to it by the members thereof. For special  
9 fund assessment purposes, "premium" also includes any and all membership dues,  
10 fees, or other payments by members of the group to associations or other entities  
11 used for underwriting, claims handling, loss control, premium audit, actuarial, or  
12 other services associated with the maintenance or operation of the self-insurance  
13 group;

14 (25) (a) "Premiums received" for policies effective on or after January 1, 1994, for  
15 insurance companies means direct written premiums as reported in the annual  
16 statement to the Department of Insurance by insurance companies, except that  
17 "premiums received" includes premiums charged off or deferred, and, on  
18 insurance policies or other evidence of coverage with provisions for  
19 deductibles, the calculated cost for coverage, including experience  
20 modification and premium surcharge or discount, prior to any reduction for  
21 deductibles. The rates, factors, and methods used to calculate the cost for  
22 coverage under this paragraph for insurance policies or other evidence of  
23 coverage with provisions for deductibles shall be the same rates, factors, and  
24 methods normally used by the insurance company in Kentucky to calculate  
25 the cost for coverage for insurance policies or other evidence of coverage  
26 without provisions for deductibles, except that, for insurance policies or other  
27 evidence of coverage with provisions for deductibles effective on or after

1 January 1, 1995, the calculated cost for coverage shall not include any  
2 schedule rating modification, debits, or credits. For policies with provisions  
3 for deductibles with effective dates on or after January 1, 1995, assessments  
4 shall be imposed on premiums received as calculated by the deductible  
5 program adjustment. The cost for coverage calculated under this paragraph by  
6 insurance companies that issue only deductible insurance policies in Kentucky  
7 shall be actuarially adequate to cover the entire liability of the employer for  
8 compensation under this chapter, including all expenses and allowances  
9 normally used to calculate the cost for coverage. For policies with provisions  
10 for deductibles with effective dates of May 6, 1993, through December 31,  
11 1993, for which the insurance company did not report premiums and remit  
12 special fund assessments based on the calculated cost for coverage prior to the  
13 reduction for deductibles, "premiums received" includes the initial premium  
14 plus any reimbursements invoiced for losses, expenses, and fees charged  
15 under the deductibles. The special fund assessment rates in effect for  
16 reimbursements invoiced for losses, expenses, or fees charged under the  
17 deductibles shall be those percentages in effect on the effective date of the  
18 insurance policy. For policies covering covered employees having a co-  
19 employment relationship with a professional employer organization and a  
20 client as defined in KRS Chapter 336, "premiums received" means premiums  
21 calculated using the experience modification factor of each client as defined  
22 in KRS Chapter 336 for each covered employee for that portion of the payroll  
23 pertaining to the covered employee.

24 (b) "Direct written premium" for insurance companies means the gross premium  
25 written less return premiums and premiums on policies not taken but  
26 including policy and membership fees.

27 (c) "Premium," for policies effective on or after January 1, 1994, for insurance

1 companies means all consideration, whether designated as premium or  
2 otherwise, for workers' compensation insurance paid to an insurance company  
3 or its representative, including, on insurance policies with provisions for  
4 deductibles, the calculated cost for coverage, including experience  
5 modification and premium surcharge or discount, prior to any reduction for  
6 deductibles. The rates, factors, and methods used to calculate the cost for  
7 coverage under this paragraph for insurance policies or other evidence of  
8 coverage with provisions for deductibles shall be the same rates, factors, and  
9 methods normally used by the insurance company in Kentucky to calculate  
10 the cost for coverage for insurance policies or other evidence of coverage  
11 without provisions for deductibles, except that, for insurance policies or other  
12 evidence of coverage with provisions for deductibles effective on or after  
13 January 1, 1995, the calculated cost for coverage shall not include any  
14 schedule rating modifications, debits, or credits. For policies with provisions  
15 for deductibles with effective dates on or after January 1, 1995, assessments  
16 shall be imposed as calculated by the deductible program adjustment. The cost  
17 for coverage calculated under this paragraph by insurance companies that  
18 issue only deductible insurance policies in Kentucky shall be actuarially  
19 adequate to cover the entire liability of the employer for compensation under  
20 this chapter, including all expenses and allowances normally used to calculate  
21 the cost for coverage. For policies with provisions for deductibles with  
22 effective dates of May 6, 1993, through December 31, 1993, for which the  
23 insurance company did not report premiums and remit special fund  
24 assessments based on the calculated cost for coverage prior to the reduction  
25 for deductibles, "premium" includes the initial consideration plus any  
26 reimbursements invoiced for losses, expenses, or fees charged under the  
27 deductibles.

- 1 (d) "Return premiums" for insurance companies means amounts returned to  
2 insureds due to endorsements, retrospective adjustments, cancellations,  
3 dividends, or errors.
- 4 (e) "Deductible program adjustment" means calculating premium and premiums  
5 received on a gross basis without regard to the following:
- 6 1. Schedule rating modifications, debits, or credits;
  - 7 2. Deductible credits; or
  - 8 3. Modifications to the cost of coverage from inception through and  
9 including any audit that are based on negotiated retrospective rating  
10 arrangements, including but not limited to large risk alternative rating  
11 options;
- 12 (26) "Insurance policy" for an insurance company or self-insured group means the term  
13 of insurance coverage commencing from the date coverage is extended, whether a  
14 new policy or a renewal, through its expiration, not to exceed the anniversary date  
15 of the renewal for the following year;
- 16 (27) "Self-insurance year" for a self-insured group means the annual period of  
17 certification of the group created pursuant to KRS 342.350(4) and 304.50-010;
- 18 (28) "Premium" for each employer carrying his own risk pursuant to KRS 342.340(1)  
19 shall be the projected value of the employer's workers' compensation claims for the  
20 next calendar year as calculated by the commissioner using generally-accepted  
21 actuarial methods as follows:
- 22 (a) The base period shall be the earliest three (3) calendar years of the five (5)  
23 calendar years immediately preceding the calendar year for which the  
24 calculation is made. The commissioner shall identify each claim of the  
25 employer which has an injury date or date of last injurious exposure to the  
26 cause of an occupational disease during each one (1) of the three (3) calendar  
27 years to be used as the base, and shall assign a value to each claim. The value

1 shall be the total of the indemnity benefits paid to date and projected to be  
2 paid, adjusted to current benefit levels, plus the medical benefits paid to date  
3 and projected to be paid for the life of the claim, plus the cost of medical and  
4 vocational rehabilitation paid to date and projected to be paid. Adjustment to  
5 current benefit levels shall be done by multiplying the weekly indemnity  
6 benefit for each claim by the number obtained by dividing the statewide  
7 average weekly wage which will be in effect for the year for which the  
8 premium is being calculated by the statewide average weekly wage in effect  
9 during the year in which the injury or date of the last exposure occurred. The  
10 total value of the claims using the adjusted weekly benefit shall then be  
11 calculated by the commissioner. Values for claims in which awards have been  
12 made or settlements reached because of findings of permanent partial or  
13 permanent total disability shall be calculated using the mortality and interest  
14 discount assumptions used in the latest available statistical plan of the  
15 advisory rating organization defined in Subtitle 13 of KRS Chapter 304. The  
16 sum of all calculated values shall be computed for all claims in the base  
17 period;

18 (b) The commissioner shall obtain the annual payroll for each of the three (3)  
19 years in the base period for each employer carrying his own risk from records  
20 of the department and from the records of the Department of Workforce  
21 Development, Education and Labor Cabinet. The commissioner shall multiply  
22 each of the three (3) years of payroll by the number obtained by dividing the  
23 statewide average weekly wage which will be in effect for the year in which  
24 the premium is being calculated by the statewide average weekly wage in  
25 effect in each of the years of the base period;

26 (c) The commissioner shall divide the total of the adjusted claim values for the  
27 three (3) year base period by the total adjusted payroll for the same three (3)

1 year period. The value so calculated shall be multiplied by 1.25 and shall then  
2 be multiplied by the employer's most recent annualized payroll, calculated  
3 using records of the department and the Department of Workforce  
4 Development data which shall be made available for this purpose on a  
5 quarterly basis as reported, to obtain the premium for the next calendar year  
6 for assessment purposes under KRS 342.122;

7 (d) For November 1, 1987, through December 31, 1988, premium for each  
8 employer carrying its own risk shall be an amount calculated by the board  
9 pursuant to the provisions contained in this subsection and such premium  
10 shall be provided to each employer carrying its own risk and to the funding  
11 commission on or before January 1, 1988. Thereafter, the calculations set  
12 forth in this subsection shall be performed annually, at the time each employer  
13 applies or renews its application for certification to carry its own risk for the  
14 next twelve (12) month period and submits payroll and other data in support  
15 of the application. The employer and the funding commission shall be notified  
16 at the time of the certification or recertification of the premium calculated by  
17 the commissioner, which shall form the employer's basis for assessments  
18 pursuant to KRS 342.122 for the calendar year beginning on January 1  
19 following the date of certification or recertification;

20 (e) If an employer having fewer than five (5) years of doing business in this state  
21 applies to carry its own risk and is so certified, its premium for the purposes  
22 of KRS 342.122 shall be based on the lesser number of years of experience as  
23 may be available including the two (2) most recent years if necessary to create  
24 a three (3) year base period. If the employer has less than two (2) years of  
25 operation in this state available for the premium calculation, then its premium  
26 shall be the greater of the value obtained by the calculation called for in this  
27 subsection or the amount of security required by the commissioner pursuant to

- 1 KRS 342.340(1);
- 2 (f) If an employer is certified to carry its own risk after having previously insured  
3 the risk, its premium shall be calculated using values obtained from claims  
4 incurred while insured for as many of the years of the base period as may be  
5 necessary to create a full three (3) year base. After the employer is certified to  
6 carry its own risk and has paid all amounts due for assessments upon  
7 premiums paid while insured, the employer shall be assessed only upon the  
8 premium calculated under this subsection;
- 9 (g) "Premium" for each employer defined in KRS 342.630(2) shall be calculated  
10 as set forth in this subsection; and
- 11 (h) Notwithstanding any other provision of this subsection, the premium of any  
12 employer authorized to carry its own risk for purposes of assessments due  
13 under this chapter shall be no less than thirty cents (\$0.30) per one hundred  
14 dollars (\$100) of the employer's most recent annualized payroll for employees  
15 covered by this chapter;
- 16 (29) "SIC code" as used in this chapter means the Standard Industrial Classification  
17 Code contained in the latest edition of the Standard Industrial Classification Manual  
18 published by the Federal Office of Management and Budget;
- 19 (30) "Investment interest" means any pecuniary or beneficial interest in a provider of  
20 medical services or treatment under this chapter, other than a provider in which that  
21 pecuniary or investment interest is obtained on terms equally available to the public  
22 through trading on a registered national securities exchange, such as the New York  
23 Stock Exchange or the American Stock Exchange, or on the National Association  
24 of Securities Dealers Automated Quotation System;
- 25 (31) "Managed health care system" means a health care system that employs gatekeeper  
26 providers, performs utilization review, and does medical bill audits;
- 27 (32) "Physician" means physicians and surgeons, audiologists holding a doctorate in

1       audiology, psychologists, optometrists, dentists, podiatrists, and osteopathic and  
2       chiropractic practitioners acting within the scope of the license or other credentials  
3       required by his or her specialty of practice in the United States jurisdiction in which  
4       he or she is authorized to practice;

5       (33) "Objective medical findings" means information gained through direct observation  
6       and testing of the patient applying objective or standardized methods;

7       (34) "Work" means providing services to another in return for remuneration on a regular  
8       and sustained basis in a competitive economy;

9       (35) "Permanent impairment rating" means percentage of whole body impairment  
10       caused by the injury or occupational disease as determined by the "Guides to the  
11       Evaluation of Permanent Impairment";

12       (36) "Permanent disability rating" means the permanent impairment rating selected by  
13       an administrative law judge times the factor set forth in the table that appears at  
14       KRS 342.730(1)(b); and

15       (37) "Guides to the Evaluation of Permanent Impairment" means, except as provided in  
16       KRS 342.262:

17       (a) The fifth edition published by the American Medical Association; and

18       (b) For psychological impairments, Chapter 12 of the second edition published by  
19       the American Medical Association.

20       ➔Section 3. KRS 342.120 is amended to read as follows:

21       (1) There is created the Division of Workers' Compensation Funds in the Department  
22       of Workers' Claims ~~that~~<sup>which</sup> shall be responsible for the administration of the  
23       special fund and the coal workers' pneumoconiosis fund and the maintenance of  
24       records regarding the payment of claims by these funds. The Division of Workers'  
25       Compensation Funds shall have no responsibility for the coal workers'  
26       pneumoconiosis fund once the assets and liabilities have been transferred to the  
27       Kentucky Employers' Mutual Insurance Authority, which will administer the fund

1 pursuant to KRS 342.1243. The Division of Workers' Compensation Funds shall be  
2 headed by a director appointed by the commissioner~~secretary of the Education and~~  
3 ~~Labor Cabinet~~, with the prior written approval of the Governor pursuant to KRS  
4 12.050. The director shall be responsible for overseeing the administration of the  
5 funds and the maintenance of records regarding the payment of claims by the funds.

6 (2) The special fund shall have no liability upon any claim in which the injury  
7 occurred, or for cumulative trauma, the disability became manifest, or, for  
8 occupational disease, if the date of injury or last exposure occurred, after December  
9 12, 1996.

10 (3) Where the employer has settled its liability for income benefits and thereafter a  
11 determination has been made of the special fund's liability, the special fund portion  
12 of the benefit rate shall be paid over the maximum period provided for by statute  
13 for that disability, with the period of payment beginning on the date settlement was  
14 approved by an administrative law judge. This provision is remedial and shall apply  
15 to all pending and future claims.

16 ➔Section 4. KRS 342.122 is amended to read as follows:

17 (1) (a) For calendar year 1997 and for each calendar year thereafter, for the purpose  
18 of funding and prefunding the liabilities of the special fund, financing the  
19 administration and operation of the Kentucky Workers' Compensation  
20 Funding Commission, and financing the expenditures for all programs in the  
21 Department of Workers' Claims, Occupational Safety and Health Review  
22 Commission, Workers' Compensation Nominating Committee, Department of  
23 Workplace Standards, except expenditures for the Division of Wages and  
24 Hours contained in the Department of Workplace Standards and the  
25 proportional support for general administration and support based on an  
26 approved indirect cost allocation plan within the Department of Workers'  
27 Claims and the Education and Labor Cabinet, as reflected in the enacted

1 budget of the Commonwealth and enacted by the General Assembly, the  
2 funding commission shall impose a special fund assessment rate of nine  
3 percent (9%) upon the amount of workers' compensation premiums received  
4 on and after January 1, 1997, through December 31, 1997, by every insurance  
5 carrier writing workers' compensation insurance in the Commonwealth, by  
6 every self-insured group operating under the provisions of KRS 342.350(4)  
7 and Chapter 304, and against the premium, as defined in KRS 342.0011, of  
8 every employer carrying his or her own risk.

- 9 (b) 1. The funding commission shall, for calendar year 1998 and thereafter,  
10 establish for the special fund an assessment rate to be assessed against  
11 all premium received during that calendar year which shall produce  
12 enough revenue to amortize on a level basis the unfunded liability of the  
13 special fund as of June 30 preceding January 1 of each year, for the  
14 period remaining until December 31, 2029. The special fund  
15 assessment imposed by the funding commission shall continue to be  
16 assessed to finance the administration and operation of the Kentucky  
17 Workers' Compensation Funding Commission, and financing the  
18 expenditures for all programs in the Department of Workers' Claims,  
19 Occupational Safety and Health Review Commission, Workers'  
20 Compensation Nominating Committee, Department of Workplace  
21 Standards, excluding expenditures for the Division of Wages and  
22 Hours contained in the Department of Workplace Standards and the  
23 proportional support for general administration and support based on  
24 an approved indirect cost allocation plan within the Department of  
25 Workers' Claims and the Education and Labor Cabinet. In no case  
26 shall the combined budgets of the Occupational Safety and Health  
27 Review Commission, Workers' Compensation Nominating Committee,

1                   Department of Workplace Standards, and the proportional support for  
2                   general administration and approved indirect cost allocation to the  
3                   Education and Labor Cabinet, exceed seventy-five percent (75%) of

3 statement from an insurance carrier presented to an insured reflecting premium and  
4 assessment amounts shall clearly identify and distinguish the amount to be paid for  
5 premium and the amount to be paid for assessments. No insurance carrier shall  
6 collect from an insured an amount in excess of the assessment percentages imposed  
7 by this chapter. The assessment for an insurance policy or other evidence of  
8 coverage providing a deductible may be collected in accordance with this chapter

10 the deductible. The percentages imposed by this chapter for an insurance policy  
11 issued by an insurance company shall be those percentages in effect on the annual

15 computed in the same manner as insurance companies. This election may not be
