6 1982; and

7 WHEREAS, C. Ronald Wise was a devoted family man of tremendous integrity
8 and compassion and a highly regarded resident of Campbellsville; and

9 WHEREAS, C. Ronald Wise enjoyed a wonderful career as a CPA and established
10 the firm currently known as Wise, Buckner, Sprowles & Associates. He was also the
11 former president of United Citizens Bank, where he continued to serve as a consultant
12 until his passing; and

13 WHEREAS, C. Ronald Wise was a pillar of the community and a man truly
14 dedicated to civic service. He was a long-time member of the Campbellsville Board of
15 Education and was actively involved with the Campbellsville Jaycees; and

17 an adventurous traveler, and he loved spending time with his family and friends. He was
18 a lifelong lover of music and always sang from his heart. What he may have lacked in

21 Presbyterian Church in Campbellsville; and
