MEASURE'S PURPOSE: The measure reorganizes the Kentucky Boxing and Wrestling Authority as the "Kentucky Boxing and Wrestling Commission" and confirms Executive Order 2016-270.

PROVISIONS/MECHANICS: Section 1 amends KRS 229.011 to add a definition of "Commission" and changes language to conform.

Sections 2 through 11, 16 through 20, and 22 through 25 amend various statutes to conform and make grammatical changes.

Section 12 amends KRS 229.141 to add language to clarify that all structures used for events shall conform to any building codes, safety codes, and local laws that apply to the structure or the location and use of the structure.

Section 13 amends KRS 229.151 to conform and adds kickboxing and mixed martial arts to the list of oversight responsibilities of the Commission. Also, requirements for Commission members are changed to include one member that is a licensed Kentucky medical doctor, one

member that is a licensed Kentucky attorney, and one member shall have experience in sports marketing or promotion.

Section 14 amends KRS 229.155 to conform and adds language that an executive director shall be appointed by the governor upon the request of the secretary of the Public Protection Cabinet.

Section 15 amends KRS 229.171 to conform and adds language requiring the Commission to promulgate administrative regulations.

Section 21 amends KRS 229.260 to create and establish the Kentucky Boxing and Wrestling Commission Medical Advisory Panel. It also directs the secretary of the Public Protection Cabinet to appoint members to the panel and establishes qualifications of the members.

Section 26 establishes the terms of the initial appointments to the commission.

Section 27 confirms Executive Order 2016-270 dated May 16, 2016.

FISCAL EXPLANATION: The measure contains the same provisions as Executive Order 2016-270, therefore there is no fiscal impact.
