**MEASURE'S PURPOSE:** The measure requires every public middle school and high school to teach about the Holocaust and other cases of genocide.

**PROVISIONS/MECHANICS:** Section 1 amends KRS 156.160 to require every middle school and high school to include in their curriculum instruction on the Holocaust and other cases of genocide.

Section 2 names the bill as the Ann Klein and Fred Gross Holocaust Education Act.

**FISCAL EXPLANATION:** Ordinarily, there is a cost involved for the Kentucky Department of Education any time there is a revision of the Kentucky Academic Standards, which are incorporated by reference into 704 KAR 3:303. These costs are derived from the time and expense involved in convening the Review/Development Committees, Advisory Panels,

Standards/Assessment Process Review Committees, and the Local Superintendents Advisory Council, among others.

However, in this particular case, the social studies standards are just beginning to undergo their revisions under 2017 Regular Session SB 1. Therefore, any revisions in standards made by this bill would be incorporated into the already existing process, resulting in no additional cost.
