



the arresting officer is responsible for obtaining the sample there will be time taken from the officer's other duties.

The amount going to local agencies based on 2017 data will be \$311,665. This is based on 62,333 arrest. Depending on the type of any prior felony offense (i.e. sexual assault), a number of these arrestees may have already submitted to a DNA sample prior to this program.

It may be assumed that if the bill passes, the amount going to local governments will decrease over time, as DNA samples will have already been collected on repeat offenders. The Bureau of Justice Statistics (BJS) puts the percentage for repeat felon arrest in the country's 75 largest counties as high as 75%. Additional BJS data states three in four former prisoners in 30 states are arrested within five years of release. Kentucky-specific data regarding repeat offenders is not readily available, but using BJS data reflecting 75% recidivism, at the conclusion of the initial 10 year cycle allowing us to account for 75% recidivism for year five arrestees, DNA samples may only be needed on approximately 15,583 felony arrestees annually.

Attached to this impact statement is a breakdown of felony arrest per county for calendar year 2017. Historically, this data has shown significant fluctuation year to year. This data is reflective of 2017 only and the future impact is based on 2017 only. Additionally, it reflects the aggregate amount going to the county, not to the individual agencies within the county, i.e. sheriff, police department, or jailer.
