MEASURE'S PURPOSE: This measure authorizes \$3,000,000 beginning in fiscal year 2018-2019 for the Kentucky Community and Technical College System (KCTCS) to establish an endowment match fund, which also includes gifts, grants, and federal funds.

**PROVISIONS/MECHANICS:** Section 1 creates a new section of KRS Chapter 164 to establish a KCTCS endowment match fund. This section provides for a transfer of \$3,000,000 in General Fund (quarterly transfers of \$750,000) to the match fund, in addition to any gifts, grants, and federal funds; prohibits any quarterly transfers if the total match fund balance is \$5,000,000 or greater; and provides for fiscal year-end match fund balances to carry forward.

Section 2 provides an emergency clause.

**FISCAL EXPLANATION:** The measure will require an annual transfer of \$3,000,000 from the General Fund to the KCTCS endowment fund. The total funds in the account can only be used to

match endowment gifts to the KCTCS. The transfers from the General Fund are set to expire June 30, 2022.
