

Below is a table (submitted by the Kentucky League of Cities) of those cities reporting telecommunications revenue and/or telecommunications expenditures for fiscal year 2015. Some cities provide residential landline access while others may only provide wireless access in part of, or all of their community. As the numbers suggest, Barbourville, Bardstown, and Williamstown have particularly robust telecommunications services in their cities.
