MEASURE’S PURPOSE: HB 423/HCS 1 establishes the Family in Recovery Empowerment (FIRE) Public and Private Partnership Grant Program and the FIRE Public and Private Partnership Grant Program trust fund to support substance use disorder treatment and recovery services for mothers and their children. It expands the number of FDA-approved medication-assisted treatment products available for the Department of Corrections (DOC) to provide to offenders.

PROVISIONS/MECHANICS: Section 1 creates a new section of KRS Chapter 222 to define terms.

Section 2 creates a new section of KRS Chapter 222 to dictate that the Office of Drug Control Policy (ODCP) shall establish the FIRE Public and Private Partnership Grant Program, develop program award requirements, assist in establishing service areas, and provide an annual report to the Governor and the Legislative Research Commission.

Section 3 creates a new section of KRS Chapter 222 to mandate the ODCP to develop an expenditure plan for FIRE trust fund resources made available in Section 4 and outlines the parameters of fund uses.

Section 4 creates a new section of KRS Chapter 222 to establish the FIRE Public and Private Partnership Grant Program trust fund and define the parameters of its use.

Section 5 creates a new section of KRS Chapter 222 to provide that the FIRE Public and Private Partnership Grant Program shall cease to exist on December 1, 2028, unless reauthorized by the General Assembly. If not reauthorized, any funds in the FIRE trust fund shall be deposited into the General Fund.

Section 6 amends KRS 196.288 to expand the number of FDA approved treatment medications to treat offenders' opioid addictions.

FISCAL EXPLANATION: HB 423/HCS 1 does not pose an impact to the state beyond additional work requirements of staff employed by the ODCP. The additional workload is not anticipated to necessitate additional personnel.
