SUBJECT: AN ACT relating to assault on a service animal.

SUMMARY OF LEGISLATION: Amend KRS 525.200 to include assistance animals in the definition of "service animals" that are covered by assault on a service animal in the first degree.

STATE IMPACT: Class A, B & C felonies are based on an average daily prison rate of \$70.12. Most Class D felons are housed in one of 76 full service jails for up to 5 years. DOC's cost to incarcerate a felony inmate in a jail is \$31.45 per day (includes jail per diem, medical & central office costs), not including substance abuse treatment. Projections are based on the daily rate x 365 x number of years.

Projected Impact: NONE MODERATE (< \$1 million) SIGNIFICANT (> \$1 million)

The proposed legislation amends KRS 525.200 by deleting language stating that a service animal, for this section, has the same meaning as KRS 525.010, except a service animal does not include assistance dogs.

Assault on a service dog would therefore qualify for the Class D criminal offense of Assault on a Service Animal.

According to data provided by AOC, in FY2015-2017 there was one (1) felony conviction for Assault on a Service Animal 1st Degree. Currently, the Department has three (3) inmates and one (1) offender on supervision for a felony Assault on Service Animal conviction.

The Department's records do not distinguish the type of service animal that was involved in an Assault on a Service Animal, so it is unknown if the three (3) offenders who are currently incarcerated for Assault of a Service Animal were assaults conducted on assistance dogs.

If ten (10) offenders were convicted to a Class D felony for Assault on a Service Animal, the cost to the Department would range from \$114,808 to \$574,040.

The Department cannot project how many additional cases would be generated from the addition of assistance dogs to this statute; however, given the overall number of convictions involving service animals, the impact to DOC and resulting incarceration costs would be minimal.

A Class D Felony sentence is 1 to 5 years.

10 Class D Felons cost KY \$114,808 to \$574,040

1 Class D Felon costs KY \$11,481 to \$57,404

100 Class D Felons cost KY \$1.1M to \$5.7M

LOCAL IMPACT: Local governments are responsible for the cost of incarcerating individuals charged with Class A or B misdemeanors and felony defendants until disposition of the case. While the expense varies by jail, this estimated impact will be based on \$31.34 per day, which equals the per diem and medical that DOC pays jails to house felony offenders.

Projected Impact: NONE MODERATE (< \$1 million) SIGNIFICANT (> \$1 million)

Assault on a Service Animal 2nd Degree, is a Class B misdemeanor.

According to data provided by AOC, in FY2015-2017 there were eight (8) convictions for Assault on a Service Animal 2nd Degree, a Class B misdemeanor, as well as seven (7) convictions of Attempted Assault on a Service Animal, 1st Degree. The Department of Corrections has two (2) offenders on supervision for the misdemeanor offense of Assault on a Service Animal 2nd Degree.

It is not possible to know how many misdemeanor offenses would be generated for an assault on an assistance dog, but based on the small number of convictions for this offense overall, it is projected the impact to the local jails would be minimal.

A Class B misdemeanor is up to 90 days in jail.

10 Class B misdemeanants: up to \$28,206

1 Class B misdemeanant: up to \$2,821

100 Class B misdemeanants: up to \$282,060
