<u>PURPOSE OF MEASURE</u>: This measure establishes the Alan "Chip" Terry Professional Development and Wellness Program to offer at least two annual, seminar-based peer support and counseling service classes for professional and volunteer firefighters to be administered by the Kentucky Fire Commission (KFC). The Professional and Volunteer Firefighters Professional Development and Wellness Program Fund is established and may be funded with restricted funds from the Firefighters Foundation Program Fund, grants, gifts, state appropriations, and federal funds.

**FISCAL EXPLANATION:** HB273/GA authorizes Firefighter Foundation Program funds to be utilized by the Alan "Chip" Terry Professional Development and Wellness Program for at least two classes, projected at \$50,000, annually, consisting of classroom, meals, travel, and lodging costs for 30 firefighters per class. Due to program development schedules, classes will not begin until fiscal year 2019-2020.
