TITLE: AN ACT relating to school safety.

SUMMARY OF LEGISLATION: Create a new section of KRS Chapter 158 to require that an individual on school district property provide government-issued photo identification if requested by a school employee, school resource officer, or law enforcement officer; provide that the individual may be required to leave the property if they refuse or are unable to comply; amend KRS 511.070, relating to criminal trespass in the second degree, to make trespassing in a school building or upon school premises to which notice against trespass is given a Class A misdemeanor; amend KRS 511.080, relating to criminal trespass in the third degree, to make trespassing upon school premises a Class B misdemeanor; amend KRS 511.090 to conform.

STATE IMPACT: Class A, B, & C felonies are based on an average daily prison rate of \$75.91. Community Custody Class C and most Class D felons are housed in one of seventy-seven (77) full service or regional jails for up to five (5) years. Department of Corrections' cost to incarcerate a felony inmate in a jail is \$36.70 per day, which includes \$31.34 per diem, medical costs, & central office administrative costs (substance abuse treatment not included). *Projections are based on the daily rate x 365 days x number of years.* Offenders may have multiple offenses or incarcerated on other charges unless otherwise noted. Unless otherwise noted, numbers will include inchoate offenses at the underlying offense level.

Projected Impact: INONE INTIMAL to MODERATE (< \$1 million) INTIGNIFICANT (> \$1 million)

LOCAL IMPACT: Local governments are responsible for the cost of incarcerating individuals charged with Class A or B misdemeanors and felony defendants until disposition of the case. While the expense varies by jail, this estimated impact will be based on \$31.34 per day, which equals the per diem and medical that DOC pays jails to house felony offenders. Since the per diem is an estimated average cost of housing an inmate, the per diem may not be the actual housing cost for the jail. *Projections are based on the daily rate x 365 days x number of years. Offenders may have multiple offenses or incarcerated on other charges unless otherwise noted. Unless otherwise noted, numbers will include inchoate offenses at the underlying offense level.*

Projected Impact: INONE IN MINIMAL to MODERATE (< \$1 million) IN SIGNIFICANT (> \$1 million)

The legislation requires individuals on school property to produce a valid government-issued ID. Refusal or inability to do so may result in the individual being asked to leave.

Under KRS 511.070, Criminal Trespass 2nd Degree is amended through the addition of a Class A misdemeanor offense of knowingly entering or unlawfully remaining on school property when notice against trespass is provided by fencing or other enclosure. Criminal Trespass 2nd Degree otherwise is a Class B misdemeanor.

Under KRS 511.080, Criminal Trespass 3rd Degree is amended to include the Class B misdemeanor of knowingly entering or unlawfully remaining on school property. Criminal Trespass 3rd Degree otherwise is a violation.

In FY 2019, AOC records reflect 1,007 convictions for Criminal Trespass 2nd Degree and 2,931 Criminal Trespass 3rd Degree.

Department of Corrections' records reflect eighty (80) community supervision offenders for the misdemeanor offense of Criminal Trespass 2nd Degree. Additionally, records reflect an additional five (5) offenders on supervision for the similar violation of law for Loitering in or about a School.

Misdemeanors are subject to the jurisdiction and cost of the county.

It is not known how many convictions would be incurred under this legislation; however, the overall impact on incarceration would be expected to be minimal.

A Class A misdemeanor is 90 days to 1 year in jail. 1 Class A misdemeanant: \$2,820.60 to \$11,439.10 10 Class A misdemeanants: \$28,206.00 to \$114,391.00 100 Class A misdemeanants: \$282,060.00 to \$1,143,910.00
