<u>PURPOSE OF MEASURE</u>: The purpose of the measure is to establish a Medicaid ground ambulance service provider assessment and to require quarterly payments of the assessment by ground ambulance service providers.

FISCAL EXPLANATION:

Department for Medicaid Services

The fiscal impact of the legislation is indeterminable due to several factors. The Department for Medicaid Services (DMS) lacked the data on the total number of statewide emergency ground transports in order to accurately estimate the fiscal impact of House Bill 8 HCS1. DMS reports that it is unable to access this data, as it is under the purview of the Kentucky Board of Emergency Medical Services and the Kentucky Transportation Cabinet (KYTC). According to DMS, there are multiple state agencies which pay for emergency transports under the fee-for-service Medicaid program including DMS and KYTC. Fees for emergency transports in the Medicaid managed care program are negotiated by the emergency ambulance providers and the Medicaid managed care organizations.

Kentucky Board of Emergency Medical Services

There is no fiscal impact to the Kentucky Board of Emergency Medical Services (KBEMS). KBEMS currently receives data on the number of emergency transports as required by the legislation.
