Part II: Bill Provisions and the Estimated Fiscal Impact Relating to Local Government

The fiscal impact of HB 348 HCS is presently unknowable and indeterminate and will range from nil to moderate, depending on the current and unique status of local/area broadband services; state funding, and the administrative regulations promulgated.

The Kentucky League of Cities notes that the bill allows the imposition of fees related to administering a broadband expansion program, although it does not set fee amounts. Thus, some fees may be associated with the program, but they should be small and incorporated as part of grant awards. The few cities currently providing telecommunications services would be required to submit availability data, which could add some additional time and effort and administrative costs.

The **Kentucky Municipal Utilities Association** is concerned that provisions of the bill provide federal and state grant money to private entities like Open Fiber.

According to the U.S. Census Bureau, approximately **80.6% of households in Kentucky cities had some form of broadband access (cellular, landline, or satellite)** in 2019. When looking specifically at landline services (**cable, fiber optic, DSL**), **66.9% of households in Kentucky cities have broadband access**.

HB 348 HCS repeals and reenacts KRS 246.010 alphabetizing definitions and adding definitions for "broadband" or "broadband service," "broadband deployment fund," broadband deployment project", "broadband deployment project area," "census block," "shapefile," "underserved area," and "unserved area".

It amends KRS 246.030 to add an Office of Broadband Innovation to the Department of Agriculture; and creates a new section of KRS Chapter 246 establishing an Office of Broadband Innovation and provides for the duties and responsibilities of the office. HB 348 HCS creates a new section of KRS Chapter 246 establishing a broadband deployment fund in the Office of Innovation;

The bill repeals KRS 224A.1121 and reenact as a new section KRS Chapter 246, amending all references of the Kentucky Infrastructure Authority to the Office of Broadband Innovation, and authorizing the Department of Agriculture to promulgate administrative regulations for a broadband deployment fund program.

HB 348 HCS amends KRS 154.15-020 to require that the Kentucky Communications Network Authority obtain written permission from the Office of Broadband Innovation before applying for federal funds, and amends KRS 18A.115 to exempt Office of Broadband Innovation employees from classified service under KRS 18A.005 to 18A.200.

Part III: Differences to Local Government Mandate Statement from Prior Versions

The fiscal impact of HB 348 HCS is the same as for HB 348. HB 348 HCS retains the original provisions of HB 348 and amends KRS 246.010 to change the definition for "broadband" and adds a definition for a "broadband deployment project". The substitute amends KRS 246.030 to add an Office of Broadband Innovation to the Department of Agriculture and amends the duties and responsibilities of the office and the reporting requirements of the office to the Legislative Research Commission.
