**PURPOSE OF MEASURE:** The bill amends 2021 Ky. Acts ch. 171, sec. 3 and repeals 2021 Ky. Acts ch. 194, sec. 17, to remove the appropriation of \$127,000,000 from the Coronavirus Capital Projects Fund to the School Facilities Replacement and Renovation Fund and instead appropriates those funds to the Broadband Deployment Fund. The Broadband Deployment Fund appropriation from the State Fiscal Recovery Fund of the American Rescue Plan Act of 2021 is reduced by the same amount.

**FISCAL EXPLANATION:** Per updated guidance from the U.S. Department of the Treasury, Coronavirus Capital Projects funding is ineligible to be expended on school renovations and replacements. This bill makes a technical correction to appropriate eligible federal funding for the Broadband Deployment Fund instead of the School Facilities Replacement and Renovation Fund. The funding for the School Facilities Replacement and Renovation Fund has been included in 2022 Regular Session HB 1/GA.

There is no additional fiscal impact to the Kentucky Infrastructure Authority since the funds going toward the Broadband Deployment Fund were anticipated for the 2021-2022 fiscal year.
