I. Mandating health insurance coverage of <u>BR 1388</u> is not expected to materially impact premiums, based upon <u>our analysis of the proposed mandate and our experience with similar health insurance benefits. The mandate requires that the sale, procurement, issuance, or rates charged for any existing life, health, or accident insurance or annuity policy shall not be conditioned upon or affected by the making or rescinding of a request by a qualified individual, with a terminal disease, for medication that the individual may self-administer to end the individual's life. Additionally, the mandate prohibits denying benefits on the basis of terms in an existing policy, contract or annuity that are in violation of the above stated provision. Our analysis includes health benefit plans, for all fully insured policies in Kentucky, excluding Medicaid and state employees.</u>

The proposed <u>BR 1388</u>, as described above, <u>is not expected to materially impact</u> the total cost of health care in the Commonwealth, <u>based upon our analysis of the proposed mandate and our experience with similar health insurance benefits</u>. Our analysis includes health benefit plans, for all fully insured policies in Kentucky, excluding Medicaid and state employees.

The proposed <u>BR 1388</u>, as described above, <u>is not expected to materially impact</u> administrative expenses of insurers, <u>based upon our analysis of the proposed mandate and our experience with similar health insurance benefits</u>. Our analysis includes health benefit plans, for all fully insured policies in Kentucky, excluding Medicaid and state employees.

Our analysis included the use of data and statistics from 2022 L&E Medical Manual, actuarial judgement, and a 2021 Annual Data Report provided by DOI.
