TITLE: AN ACT relating to sexual offenses.

SUMMARY OF LEGISLATION: Amend KRS 510.010 to include alcohol in the definition of "physically helpless"; amend KRS 510.060 to create an additional element of rape in the third degree; amend KRS 510.090 to create an additional element of sodomy in the third degree.

STATE IMPACT: Class A, B, & C felonies are based on an average daily prison rate of \$105.23. Community Custody Class C and most Class D felons are housed in one of seventy-four (74) full service or regional jails for up to five (5) years. Department of Corrections' cost to incarcerate a felony inmate in a jail is \$40.11 per day, which includes \$35.34 per diem, medical costs, & central office administrative costs (substance abuse treatment not included).*

Projected Impact: NONE MINIMAL to MODERATE (< \$1 million) SIGNIFICANT (> \$1 million)

Expanding the definition of the KRS 510.010, 510.060 and 510.090 could potentially result in new felony and/or misdemeanor offenses which would impact the number of offenders incarcerated and/or placed on supervision. Class D sex offenses with 2 years or more requires housing in a prison.

DOC does not anticipate many new convictions. There are currently 359 inmates in custody for Rape 3rd and/or Sodomy 3rd. There are currently 266 offenders on supervision for Rape 3rd and/or Sodomy 3rd.

LOCAL IMPACT: Local governments are responsible for the cost of incarcerating individuals charged with Class A or B misdemeanors and felony defendants until disposition of the case. The estimated impact will be based on the \$40.11 cost to incarcerate for the Department of Corrections, including \$35.34 per diem and medical that DOC pays jails to house felony offenders. This cost to incarcerate may not be the actual housing cost for the jail.*

Projected Impact: NONE MINIMAL to MODERATE (< \$1 million) SIGNIFICANT (> \$1 million)

Any increase to the sex offender population based on the creation of additional sex offenses could impact contract beds with Reentry Service Centers (RSCs) who house sex offenders with residency restrictions in addition to program beds for Sex Offender Treatment Program (SOTP).

Expanding the definition of the KRS 510.010, 510.060 and 510.090 could potentially result in new felony and/or misdemeanor offenses which would impact the number of offenders incarcerated and/or placed on supervision. Class D sex offenses with less than 2 years would be housed in a county jail.

DOC does not anticipate many new convictions. There are currently 359 inmates in custody for Rape 3rd and/or Sodomy 3rd.

PROJECTED IMPACT FROM AMENDMENTS:


